INDEPENDENT AUDITOR'S REPORT

To the Executive Committee of the
UFCW Health Insurance Plan for Retirees

Opinion

We have audited the accompanying financial statements of the UFCW Health Insurance Plan for Retirees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of February 28, 2025 and February 29, 2024, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of February 28, 2025 and February 29, 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with the modified cash basis of accounting as described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.





Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.


Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTES TO FINANCIAL STATEMENTS (MODIFIED CASH BASIS)

YEARS ENDED FEBRUARY 28, 2025 AND FEBRUARY 29, 2024

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the UFCW Health Insurance Plan for Retirees (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Plan was formed in 1969 to provide health and welfare benefits to former, full-time employees and officers of UFCW or participating Chartered Bodies. The Plan is funded by the UFCW International Union and participating Chartered Bodies on behalf of their employees employed in the U.S. Effective January 1, 2016, a Trust was established for the purpose of holding assets to provide health and other benefits to the participants in accordance with the Plan. The Trust, together with the Plan, is intended to constitute a voluntary employees beneficiary association under Section 501(c)(9) of the federal tax code.

The Plan offers both self-insured and fully-insured health benefits. The self-insured benefits are administered by United HealthCare (UHC) for medical and dental benefits, Group Vision Service for vision benefits, and Sav-Rx or Claim Secure (Canada) for prescription benefits. The Plan offers fully-insured medical, vision and prescription benefits that are provided by Kaiser Permanente. The Plan also offers life and accidental death and dismemberment benefits which are fully insured through Union Labor Life Insurance Company (ULLICO). The Plan also offers a UHC Medicare Advantage Preferred Provider Organization contract for Medicare-eligible beneficiaries that is also fully insured.

To receive benefits, plan participants must meet certain eligibility requirements. Contributions to the Plan are made by both the participants as a premium deduction from monthly pension payments, and the Plan sponsor. The Plan provides a comprehensive schedule of health care benefits including medical, dental, life insurance, accidental death and dismemberment coverage, and prescription drug benefits to eligible participants and their dependents. The Plan uses a preferred provider organization to help reduce healthcare costs.

Effective January 1, 2020, the Plan was amended to require the spouses of retirees who retired on or after January 1, 2020 to pay \$100 per month for non-Medicare coverage and \$50 per month for coverage in one of the MA plans (i.e., UHC, Kaiser, or Group Health). All Medicare-eligible beneficiaries enrolled in the Retiree Drug Subsidy program administered by Express Scripts will be enrolled in an Employer Group Waiver Program. Also, the Plan was amended to eliminate Non-Medicare coverage for participants hired on and after January 1, 2020.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements have been prepared using the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. That basis differs from U.S. generally accepted accounting principles in that additions are included in the year in which they are collected rather than when earned, and deductions are included in the year in which they are disbursed rather than when incurred. The Plan periodically holds investments which are reported at fair value and as such any earnings on investments include adjustments to fair value.

Employer Contributions - Contributions are received from UFCW in the form of expenses paid. When vendors send the Plan invoices for payment, the Plan then remits them to UFCW for payment. The Plan does not pay any expenses directly.

Participant Contributions - The Plan receives contributions from both retirees themselves and the Chartered Bodies. The retiree contributions are electable at the retiree's choice, and represent premiums deducted from their pension checks. The contributions from Chartered Bodies come in the form of per capita tax dues received by UFCW, and distributed to the applicable funds, including the Plan.

Medicare Part D Reimbursement - The Plan receives reimbursements for prescription drug benefits pursuant to the Medicare Part D guidelines.

Payment of Benefits - Premiums paid by the Plan are recorded as premium payments in the accompanying statements of changes in net assets available for benefits (modified cash basis). Claim payments are recorded when paid by the third-party claims processor. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits (modified cash basis).

Postretirement Benefit Obligations - The postretirement benefit obligation represents the actuarial present value of those estimated future premiums that attribute to employee service rendered to the valuation date. Postretirement benefits include future premiums expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with their employer. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The Plan's deficiency of net assets over benefit obligations at February 28, 2025 and February 29, 2024 relates to the postretirement benefit obligations, the funding of which is not covered by the current contribution rate agreed between the Plan and participating employers. It is expected that the deficiency will be funded through future contributions.

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.



NOTE 3. TAX STATUS

The Internal Revenue Service has advised, in a letter dated May 24, 2016, that the Plan is qualified under Section 501(c)(9) of the Internal Revenue Code and, therefore, is not subject to income tax under current tax laws.

The Plan follows the authoritative guidance relating to accounting for uncertainty in income taxes included in Accounting Standards Codification Topic *Income Taxes*. These provisions provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribe a threshold of "more likely than not" for recognition and derecognition of tax positions taken or expected to be taken in a tax return. The Plan performed an evaluation of uncertain tax positions for the years ended February 28, 2025 and February 29, 2024, and determined that there were no matters that would require recognition in the financial statements or that may have an effect on its tax-exempt status. As of February 28, 2025, the statute of limitations for tax years 2021 through 2023 remains open with the U.S. federal jurisdiction and the various states and local jurisdictions in which the Plan files returns. It is the Plan's policy to recognize interest and/or penalties related to uncertain tax positions, if any, in unrelated business income tax expense.

NOTE 4. PRIORITIES UPON TERMINATION

It is the intent of the Executive Committee to continue the Plan in full force and effect, however, the Executive Committee reserves the right to discontinue the Plan.

In the event of termination, the Executive Committee shall first satisfy or make provisions to satisfy the obligations of the Plan in accordance with law. Any remaining plan assets will be distributed in such manner as will, in the opinion of the Executive Committee, carry out the purpose of the Plan. Termination shall not permit any part of the Plan's assets to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As described in Note 2, the UFCW pays benefit providers directly, including insurance premiums, for ULLICO and Kaiser Permanente, as well as administrative fees, on behalf of the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of the Employee Retirement Income Security Act of 1974 (ERISA).

NOTE 6. INSURANCE COMPANY PREMIUMS

The Plan is insured through ULLICO for excess loss, participant group life insurance and accidental death and dismemberment benefits and through United Healthcare and Kaiser Permanente for medical, dental, vision and prescription insurance benefits.



NOTE 7. STOP-LOSS COVERAGE

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The Plan has arranged insurance coverage to provide specific stop-loss protection above the deductible of \$350,000 per Plan participant and aggregated specific deductible of \$285,000 for the plan-year ended February 28, 2025.

Premiums for stop-loss insurance totaling \$289,946 and \$278,447 were paid for directly by the Plan Sponsor for the years ended February 28, 2025 and February 29, 2024, respectively. There were no stop-loss refunds received during the years ended February 28, 2025 and February 29, 2024.

NOTE 8. BENEFIT OBLIGATIONS

Benefit obligations include the Plan's liability for health claims incurred as of February 28, 2025 and February 29, 2024 and paid subsequent to year-end, including claims incurred but not reported. The Plan's liabilities for claims incurred but not reported is estimated based on prior claims paid experience and the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid. Claims payable represent claims processed but not paid as of year-end and are included in the claims incurred but not reported amounts.

There were no premiums payable at February 28, 2025 and February 29, 2024. The following table presents the Plan's benefit obligations:

Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers.

Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by future contributions from the Plan's participants and plan sponsor.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claim costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Changes in Actuarial Assumptions

For the valuation as of February 28, 2025, the report utilizes a roll-forward methodology, the assumptions were not changed from the prior valuation.

The actuarial determined it was reasonable to make no changes at this time based on their review of the current healthcare marketplace. In making this determination, they considered the following:

- The 2025 population statistics were relatively stable compared to the 2024 statistics.

For the valuation as of February 29, 2024, claims and trends were updated to reflect recent experience, industry expectations, and contract negotiations. The net result is a decrease in the liability of over \$49 million, or 9.6%. The decrease is primarily caused by the expected costs increasing slower than the assumed trend from the prior full valuation, particularly among the non-medicare eligible participants as pharmacy savings from switching vendors to Sav-Rx effective April 1, 2021 exceed the assumed savings.

A one percentage point increase in the assumed health care cost trend rate would increase the accumulated postretirement benefit obligation from \$466,179,000 to \$528,754,000 as of February 28, 2025. A one percentage point decrease in the assumed health care cost trend rate would decrease the accumulated postretirement benefit obligation from \$466,179,000 to \$414,273,000 as of February 28, 2025.



NOTE 8. BENEFIT OBLIGATIONS (CONTINUED)

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.
