### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the Eat Just, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 through March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and December 31, 2024, and for the period from January 1, 2025 through March 31, 2025, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Merger**

As described in Note 1 to the financial statements, the Plan sponsor's Board of Directors resolved in January 2025 to merge the Plan with another employee benefit plan. Effective January 1, 2025, contributions to the Plan ceased. Plan assets were transferred into the other employee benefit plan on March 31, 2025. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to the participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

## **Eat Just, Inc. 401(k) Plan**

#### 1. Description of the Plan

Eat Just, Inc. (the Company) established the Eat Just, Inc. 401(k) Plan (the Plan), effective January 1, 2015, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Company's Board of Directors resolved to merge the Plan with another employee benefit plan, effective January 1, 2025 (the Merger Date). Subsequent to the Merger Date, the Plan continued to operate until Plan assets were transferred to a multiple employer plan, the ADP TotalSource Retirement Savings Plan, on March 31, 2025, at which time the Plan ceased to exist.

#### *General:*

The Plan was a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was the Plan sponsor and Plan administrator. The Plan was administered by Company employees and an Investment Committee. Two Company employees were co-trustees of the Plan. Voya Retirement Insurance & Annuity Company and Voya Institutional Plan Services, LLC (collectively, Voya) served as the Plan's investment custodian and record keeper, respectively. Voya held, invested, and reinvested Plan assets in the interest and direction of the participants and their beneficiaries.

#### *Eligible Participants:*

Eligible employees, as defined by the Plan agreement, who had reached the age of 21, could participate in the Plan after completing 30 days of service.

#### *Contributions:*

Participants were permitted to make voluntary pre-tax salary deferral and Roth post-tax contributions up to 100% of their annual compensation, as defined in the Plan agreement. Participants who had reached the age of 50 could also elect to withhold additional "catch-up" contributions under the Code. Participants could also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers).

### 1. Description of the Plan (continued)

#### *Contributions:* (continued)

The Plan provided for automatic enrollment on the date participants became eligible for the Plan. The automatic salary deferral contribution was 5% of participant compensation, escalating by 1% annually to a maximum of 10%, unless the participants requested a different amount to be contributed or formally declined participation. Participants could adjust their deferral rate or discontinue their contributions at any time.

The Company could make discretionary employer matching and non-elective contributions, at the discretion of the Company's Board of Directors. The Company did not make any discretionary contributions to the Plan through March 31, 2025.

The Company discovered certain types of compensation were improperly excluded from eligible compensation in 2022. As a result, the Company made a qualified non-elective contribution of \$5,099. This was recorded as an employer contribution receivable as of December 31, 2024 and funded to the Plan in February 2025.

Contributions were subject to certain limitations under the Code.

#### *Participant Accounts:*

Participant accounts were credited with participant contributions, discretionary Company contributions, if any, rollovers and an allocation of Plan net earnings or losses. Allocations were based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled was the benefit that could be provided from the participant account balances.

Participants could elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that were designed to provide the participants with a wide range of investment options. Participants could authorize transfers among investment options at any time.

#### *Vesting:*

Participants were fully vested (100%) in their pre-tax and Roth after-tax contributions and rollovers and Plan earnings (less any losses) thereon. Company discretionary contributions, if any, would not vest during the first year and then vest 20% annually with full (100%) vesting after six years.

##### *Forfeitures:*

Forfeitures of non-vested Company contributions, if any, would be available to reduce future Company contributions or to pay Plan expenses. There were no available forfeitures as there have been no Company contributions to the Plan through March 31, 2025.

##### *Notes Receivable from Participants:*

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the Plan agreement.

Participants could borrow up to one-half of their account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 30 years were permitted. Participants could have up to two notes outstanding. Participant notes were evidenced by a written note, secured by the balance in the participant account, and bore interest at the prime rate, as published in The Wall Street Journal, plus 1%. Repayment of principal and interest was generally made through payroll deductions.

##### *Payment of Benefits:*

On termination of service for any reason, benefits were paid to participants in a lump-sum cash distribution equal to the value of the participant account. Accounts between \$1,000 and \$7,000 could be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Accounts below \$1,000 could be distributed directly to participants without participant approval. Benefits were recorded when paid.

##### *Plan Expenses:*

Several of the investment fund options were subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees were charged directly against the fund's investment performance and, thus, were not separately disclosed in the Plan's financial statements. Certain administrative expenses were charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan were paid by the Company and are not reflected in the Plan's financial statements.

#### 2. Summary of Significant Accounting Policies

##### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Investments:*

The Plan's investments consisted of mutual funds and a guaranteed interest account, and were accounted for as follows:

**Mutual Funds:** These funds were valued at the net asset value of shares held by the Plan at year end, as quoted in active markets.

**Guaranteed Interest Account:** This account was part of Voya's general fund account. The fair value of the account represented the value to be received when funds were withdrawn prior to their maturity for an event other than death, disability, termination, or retirement, less any applicable surrender charge.

##### *Fair Value Measurement:*

The Plan used a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritized within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

*Fair Value Measurement:* (continued)

The three-level hierarchy for fair value measurement is defined as follows:

**Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

**Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

**Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

*Income Recognition:*

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual method of accounting. Dividends were recorded on the ex-dividend date. Net appreciation included gains and losses on the Plan's investments bought, sold, or held during the period.

#### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024.
- net income on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2025 through March 31, 2025.
- investment information included in the footnotes.

#### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended since receipt of the letter. However, the Plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the Code and related state statutes and was, therefore, qualified, and the trust that formed a part of the Plan was exempt from federal and state income taxes.

GAAP required the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of March 31, 2025, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

5. Party-In-Interest Transactions

Certain Plan investments were offered by Voya. As Voya was the Plan's investment custodian, purchases and sales of these investments qualified as party-in-interest transactions. Note receivable transactions with participants also qualified as party-in interest transactions. These party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.
