## REPORT OF INDEPENDENT AUDITORS

### Opinion

We have audited the financial statements of Guardian Fleet Services, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets in liquidation available for benefits as of September 5, 2025 and December 31, 2024, and the related statement of changes in net assets in liquidation available for benefits for the period from January 1, 2025 through September 5, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets in liquidation available for benefits of the Plan as of September 5, 2025 and December 31, 2024, and the changes in its net assets in liquidation available for benefits for the period from January 1, 2025 through September 5, 2025, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As described in Note 1 to the financial statements, the Plan was terminated, effective February 10, 2023, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting to the liquidation basis used in presenting the financial statements. Our opinion is not modified with respect to this matter.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. **1. DESCRIPTION OF PLAN**

The following brief description of the Guardian Fleet Services, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for complete information.

The Plan, established by Guardian Fleet Services, Inc. (the Company) effective January 1, 2016, operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by Guardian Fleet Services, Inc.'s Board of Directors.

The Plan purchased Company common stock in August 2017, January 2019 and June 2021 using the proceeds borrowed from the Company and held the stock in a trust established under the Plan. As the Plan made payments of principal and interest, an appropriate percentage of stock was allocated to eligible employees' accounts in accordance with applicable regulations under the Code. The allocation to participant accounts was done on the last day of each plan year through December 31, 2022.

The Board of Directors of the Company approved the termination of the Plan effective February 10, 2023, and all participants became 100% vested in their accounts. During the year ended December 31, 2023, the Company forgave the outstanding principal and interest on the Plan loan. Concurrent with the loan forgiveness, the Plan redeemed 94,048 of the Plan's allocated shares to the Company for cash consideration of \$6,252,340. All unallocated shares were terminated. During the year ended December 31, 2023, the Plan filed for an updated determination letter from the Internal Revenue Service (IRS) to confirm the Plan's tax-qualified status upon Plan termination. The Plan received a determination letter from the IRS dated February 25, 2025, stating that the termination of the Plan would not affect its qualification for federal tax purposes. In anticipation of an updated determination letter, the Plan's participants were given the option to receive a partial distribution (no more than 75%) of their account balance in either a (1) direct rollover to the Guardian Fleet Services, Inc. 401k plan or another qualified retirement account; (2) lump sum payment; (3) combination thereof.

Eligibility

All employees of the Company and its participating subsidiaries as of August 7, 2017, who attained the age of 21, were immediately eligible to participate in the Plan. Employees hired after August 7, 2017, are generally eligible to participate in the Plan after completing 12 months and 1,000 hours of service and attain the age of 21. Employees became participants on January 1 or July 1 the plan year in which they met these requirements. Participants who were not employed on the last working day of a plan year were generally not eligible for an allocation of Company contributions for such year. Participants who terminate during a plan year due to death, permanent disability or normal retirement were eligible to receive a contribution regardless of hours worked.

Voting Rights

Prior to plan termination, the trustee voted the shares of the Company stock held in the unallocated balance. The trustee was required to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries. With respect to allocated shares, they too were voted by the trustee; however, participants were entitled to direct the trustee as to the manner in which voting rights represent the interest of such participants with respect to significant corporate matters, as defined.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account was credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who were eligible employees of the Company as of the last day of the plan year received an allocation. Allocations were based on a participant's eligible compensation, relative to total eligible compensation.

Vesting

All participants became 100% vested in their accounts on February 10, 2023. Prior to February 10, 2023, if a participant's employment with the Company ended for any reason other than retirement, permanent disability, or death, he or she vested in the balances in his or her account based on total years of service with the Company. Participants vested 20% per year of service starting after having completed two consecutive years of service and are 100% vested after completing six years of service. In the event that the Plan became top heavy, an alternative vesting schedule would be applied. If this event were to occur, all participants would be informed in writing of the new vesting schedule.

Put Option

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company will pay for the purchase in substantially equal periodic payments, with interest, over a period beginning no later than 30 days after the put option is exercised and not exceeding five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Prior to plan termination, diversification was offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Company's common stock into investments, which were more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan could elect to diversify a portion of their account, as described in the plan agreement.

Participant Accounts and Forfeitures

Company contributions and plan forfeitures were allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the plan year. During 2025, no shares were forfeited or allocated to other participants. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance to all participants' account balances as of the allocation date.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

As discussed in Note 1, management determined that liquidation was imminent and accordingly changed from the ongoing basis to the liquidation basis during 2023.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability between market participants at the measurement date. Fair value approximates the amount of cash that the Plan expects to collect in carrying out its plan for liquidation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrued basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments held during the plan year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Unless paid by the Company, all reasonable expenses of maintaining the Plan shall be paid by the Plan. The Company may in its discretion pay certain expenses on behalf of the Plan.

Subsequent Events

Subsequent events were evaluated through November 25, 2025, which is the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation of methodologies used for investments measured at fair value. There have been no changes in the methodologies used at September 5, 2025 and December 31, 2024.

- *Exchange-traded fund*: Valued at the daily closing price as reported by the fund. These funds are held by the Plan and are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

**4. TAX STATUS**

The Internal Revenue Service has determined by an opinion letter for the Plan dated February 25, 2025, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

**5. ADMINISTRATION OF PLAN ASSETS**

Prior to plan termination, the Plan's assets, which consisted of Guardian Fleet Services, Inc. common shares, were held by the trustee of the Plan. Company contributions were held and managed by the trustee.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees will be paid directly by the Company.

**6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Prior to termination, the Plan invested in the Company's common stock and had a note payable to the Company. During 2023, the Company forgave repayment on the note payable. These are related party and party-in-interest transactions. As described in Note 5, the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.
