Notes to Financial Statements

Note 1: Plan Description

The following description of the Fox Valley Metal Tech LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all nonunion employees of Fox Valley Metal Tech LLC (the "Company"), who have completed three months of service and are age 19 or older. Upon satisfying eligibility requirements, an employee is eligible to participate on the first day of the following calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Plan Merger

Effective February 21, 2025, the Plan was merged into the ArmorWorks Retirement Savings Plan, with plan assets being liquidated on that date. The assets of the Plan transferred to the ArmorWorks Retirement Savings Plan totaled \$14,367,559, including \$165,944 of notes receivable from participants. Participants vesting percentages were not changed with the merger.

On the date the notes receivable from participants transferred to the ArmorWorks Retirement Savings Plan, interest rates on existing notes ranged from 3.25% to 8.50%.

Contributions

Each year, participants may elect to contribute to the Plan up to 100% of their eligible compensation, as defined in the plan document, on a pre-tax or Roth basis, subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect another deferral rate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

The Company contributes a safe-harbor matching contribution equal to 100% of the first 1% and 50% of the next 5% of compensation that a participant contributes to the Plan. Rollover contributions are not matched. In addition, the Company may make additional discretionary nonelective contributions to the Plan. Participants must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year to be eligible to receive the Company's discretionary nonelective contribution. The Company did not make any discretionary nonelective contributions for 2025.

Note 1: Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's voluntary contributions, Company safe-harbor matching contributions, and allocations of (a) the Company's discretionary nonelective contributions and (b) plan investment earnings (losses). Participant accounts are reduced by withdrawals and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Participants become 100% vested in the Company's safe-harbor matching contributions, plus actual earnings thereon, after two years of continuous service. Vesting in the Company's discretionary nonelective contributions, plus actual earnings thereon, is based on continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service. In addition, participants become fully vested upon death or disability.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account or other security if the note is for the purchase of a primary residence. Participants may only have one note outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability retirement, death, and termination of employment with vested interests. Benefits are paid in the form of a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's safe-harbor matching and discretionary nonelective contributions. At February 21, 2025 there were no forfeited nonvested accounts. At October 31, 2024, forfeited nonvested accounts totaled \$11,375, which were used during the period from November 1, 2024 to February 21, 2025 and were applied against the Company contribution receivable that was recorded as of October 31, 2024. The Company may decide at its discretion how to use forfeitures under the plan document. During 2025, no forfeited accounts were used to offset Company safe-harbor matching contributions.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted the provisions which were applicable through February 21, 2025.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefit payments on the basis of terms of the plan document.

Note 2: Summary of Significant Accounting Policies (Continued)

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Management Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment management expenses and included in net investment income. Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses. Other administrative expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through December 31, 2025, which is the date that the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

There were no assets or liabilities to be measured at fair value at February 21, 2025, due to the plan merger discussed in Note 1, which was effective February 21, 2025.

Following is a description of the valuation methodologies used for assets measured at fair value.

Note 3: Fair Value Measurements (Continued)

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value ("NAV") of units of the bank collective trust, which is based on the underlying investments held by the fund, less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund would sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the security liquidations are carried out in an orderly business fashion. There were no unfunded commitments at October 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments, notes receivable from participants, non-interest-bearing cash, and due to broker at February 21, 2025 and October 31, 2024, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from November 1, 2024 to February 21, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A. ("Alerus"), the Custodian of the Plan.

Note 5: Party-in-Interest Transactions

Alerus is the Custodian, as defined by the plan document and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Alerus for investment management and administrative services amounted to \$28,816 for the period from November 1, 2024 to February 21, 2025. Certain fees incurred by the Plan for investment-related services are included in net depreciation in fair value of investments, as they are paid to Alerus through revenue sharing rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30 2020, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
