### Independent Auditor's Report

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of FRX Management Holdings 401(k) plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)3(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of FRX Management Holdings 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

##### General:

The Plan is a defined contribution pension plan covering substantially all employees of FRX Management Holdings, LLC (the Company) that are over 18 years old. The Plan's assets are held under a group annuity contract with John Hancock Life Insurance Company, which provides participants with a range of investment options through sub-accounts. These sub-accounts invest in mutual funds and other investment vehicles. The Plan also offers a guaranteed interest account (GIA), which provides a fixed rate of return and guarantees principal and interest. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions:

Participants may make voluntary contributions of their annual base pay on a pre-tax or Roth basis, up to the maximum dollar amount allowed by law (plus catch-up contributions as defined by the Plan document). The maximum voluntary contribution was \$23,000 in 2024, plus an additional \$7,500 contribution in 2024 for those employees that are age 50 and older. A Company safe harbor non-elective contribution is equal to 3% of compensation. Additional non-elective profit-sharing amounts may be contributed at the option of the Plan's board of directors. Contributions are subject to certain limitations.

Participants' voluntary contributions and employer's non-elective contributions are designated under a qualified deferred arrangement as allowed by Sections 401(k) and 401(m) of the Internal Revenue Code.

##### Participants' Accounts:

Each participant's account is credited with their voluntary contribution and employer's non-elective contribution, and allocations of (a) the Company's discretionary profit-sharing contributions, and (b) plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Payment of Benefits:

Upon termination of service, a participant is entitled to receive the vested portion of their account with the remainder being forfeited and used to offset future employer contributions.

##### Vesting:

Participants are immediately vested in their deferral and safe harbor non-elective contributions. Vesting in the employer profit sharing portion of their accounts is determined based upon years of service using a six year tiered vesting schedule. A year of service is defined as a year in which the participant completes 1,000 hours of service.

A participant is automatically fully vested upon attainment of normal retirement age of 65 or termination of employment caused by death or disability.

Notes Receivable from Participants:

Participants may borrow from their account balance with a minimum loan amount of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% above the prime rate. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits:

Upon termination of service due to death, disability, retirement, separation of service, or upon attainment of age 59 1/2, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeitures:

Upon termination of a participant, the employer's profit-sharing contribution to which the participant is not vested shall be forfeited as of the date of the distribution of the participant's account balance. These forfeitures may be used to offset employer contributions at the plan administrator's discretion in a nondiscriminatory manner, reduce administrative expenses of the plan, or to restore forfeited account balances of rehired employees. Forfeitures total \$-0- at December 31, 2024. No forfeitures were used during the Plan year.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and excluded from these financial statements. Plan fees are incurred when a participant uses a particular feature of the Plan, such as a distribution following termination, participant loans, and other features as defined in the Plan agreement. These fees are included in administrative fees when incurred. For the year ended December 31, 2024, the Plan incurred administrative expenses of \$16,685.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

##### Investment Valuation and Income Recognition:

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan's valuation policies utilizing information provided by third-party investment advisers and custodians. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the outstanding loan including accrued interest will become taxable and treated as a "deemed distribution." The loan will be reported and processed as a taxable distribution based on the terms of the Plan document.

##### Use of Estimates:

The preparation of financial statements in accordance with US GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### Payment of Benefits:

Benefits are recorded when paid.

##### SECURE 2.0 Act:

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. The Plan is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2025.

The Plan has implemented applicable provisions of the SECURE 2.0 Act in accordance with the required effective dates outlined in the legislation. The Plan continues to monitor the Act's provisions and any related regulatory guidance. Management does not expect the adoption of these provisions to have a material impact on the Plan's financial statements.

##### Subsequent Events:

Management evaluated all activity of the Plan through, November 21, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

#### **NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of an input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - PARTIAL PLAN TERMINATION**

Based on IRS rules, a partial plan termination can occur if approximately 20% or more of Plan participants are terminated because of an action taken by the Company. If a partial plan termination occurs, affected participants become fully vested in their accounts at the termination date, but the remaining participants' vesting continues to be determined per the plan provisions.

As a result of a reduction of the Company's workforce in 2024, the Plan experienced a partial plan termination as defined by ERISA in 2024. All affected participants were fully vested in their account balances prior to the partial plan termination.

**NOTE F - INCOME TAXES**

The Plan was established using the Siegel Actuarial Consulting Inc Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan which, according to an opinion letter dated June 30, 2020

from the Internal Revenue Service, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in

accordance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE H – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$16,685 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan

Certain Plan investments are managed by the custodian and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.
