- 1. Description of the Plan** The following description of the Torti Gallas and Partners, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Torti Gallas and Partners, Inc. (the "Company"), who have completed one month of service except part-time, temporary, and seasonal employees whose regularly scheduled service is less than 1,000 hours during the relevant eligibility period and student interns. Employees may enter the Plan on the first day of the month coincident with or next following satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan allows for discretionary matching contributions. For the Plan year ended February 28, 2025, the Company contributed 33.33 percent of amounts that a participant contributed to the Plan, not to exceed \$1,000 per participant. Nonelective amounts may be contributed at the discretion of the Company. Participants must complete at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to receive an allocation of any discretionary nonelective contribution. There were no such contributions for the Plan year ended February 28, 2025. The Statement of Net Assets Available for Benefits as of February 28, 2025 and Statement of Changes in Net Assets Available for Benefits for the year then ended, reflect other employer contributions and related receivables required to remediate annual compliance testing failures. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary nonelective contribution, if any, and Plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary nonelective contributions, if any, are based on a formula integrated with the taxable wage base. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid through payroll deductions.

Payment of benefits: Benefits are payable upon retirement at the later of the fifth anniversary of participation or age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Benefits are payable in lump sum or installment payments. In February 2025, the Company elected to implement certain optional provisions of recent legislation in operations, including permitting personal emergency distributions, qualified natural disaster distributions and domestic abuse distributions.

Vesting: Participants are vested immediately in their contributions and Company discretionary matching contributions plus actual earnings thereon. Vesting in the Company discretionary nonelective contributions is based on years of continuous service of at least 1,000 hours a year. A participant is 20 percent vested after two years of service is completed, and vests an additional 20 percent per year until full vesting after six years.

Administrative expenses: Participants are charged an asset based fee for Plan administrative costs. Expenses of maintaining the Plan in excess of the asset based fee are paid by the Company.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions: Participant contributions and the related Company discretionary matching contributions are recognized in the period the participant contribution is withheld from compensation. The Company discretionary nonelective contributions are recognized in the period the related compensation is paid to the participants.

Due to plan sponsor: Due to plan sponsor at February 29, 2024, represents amounts deposited to the Plan in error and were returned to the Company in March 2024.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through December 8, 2025, which is the date the financial statements were available to be issued.

- 3. Certified information** Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at February 28, 2025 and February 29, 2024, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended February 28, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America on behalf of and pursuant to a Power of Attorney granted by Massachusetts Mutual Life Insurance Company and Empower Trust Company, the insurance company and custodian of the Plan.

Investments of \$35,558 and \$29,792 as of February 28, 2025 and February 29, 2024, respectively, were not certified. Interest and dividend income of \$407 and net appreciation in fair value of investments of \$5,359 for the year ended February 28, 2025, was also not certified.

- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2025 and February 29, 2024.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the units of pooled separate accounts is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the accounts. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

5. Investment contract

The Plan participates in a traditional benefit responsive investment contract with Massachusetts Mutual Life Insurance Company ("Mass Mutual"). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Mass Mutual is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Mass Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination or partial termination of the Plan, the breach of a provision in the agreement, the failure of the Plan to meet the requirements of the Internal Revenue Code, or a significant change in the groups or classifications of participants as defined by the contract. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

7. Risks and uncertainties

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

- 8. Tax status** The Plan is a pre-approved plan of Coastal Pension Services, Inc. which received an opinion letter on November 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 9. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Empower Trust Company (Empower). Empower is the custodian as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.

The Company has an agreement that provides for a “Plan Expense Account” (PEA), under which a portion of the revenue earned by Empower with respect to the services they provide for the Plan, including the recordkeeping fees paid from participant accounts, is made available to the Plan to pay expenses. During the year ended February 28, 2025, Empower deposited approximately \$92,000 into the PEA. These amounts have been netted against administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits. The Plan incurred approximately \$84,000 in fees for investment advisory, administration and auditing services during the year ended February 28, 2025, which was paid from the PEA. The balance in the PEA at February 28, 2025 and February 29, 2024 was \$15,340 and \$7,441, respectively, and is included in investments in the accompanying Statements of Net Assets Available for Benefits.
