## **Communications with Those Charged with Governance**

To the Board of Trustees  
Pension Plan for Employees of Woodbury University

We have audited the financial statements of Pension Plan for the Employees of Woodbury University (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) as of and for the year ended February 28, 2025. We have issued our report on the financial statements and ERISA-required supplemental schedules dated December 10, 2025.

### **Our Responsibility Under Auditing Standards Generally Accepted in the United States of America**

As stated in our engagement letter dated March 7, 2025, we are responsible for forming and expressing an opinion about whether the financial statements that have been prepared by management, with your oversight, are prepared, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP). Our audit of the financial statements does not relieve you or management of your responsibilities.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). As part of an audit conducted in accordance with GAAS, we exercise professional judgment and maintain professional skepticism throughout the audit.

An audit of financial statements includes consideration of internal control over financial reporting as a basis for designing audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control over financial reporting. Accordingly, we considered the Plan’s internal control solely for the purposes of determining our audit procedures and not to provide assurance concerning such internal control.

We are also responsible for communicating significant matters related to the financial statement audit that, in our professional judgment, are relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures for the purpose of identifying other matters to communicate to you.

### **Considerations Related to Form 5500 Filing**

Professional standards require that we obtain and read a draft of the Form 5500 that is substantially complete prior to the dating of our auditor’s report. The purpose of this procedure is to identify material inconsistencies, if any, with the audited financial statements. These procedures are not sufficient nor are they intended to determine that the Form 5500 is completely or accurately prepared.

We have read the draft Form 5500, and nothing came to our attention that caused us to believe that such information is materially inconsistent with the financial statements.

## **Planned Scope and Timing of the Audit**

We performed the audit according to the planned scope and timing previously communicated to you in our engagement letter and planning discussions.

## **Significant Audit Findings**

### ***Qualitative Aspects of Accounting Practices***

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements.

No new accounting policies were adopted and there were no changes in the application of existing accounting policies during the year. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. There are no significant transactions that have been recognized in the financial statements in a different period than when the transactions occurred.

### ***Significant Accounting Estimates***

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The most sensitive estimate affecting the financial statements was:

Management's estimate of the actuarial present value of accumulated plan benefits, which is based on the actuary's assumptions as documented in Note 3 to the financial statements. We evaluated the key factors and assumptions used to develop the present value of accumulated plan benefits in determining that it is reasonable in relation to the financial statements taken as a whole.

### ***Financial Statement Disclosures***

The disclosures in the financial statements are consistent, clear, and understandable. Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users.

We did not note any disclosures in the financial statements that we consider sensitive to potential users.

### ***Significant Unusual Transactions***

We encountered no significant unusual transactions during our audit of the Plan's financial statements.

### ***Significant Difficulties Encountered in Performing the Audit***

Professional standards require us to inform you of any significant difficulties encountered in performing the audit. No significant difficulties were encountered during our audit of the Plan's financial statements.

### ***Disagreements with Management***

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. No such disagreements arose during the course of our audit.

***Circumstances that Affect the Form and Content of the Auditor’s Report***

There may be circumstances in which we would consider it necessary to include additional information in the auditor’s report in accordance with GAAS. There were no circumstances that affected the form and content of the auditor’s report.

***Corrected and Uncorrected Misstatements***

Professional standards require us to accumulate all factual and judgmental misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management.

There were no non-trivial misstatements detected as a result of audit procedures that were communicated to management.

***Management Representations***

We have requested certain representations from management that are included in the management representation letter dated December 10, 2025.

***Management Consultation with Other Independent Accountants***

**Form of benefit and basis** 50% of participants are assumed to receive benefits as a single lump sum payable immediately for retirement, death and withdrawal benefits.

12.5% of married participants are assumed to receive a benefit as a 50% joint and life annuity at the assumed retirement age. The remaining participants are assumed to receive a life annuity at the assumed retirement age. This has been updated to reflect the new provision allowing a lump sum payment option. We will monitor and make appropriate adjustments in the future.

The single sum benefit is based on the applicable mortality and the plan's funding target interest rates, as prescribed.

#### Methods prescribed by law

**Liability measure** Funding target is the present value of the benefits accrued on the valuation date.

Target normal cost is based on benefits expected to accrue during the current plan year and includes an estimate of plan expenses for the year.

**Lump sum payments** Lump sum payments are valued using the plan's funding target interest rates as required, per IRS guidance. These rates are currently higher than the actual rates used to determine lump sum distributions. Therefore, plan liabilities do not currently recognize this additional cost and this may result in the plan not accumulating adequate assets. You may wish to consider additional contributions.

#### Methods selected by plan sponsor

**Asset method** The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years. The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

**Segment rates** 24-month average with no weighting to prior law basis. Use rates where February is the last month included in the average.

**PBGC premium basis**

Variable rate premiums are calculated using census, market value of assets and the one-month average of corporate bond rates in effect on the valuation date. You elected this Standard interest method for the 03/01/2014 plan year and the method must be used for five years before a change can be made.

**Methods elected by actuary**

**Retirees**

Assets and liabilities for current and future retirees are included.

**Vested benefits**

A benefit is included in vested benefits if it meets the requirements under PBGC. The benefit is multiplied by the participant’s vesting percentage applicable to each benefit on the valuation date.

The following ancillary benefits are always treated as nonvested: disability benefits payable to retirement age unless in pay status, pre-retirement death benefits in excess of the survivor annuity death benefit and post retirement death benefits for non-retired participants except as noted in the Plan provisions.

**Assumptions and methods elected by actuary - plan accounting (ASC 960)**

With the exceptions below, all assumptions and methods are the same as those used in determining your plan’s regular funding target and target normal cost.

**Mortality**

Based on Pri-2012 total dataset base rate mortality table projected generationally using the using the Principal Mortality Improvement Scale (Principal 2023).

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The total dataset base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe “Approach 1” is reasonable for this plan.

**Interest rate used to value liabilities**

6.25%

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes' arithmetic returns of the plan's target asset allocation, and then converted to the geometric under lognormal distribution assumption. For details, see Long-Term Capital Market Assumptions link.

**Treatment of administrative expenses**

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

#### Basis for lump sums

#### Interest rate

Based on the three segment yield curve: 3.55%/3.95%/4.95%  
The plan document defines the lump sum interest rate based on IRC §417(e) rates which closely tie to the high quality corporate bond yields. According to our most recent study, the long-term expected yields for short/intermediate/long corporate bonds are 3.55%/3.95%/4.95%. For details, see Corporate AA yield in Table 3 of Long-Term Capital Market Assumptions link.

#### Mortality

We have selected the same [mortality](#) assumption for lump sum payments, but with a 50/50 blend of male and female total dataset base rates and mortality improvement scales. This reflects the IRS practice of defining lump sum mortality on a unisex basis.



### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the financial statements of Pension Plan for Employees of Woodbury University, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of February 28, 2025 and February 29, 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Pension Plan for Employees of Woodbury University as of February 28, 2025 and February 29, 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### **Note 1 – Description of Plan**

The following brief description of the Pension Plan for Employees of Woodbury University (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a noncontributory defined benefit pension plan covering substantially all employees of Woodbury University (the Plan Sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan year end** – The plan year is defined as the 12 consecutive months beginning on March 1 and ending the last day of the following February.

**Pension benefits and vesting** – Under the terms of the Plan Document, participants accrue benefits based on a percentage of annual compensation for each year of credited service as follows: for each year of credited service prior to March 1, 1965, those who became members on the effective date are entitled to a monthly benefit of 1.5% of the first \$400 of monthly earnings (determined in the first 12-month period ending March 1, 1965), plus 2.25% of such earnings in excess of \$400; for each year of credited service after February 28, 1965, and prior to March 1, 1989, a monthly benefit of 1.5% of the first \$400 of current monthly earnings, plus 2.25% of such earnings in excess of \$400; and for each year of credited service after February 28, 1989, a monthly benefit of 2.25% of current annual earnings. Participants are eligible for full monthly benefit payments upon reaching age 65 with a minimum of three years of vesting service. If employees terminate before rendering three years of service, the benefits vest as follows: 0% for less than one year of credited service; 33% for one year of credited service; 67% for two years of credited service; and 100% after two years of credited service. If employees terminate before rendering three years of service, they forfeit the unvested portion of accumulated plan benefits. The Plan does not permit early retirement. Employees may elect to receive their pension benefits in the form of a joint and survivor annuity. Terminated vested participants or eligible beneficiaries may elect to receive the value of their accumulated benefits as a lump-sum distribution upon termination or they may elect to receive their benefits as a life annuity payable monthly from retirement.

Effective June 30, 2011, the Plan was amended to freeze participation and benefit accruals, but to allow participants to continue to accrue Credited Vesting Service, as defined by the Plan.

**Death benefits** – If an active employee dies at age 55 or older, a death benefit equal to the value of the employee's accumulated pension benefits is paid to the employee's beneficiary. If an employee dies prior to normal retirement, the spouse will receive death benefits equal to the amount the employee would have received if retired on the day before death under the normal retirement formula.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual basis of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

**Investment valuation and income recognition** – The investments are stated at fair value based on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Payment of benefits** – Benefit payments to participants are recorded upon distribution.

**Expenses** – Administrative expenses related to operating and maintaining the Plan are paid by the Plan Sponsor, and certain investment and transaction fees are paid by the Plan.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

On October 18, 2025, the Board of Trustees voted to begin the process of terminating the Woodbury Pension Plan. The University moved the assets into a conservative investment allocation to protect from future market fluctuations and will begin the process of terminating the Plan in the upcoming year or two, as funding permits. The Plan has evaluated subsequent events through December 10, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 – Actuarial Present Value of Accumulated Plan Benefits**

Accumulated plan benefits are those estimated future periodic payments, including lump-sum distributions, which are attributable under the Plan’s provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees’ compensation. Benefits payable under all circumstances—retirement, death, and termination of employment—are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of the accumulated plan benefits is determined by an actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and the expected date of payment.

The computation of the actuarial present value of accumulated plan benefits was made as of March 1, 2024. Had the valuation been performed as of February 29, 2024 there would not be a material difference.

The significant actuarial assumptions used in the valuation as of February 29, 2024, were (a) mortality based on Pri-2012 total dataset base rate mortality table projected to future years with historical and assumed improvement rates using the Principal Mortality Improvement Scale based on MIM-2021 v4 issued in October 2023, (b) retirement age assumptions (the assumed average age was 65), and (c) interest rate used was 6.25%.

Assumptions used to allow lump sums:

- 50% of participants will elect a benefit paid in a lump sum based on the applicable mortality and the Plan's funding segment rates.
- 12.5% of married participants are assumed to elect a 50% joint and life annuity.
- The remaining participants are assumed to elect a life annuity.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

#### Note 4 – Funding Policy

**Employee contributions** – Contributions by participants are not required or permitted by the Plan.

**Employer contributions** – The Plan Sponsor's funding policy has generally been to make sufficient contributions to maintain a well-funded position, but not less than the minimum required contribution or more than the maximum deductible contributions for the plan year, and also to make additional contributions under certain circumstances to achieve short-term objectives. The Plan has met the minimum funding requirements of the ERISA. Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth by ERISA.

#### Note 5 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2025 and February 29, 2024.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts* – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

#### **Note 6 – Plan Termination**

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by the Plan and its related regulations, generally to provide the following benefits in the order indicated:

- a. To provide benefits to the extent guaranteed by the Pension Benefit Guaranty Corporation (PBGC), a U.S. government agency, for participants, spouses, or beneficiaries who have been receiving pension payments for at least three years as of the date of termination.
- b. To provide benefits to the extent guaranteed by the PBGC for participants who would have been receiving pension payment for at least three years as of the date of termination if they had elected to retire.
- c. To provide benefits to the extent guaranteed by the PBGC for participants, spouses of beneficiaries not included above who have benefits guaranteed under this Plan by the PBGC.
- d. To provide benefits to the extent vested and not provided for above for all participants who have met the vesting requirements.
- e. To provide all other accrued benefits under the Plan.

The Plan provides that if assets available for allocation are insufficient to satisfy in full the benefits of all individuals, the assets shall be allocated pro rata on the basis of the present value as of the termination date of their respective benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. For plan terminations occurring during 2024, that ceiling is \$7,108 per month. That ceiling applies to those annuitants who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

#### **Note 7 – Transactions with Parties-in-Interest**

The Plan invests in a money market separate account managed by Principal Global Investors, an affiliate of Principal Trust Company. As Principal Trust Company is the Plan's trustee, the transactions qualify as party-in-interest transactions as defined by the ERISA.

All administrative expenses are paid by the Plan Sponsor, except for administration fees paid to Principal Trust Company, which are paid by the Plan. Administrative fees are based on the dollar value of assets held by the trustee.

#### **Note 8 – Tax Status**

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated July 7, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
