Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of FruitSmart 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of January 10, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through January 10, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of January 10, 2023 and December 31, 2022, and for the period from January 1, 2023 through January 10, 2023, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 6 of the financial statements, FruitSmart, was acquired by an unrelated party and the Plan began a transfer process that concluded January 10, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Note 1—Description of the Plan

The following description of the FruitSmart 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

General – The Plan is a defined contribution plan, established on July 1, 2016, and is open to substantially all employees of FruitSmart, Inc. (the “Plan Sponsor”), who have met the six consecutive months of service requirement, as defined in the Plan’s provisions, and are age 21 or older. The Plan excludes leased employees and employees covered under a collective bargaining agreement. See Note 6 for disclosures related to the sale of the Plan Sponsor.

Administration – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions – Eligible participants may contribute any percentage of pre-tax and after-tax annual compensation to the Plan, subject to the Internal Revenue Code (“IRC”) limitations for 401(k) plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Such contributions, if any, are recorded as rollover contributions in the accompanying financial statements. The Plan Sponsor in prior years elected to make safe harbor matching contributions up to 100% of the first 3% and 50% of the next 2% of base compensation that a participant contributes to the Plan. The Plan Sponsor may elect to make discretionary profit-sharing contributions. No discretionary contributions were made for the year ended January 10, 2023.

Due to the circumstances described in Note 6, the Company made no contributions for the period January 1, 2023 through January 10, 2023.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution and allocations of the Plan Sponsors’ contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions and the Plan Sponsor matching contributions, plus actual earnings thereon. Vesting in the profit-sharing contributions, plus actual earnings thereon, is based on years of service as defined by the Plan. Vesting is determined according to the following schedule:

Upon employee normal retirement, death, disability, or termination of the Plan, profit sharing contributions become 100% vested.

Note 1—Description of the Plan (continued)

Payment of Benefits – Participants are eligible to receive 100% of their vested account balance upon attaining age 65, death, disability, or break in service. Benefits are paid under various options, as defined in the Plan. Participants may also request in-service hardship distributions, distributions upon reaching 59½ years, and distributions of rollover contributions, subject to the provisions of the plan document.

Investment Options – Participants direct the investment of their contributions and Plan Sponsor contributions into various investment options offered by the Plan.

Forfeited Accounts – Forfeitures which are nonvested portions of participants' accounts at the point of termination from the Plan will be placed in a suspense account and will be restored to the participant if rehired before five one-year breaks in vesting service have occurred. If the participant takes a distribution of their entire vested portion, the non-vested portion will be forfeited at that time. The non-vested amounts are then used to reduce administrative expenses or reduce future employer contributions to the Plan. For the period January 10, 2023 through January 10, 2023, there were no forfeitures used to reduce expenses. As of January 10, 2023 and December 31, 2022, the forfeiture balance was \$-0-.

Administrative Expenses – The Plan pays all asset management and contract administrator fees. All other administrative expenses are paid by the Plan Sponsor. The Plan expenses are allocated based on participant account balances.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Concentration of Credit Risk – Financial instruments that potentially subject the Plan to concentrations of credit risk consist of investments in mutual funds, pooled separate accounts, and common collective trusts. Concentrations of credit risk with respect to investments are limited as the Plan maintains an investment portfolio that is diversified between various publicly traded funds.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Fair Value Measurements – Financial Accounting Standards Board Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The following are descriptions of the valuation methodologies used by Plan management for assets measured at fair value. There have been no changes in the valuation methodologies used during 2023 and 2022:

Mutual Funds – These investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds are deemed to be actively traded and are considered Level 1 investments.

Pooled Separate Accounts – These investments are public investment vehicles valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is calculated using quoted prices in active markets and, therefore, considered to be readily determinable and classified at Level 1 of the valuation hierarchy.

Common Collective Trusts – These investments are valued using NAV provided by the administrator of the trusts. NAV is based on the fair value of the underlying assets owned by the trusts, minus its liabilities, and then divided by the number of shares outstanding. The trusts seek to preserve capital, provide sufficient liquidity, and provide predictable returns. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require a one-year notification in order to ensure securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Contributions Receivable – The amount of participant related contributions that have been deducted from the participant's payroll as of the end of the year but that have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Plan Sponsor are reflected as Employer contributions receivable in the Plan's financial statements.

Payment of Benefits – Benefits are recorded when paid.

Risks and Uncertainties – Investment securities, in general, are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

Note 3—Information prepared and certified by the Qualified Institutions (unaudited)

Plan management has elected the methods of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Principal Life Insurance Company and Principal Trust Company (the "Qualified Institutions") have certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value as shown in the statements of net assets available for benefits as of January 10, 2023 and December 31, 2022.
- Net appreciation (depreciation) in fair value of investments, as shown in the statement of changes in net assets available for benefits for the period January 1, 2023 through January 10, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 6—Plan termination

In November 2019, Fruitsmart Inc. (the Plan's sponsor) announced it had entered into an agreement with an unrelated party to be purchased. The transaction was completed on January 5, 2020, and a resolution was adopted to terminate the Plan. Effective with the Plan termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. Effective January 1, 2023, the Plan ceased all employee and employer contributions into the Plan. Effective January 10, 2023, all participant accounts were made eligible and merged with the Plan of the acquiring company's retirement plan.

Note 7—Tax status

The Plan adopted a prototype non-standardized profit sharing with a cash or deferred arrangement plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated the prototype Plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of January 10, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent to the statements of net assets available for benefits date of January 10, 2023 through October 6, 2025, which is the date these financial statements were available to be issued.
