
To Whom It May Concern:

This Thebco Inc was sold in early 2019 and the new owners kept the name and the new federal id# is **83-4453558**. We have just realized that the new Thebco Inc 5500 forms were filed using an incorrect federal id#. The EIN# used on these returns including Form 8955-SSA was 84-4453558 one digit off in the second number. **The correct federal id# is 83-4453558 and this is the number that should be used on all forms for Thebco Inc. today.**
