### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Flagship Food Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### Note 1. Description of the Plan

The following description of the Flagship Food Group 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General and eligibility:** The Plan is a defined contribution safe harbor plan established January 1, 2010. The Plan is available to all non-union employees of Flagship Food Group, LLC (the Plan Sponsor), and its subsidiaries (collectively, the Employers), who have attained the age of 17. Employees are eligible to participate in the Plan after 30 days of service for Class 1 employees or 60 days of service for Class 2 employees, unless they are excluded per the Plan document, and may enter the Plan on the first day of each month after the eligibility requirements have been met. Excluded employees include nonresident aliens, leased employees, and employees under a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may elect to contribute up to 100% of their annual pretax compensation, as defined in the Plan, not to exceed the limits according to the Internal Revenue Code (IRC). Participants who attain the age of 50 by the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. For the year ended December 31, 2024, the Plan Sponsor made safe harbor matching contributions equal to 100% up to 3% of compensation and 50% of the next 2% of participant compensation.

**Participant accounts and investment options:** Each participant's account is credited with the participant's contributions, employer safe harbor matching contributions and allocations of the Plan's earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on the participant's eligible compensation, participant contributions, investment elections and/or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct both employee and employer contributions to be invested among various investment options offered by the Plan. Participants may change their investment options at any time during the year.

**Vesting:** Participants are immediately vested in their deferral contributions, employer contributions, rollover contributions, safe harbor matching contributions and the allocated earnings thereon.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 less any outstanding balance of loans in the past 12 months from the date the loan is made or 50% of their vested account balance. Loan terms range from one to five years or within a reasonable period of time that is longer than five years for a note used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and generally bear interest at the Wall Street Journal prime rate plus 2%. Principal and interest are paid ratably through payroll deductions. Notes outstanding at December 31, 2024, bear interest at rates ranging from 5.50% to 10.50% and are due through April 2032.

**Payment of benefits:** Upon termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. In-service distributions are allowed for participants attaining the age of 59½. Participants may also elect to roll over their account to another tax deferred account or remain in the Plan until they are legally required to begin taking distributions. Participants may also withdraw money from their account in the event of financial hardship.

#### Note 1. Description of the Plan (Continued)

Terminated participants with vested account balances less than \$5,000 but greater than or equal to \$1,000 will automatically have their vested account balance rolled into an individual retirement account unless they otherwise instruct the third-party administrator and take a lump-sum distribution as soon as practicable following termination. Terminated participants with vested account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination.

**Forfeited accounts:** Forfeitures of terminated participants' non-vested accounts and uncashed distributions are used to pay Plan expenses or to reduce employer contributions, as defined.

**Administrative expenses:** Certain administrative functions are performed by employees of the Employers. No such employee receives compensation from the Plan. Administrative expenses of the Plan are charged against earnings, except to the extent expenses are paid by the Employers.

**Investment management fees and operating expenses:** Certain investment management fees and operating expenses are charged to the Plan for investments in mutual funds and are deducted from income earned on a daily basis and reflected as a component of net appreciation (depreciation) in fair value of investments.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties:** The Plan utilizes various funds as investments instruments. Mutual funds are exposed to various risks, such as interest rate and credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivables are treated as distributions based upon the terms of the Plan document.

**Contributions:** Contributions from Plan participants and the matching contributions from the Employers are recorded in the year in which the employee contributions are withheld from compensation.

**Valuation of investments and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as those held during the year.

Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under terms of the Plan.

**Payment of benefits:** Benefit payments to participants are recorded upon distribution.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through December 1, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan changed its eligibility service period to 30 days for all classes of employees. During 2025, another qualified retirement plan merged into the Plan, resulting in the transfer of approximately \$1,441,000 in assets to the Plan in May 2025.

#### Note 3. Information Certified and Provided by the Trustees

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, that was prepared by or derived from information provided by the trustees and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Empower Trust Company and Empower Annuity Insurance Company of America (Current Trustee) as of December 31, 2024 and for the period November 23, 2024 to December 31, 2024, and Ascensus Trust Company (Prior Trustee) (collectively, the Trustees) as of December 31, 2023 and for the period January 1, 2024 to November 22, 2024, that information provided to the Plan Administrator by the Trustees related to the following assets is complete and accurate:

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 compared to 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds of the Plan are deemed to be actively traded.

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 4. Fair Value Measurements (Continued)

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

There were no transfers in or out of Level 3 assets during the year ended December 31, 2023.

#### Note 5. Fully Benefit-Responsive Investment Contract

The Plan has a traditional, guaranteed investment contract with the Current Trustee. Participants can direct their contributions to be invested in this group fixed annuity contract. This annuity contract meets the criteria of fully benefit-responsive investment contract (FBRIC) and, therefore, is reported at contract value. Contract value is the relevant measure for FBRIC because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with FBRIC is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (the Code) or the failure of the trust to be tax-exempt under Section 501(a) of the Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.

2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

#### **Note 6. Party-in-Interest Transactions**

Transactions with the Trustees, recordkeeper and third-party administrator qualify as party-in-interest transactions. Fees paid by the Plan to these parties amounted to \$39,197 for the year ended December 31, 2024.

#### **Note 7. Prohibited Transactions**

For the year ended December 31, 2024, the Company failed to deposit participant contributions within the required timeframe estimated by their normal business practice totaling \$123,029. The Company will correct the late deposits for the year ended December 31, 2024, outside of the Voluntary Fiduciary Correction Program (VFCP) during 2025, and will compensate participants with lost earnings resulting from the late deposits from the Company's assets and not from assets of the Plan. The Company intends to file Form 5330 and intends to pay applicable excise tax to the Internal Revenue Service.

#### **Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be distributed to the participants of the Plan in accordance with the provisions of ERISA.

#### **Note 9. Tax Status**

The Plan is a non-standardized pre-approved plan sponsored by the Prior Trustee. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain positions that more likely than not would not be sustained upon examinations. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
