Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of United Methodist Homes 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (liquidation basis) as of March 27, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits (liquidation basis) for the period January 1, 2025 to March 27, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of March 27, 2025 and December 31, 2024, and for the period January 1, 2025 to March 27, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of United Methodist Homes 401(k) Plan approved a plan of liquidation on December 20, 2024, and management determined liquidation is imminent. Generally accepted accounting principles require financial statements to be prepared on the liquidation basis when a Plan is in liquidation or when liquidation is imminent. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

1. Description of the Plan

The following description of the United Methodist Homes 401(k) Plan (the “Plan”), as amended, is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan was a defined contribution plan that was established on March 15, 2000, and covered all eligible employees of United Methodist Homes, Inc. and affiliated companies (the “Company” or the “Employer”), as defined by the Plan Document. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

For the years ended March 27, 2025 and December 31, 2024, Empower Annuity Insurance Company of America (“EAICA”), Empower Life & Annuity Insurance Company of New York (“ELAINY”), and Empower Trust Company, LLC (“ETC”) (collectively “Empower”) were the custodian and trustee of the Plan.

In June of 2024, the Employer entered into a membership substitution agreement with Masonicare, Inc. (“Masonicare”) whereby the parties agreed to have Masonicare become the sole member of the Employer. Eligible employees of the Employer became participants in the Masonicare Corporation 401(k) Retirement Savings Plan effective December 31, 2024. As a result, the Plan terminated effective December 31, 2024. Employee and employer contributions were frozen as of December 31, 2024. All assets of the Plan were distributed as of March 27, 2025.

Eligibility

All eligible employees were eligible to begin salary reduction contributions upon attaining age twenty-one and working at least sixty days. Participating employees were required to work twelve months of service with the Employer and attain age twenty-one to be eligible to receive an Employer contribution.

Contributions

Plan participants could voluntarily contribute a portion of their eligible compensation to their employee deferral accounts, on a pre-tax basis or after-tax Roth basis. Participant contributions could not exceed limits specified in the Internal Revenue Code (“IRC”). Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

Each year, the Company would contribute an Employer safe harbor matching contribution which was 100% of the amount an employee contributed up to 4% of eligible compensation. Each year, the Employer could make a discretionary nonelective contribution to the Plan. In order to share in the nonelective contribution, participants must have been employed on the last day of the Plan year and have completed at least 1,000 hours of services.

1. Description of the Plan (*continued*)

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) an Employer contribution and (b) Plan earnings (losses). Allocations were based on participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in any rollover contributions and participant contributions into the Plan plus actual earnings thereon.

All balances were 100% vested upon termination of the Plan.

Notes Receivable from Participants

Participants could borrow from their accounts up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. Participants could not have more than two loans outstanding. Participant loans were secured by the balance in the participant's account and bear interest at rates that were commensurate with the Prime Rate plus 1%. Principal and interest were paid ratably through payroll deductions.

The loan must be repaid within a five-year period, unless the loan is used to acquire the principal residence of the borrower.

Payment of Benefits and Withdrawals

The Plan was designed to provide benefits at the time of retirement. However, if employment with the Company was terminated because of death, disability, or any other reason, a request for distribution of a participant's account balance was also allowed. If a participant died while classified as an active participant of the Plan, the participant's beneficiary or beneficiaries were entitled to receive the participant's vested account balance. If a participant became totally and permanently disabled while employed by the Company, the full value of the participant's account balance could have been distributed upon request.

Upon termination of employment, the vested amount of the participant's account was distributed to the participant in a lump-sum cash payment if the participant's vested account balance was less than \$5,000. If the account balance was greater than \$5,000, the participant's written consent was required for any distribution including the election of a rollover distribution to a new qualified plan. Otherwise, the plan administrator would direct the custodian or trustee to begin distribution no later than April 1 of the calendar year after the participant attains the age of 73. Upon reaching age 59½, pursuant to IRC, participants could have elected distributions from their accounts without any tax penalty.

Subject to certain limitations prescribed by the Plan and the IRC, participants could have elected hardship withdrawals. In accordance with the IRC, a 10% premature distribution penalty tax could have also been imposed on such withdrawals from a participant's account.

Forfeited Accounts

At March 27, 2025 and December 31, 2024, forfeited accounts totaled \$0 and \$2,755. Forfeitures were retained in the Plan and were used to reduce future Employer contributions or Plan expenses. During 2025, no forfeitures were used to reduce Plan expenses and no forfeitures were used to reduce Employer contributions.

ERISA Budget Account

The Plan and Empower entered into a service based pricing arrangement whereby a portion of the revenue earned by certain Plan investments was passed through to the Plan for payment of permitted Plan expenses. The ERISA Budget Account was a nonparticipant directed account within the Plan. The ERISA Budget Account balance was \$0 and \$27 at March 27, 2025 and December 31, 2024. During 2025, no amounts from the ERISA Budget Account was used to reduce Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

As a result of the Plan termination effective December 31, 2024 (see Note 1), in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), the Plan prepared the financial statements on the liquidation basis. The accompanying financial statements are prepared in accordance with U.S. GAAP which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan followed U.S. GAAP guidance on *Fair Value Measurements* which defined fair value and established a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value, except for the guaranteed interest account which was at contract value.

Investment Valuation and Income Recognition (continued)

Mutual funds and the money market fund were valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan were registered with the Securities and Exchange Commission. These funds were required to publish their daily NAV and to transact at that price. The funds held by the Plan were deemed to be actively traded. The fair values of participant units held in the Collective Trust Fund were based on the net assets values per unit as reported by the fund managers. The Collective Trust Fund provides for daily redemptions by the Plan at reported net asset values per share with no advance notice requirement.

The guaranteed interest account, which had been determined to be fully benefit responsive, was valued at contract value, which represented contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded upon a distributable event.

Benefit Payments

Benefit payments were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Company and were excluded from these financial statements. Administrative fees incurred in connection with participant activity were borne by the individual and deducted from their respective Plan assets. Investment related expenses were included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is November 20, 2025.

3. Investments Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at March 27, 2025 and December 31, 2024, and the net appreciation in value of investments, interest and dividends income, and interest on notes receivable from participants for the period January 1, 2025 to March 27, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

* Investments measured at fair values using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments were intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

5. Guaranteed Interest Account

The Guaranteed Interest Account ("GIA") was a fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company ("GWLA"), which was provided through a group annuity contract. Under the terms of the contract, a crediting rate was established for amounts invested in the GIA and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represented contributions plus credited interest less participant withdrawals and fees. Under the GIA, principal and stated rate of interest is guaranteed.

The average yield earned by the Plan and average interest rate credited to the participants for the year ended December 31, 2024 was 2.38%. The average yield earned and the average interest rate credited to the participants was calculated by dividing the annual interest credited to the Plan during the plan year by the average annual fair value.

5. Guaranteed Interest Account (*continued*)

Certain events limited the ability of the Plan to transact at contract value. Such events included but may not have been limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the Employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business. Such events also include: (1) removal from the Plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) Plan disqualification.

No events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's Ratings Services (AA), Moody's Investors Service (Aa3), Fitch Ratings (AA), A.M. Best Company, Inc. (A+).

6. Collective Trust Fund

The Plan's investment in the Collective Trust Fund ("CTF") seeks long-term capital growth through investment in a diversified portfolio of securities of larger, established domestic companies. To implement this objective, the CTF would be invested in the American Century U.S. Premier Large Cap Growth Trust (the "Underlying Fund"), a fund of the American Century Retirement Date Trust for which Global Trust Company is trustee and American Century Investment Management, Inc. is the advisor.

Funds or their affiliates may have pay compensation to Voya Financial ("Voya") affiliates offering a fund. Such compensation may have been paid out of distribution, service and/or 12b-1 fees that were deducted from the fund's assets, and/or may have been paid directly by the fund's affiliates. Any fees deducted from fund assets were discussed in the fund's prospectus and disclosed in the fund fact sheet. Because these fees were paid on an on-going basis, over time these fees would have increased the cost of your investment and may have cost you more than paying other types of sales charges. If offered through a retirement program, additional fees and expenses may have been charged under that program. As of March 27, 2025 and December 31, 2024, there were no unfunded commitments.

7. Related Party Transactions

Certain Plan investments were managed by Empower. Therefore, these transactions qualified as exempt party-in-interest under ERISA.

Participants who were active employees could have borrowed from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Tax Status

The Company had adopted a prototype plan, which received an Internal Revenue Service opinion letter dated November 14, 2022, indicating the prototype plan was designed in accordance with applicable qualification sections of the IRC. The Plan had since been amended; however, the plan administrator believes that the Plan was designed and was being operated in accordance with the applicable requirements of the IRC.

The Plan recognized the effect of income tax positions only if those positions were more likely than not to be sustained. Management had determined that the Plan had no uncertain tax positions that would require financial statement recognition or disclosure. The Plan was subject to routine examinations by taxing jurisdictions; however, there were no examinations for any tax period in progress.

9. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
