## INDEPENDENT AUDITOR'S REPORT

### Opinion

## **Note 1. Description of the Plan**

The following description of the Alan Ritchey, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

### **General**

The Plan is a health and welfare plan covering eligible employees of Alan Ritchey, Inc. (the Company) and their dependents. The Plan was established on July 30, 1976, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan.

### **Eligibility**

The Plan provides health care benefits to all employees and elected dependents. Eligible employees must be regular full-time employees of the Company for at least 90 continuous days. Employees working at least 30 hours a week are considered full-time employees.

### **Benefits**

The Plan offers health benefits, including medical, dental, vision, prescription drug, life insurance, and reimbursement accounts for health care benefits and dependent care to eligible employees and their eligible dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan's comprehensive health care benefits, including medical and prescription drugs, are mostly self-funded. The Plan offers three types of medical plans, including prescription drug coverage, from which participants may choose. The Plan partially insures these benefits through the purchase of annual insurance contracts. The Company pays for a portion of the premiums based on the medical plan elected by each participant.

### **Stop loss coverage**

The Plan Sponsor has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

### **Participation**

All employees who wish to have benefits must enroll upon hire or during the enrollment periods set by the Plan Administrator. An employee who has elected to participate in the Plan (or to waive such participation) may not change such election during the Plan year unless there is a qualified change in status and the participant makes an election change that is consistent with the change in status.

### **Note 1. Description of the Plan, continued**

#### **Contributions**

The Plan is sponsored by the Company and is funded by contributions from participating employees, COBRA participants, and the Company. Active employees make their contributions for health care benefits, which are specified amounts based on applicable monthly premiums for their respective benefit elections, on a pre-tax basis under Section 125 of the Internal Revenue Code of 1986 (the Code). All employee contributions are remitted to the Company, which then remits them to the Plan. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

### **Note 2. Summary of significant accounting policies**

#### **Basis of accounting**

The accounts of the Plan are maintained utilizing the cash receipts and disbursements method of accounting (cash basis), which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). Accordingly, revenues and related assets are recognized when received rather than when earned and expenses are recognized when paid rather than when the obligations are incurred.

The differences between the cash basis and U.S. GAAP are that under the cash basis, contributions may be recognized when received, and claims payments, premium payments, and expenses when paid, while U.S. GAAP requires recognition of contributions when due as a result of a firm commitment or legal or contractual requirement and expenses when incurred.

#### **Use of estimates**

The accompanying financial statements have been prepared using the cash basis of accounting. The preparation of financial statements in accordance with the cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The most significant estimate included in the financial statements is the present value of accumulated Plan benefits.

#### **Payment of claims and insurance premiums**

Claims and insurance premiums are recorded when paid. Any refunds or adjustments to such amounts are recorded when received and are netted with claims paid and insurance premiums in the financial statements.

#### **Stop loss coverage**

Premiums for stop loss insurance are included in insurance premium payments in the accompanying statements of changes in net assets available for benefits – cash basis. Stop loss premiums totaling \$508,447 and \$772,276 for the years ended February 28, 2025 and February 29, 2024, respectively, are included in insurance premiums. Stop loss refunds totaling \$9,877 and \$960,448 for the years ended February 28, 2025 and February 29, 2024, respectively, have been received by the Plan Sponsor and, in some cases, netted with claims paid in the accompanying statements of changes in net assets available for benefits – cash basis.

### Note 2. Summary of significant accounting policies, continued

#### Administrative expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and professional fees. These expenses are reported on the statements of changes in net assets available for benefits – cash basis as administrative expenses. At times, certain administrative expenses of the Plan may be paid by the Company.

#### Subsequent events

The Plan Administrator has evaluated subsequent events through December 8, 2025, the date on which the financial statements were available to be issued.

### Note 3. Benefit obligations

Plan benefit obligations of the Company at February 28, 2025 and February 29, 2024 for health claims incurred by participants but not reported at that date are estimated by the Company by analyzing claim lag studies. Such amounts are reported at an undiscounted amount because amounts typically are payable within one year. Any differences in the amounts estimated and actual amounts will be reported in future years. The approximate present value of accumulated Plan benefits as of February 28, 2025 and February 29, 2024, and the changes in accumulated benefits for the years then ended are as follows:

The present value of benefit obligations as of February 28, 2025 is reported based on claims paid from March 2025 through October 2025 for expenses incurred through February 28, 2025. The present value of benefit obligations as of February 29, 2024 is reported based on claims paid from March 2024 through October 2024 for expenses incurred through February 29, 2024. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### Note 4. Related party transactions and party in interest transactions

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

### **Note 5. Plan termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

### **Note 6. Tax status**

The Plan has applied for exemption from federal income tax provisions as a qualified trust that is tax-exempt under the provision of Section 501(c)(9) of the Code. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for the years ended February 28, 2025 and February 29, 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related trust is tax-exempt.
