Opinion

We have audited the accompanying financial statements of the Ulliman Schutte Construction, LLC Group Health Insurance Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of February 28, 2025 and February 29, 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Ulliman Schutte Construction, LLC Group Health Insurance Plan as of February 28, 2025 and February 29, 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Ulliman Schutte Construction, LLC Group Health Insurance Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Ulliman Schutte Construction, LLC Group Health Insurance Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. DESCRIPTION OF PLAN:

The following brief description of the Ulliman Schutte Construction, LLC (the “Company”) Group Health Insurance Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Company has established a group health plan to provide medical and prescription benefits to eligible employees of the Company and their covered dependents. Participants become eligible after 30 days of employment. The Plan assets are held in a voluntary employees’ beneficiary association (“VEBA”) trust. The VEBA trust was established on February 1, 2012, to collect contributions from the Company and participants to cover the cost of benefits. The funds from the trust may be used for the following purposes: (1) to pay the necessary expenses of the trust; (2) to pay premiums on the policies issued to the Plan; and (3) to provide health care and prescription benefits for covered employees and their dependents and to set aside funds for such purposes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan does not offer any postretirement benefits.

Effective July 1, 2025, the employees of Eagle Concrete – US, LLC, a wholly owned subsidiary of the Company, were able to participate in the Plan upon satisfaction of the Plan’s eligibility requirements.

Contributions

The Plan is funded by contributions from the Company and through employee withholdings. Employees contribute to the Plan based upon the level of coverage elected.

Additionally, under provisions of the Consolidated Omnibus Budget Reconciliation Act, or COBRA, terminated employees may elect to extend coverage for a period not to exceed eighteen months from date of termination by contributing specified amounts as determined annually by the Company.

Self-insured benefits

All Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processor under an administrative service only arrangement. The claims processor pays claims directly to or on behalf of participants and is then reimbursed by the Plan’s VEBA trust. Despite the Plan’s utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop-loss coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The individual stop loss limit was \$70,000 for the years ended February 28, 2025 and February 29, 2024. During 2025 and 2024, the Plan received stop loss reimbursements of \$205,278 and \$346,808, respectively, which are recorded as a reduction of medical and prescription claims paid in the accompanying statements of changes in net assets available for benefits.

Administration

On behalf of the Plan, Cigna Health and Life Insurance Company (“Cigna”) pays participant benefits. A monthly fee, based upon the number of participants in the Plan, is paid to Cigna for claims administration services.

2. SUMMARY OF ACCOUNTING POLICIES:

The following is a description of the significant accounting policies of the Plan.

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Cash

Cash consists of funds on deposit in the VEBA trust checking account. All amounts are covered by insurance under the Federal Deposit Insurance Corporation.

Payment of benefits

All medical claims of participants and their dependents are processed by Cigna. Claim payments are recorded when paid by Cigna. Amounts due to the claims processor that have yet to be reimbursed by the Plan are recorded as payable to claims administrator in the accompanying statements of net assets available for benefits. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits.

Stop-loss insurance and administrative expenses

Premiums for stop-loss insurance coverage are expensed as incurred and are included as premium payments.

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator and the trustee. These expenses are reported on the statements of changes in net assets available for benefits as stop loss premiums and claims administrator fees. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events

The Plan has evaluated subsequent events through December 11, 2025, the date the financial statements were available to be issued.

3. INCOME TAX STATUS:

The VEBA trust funding the benefits of the Plan received a determination letter dated June 18, 2014, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC"). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. The plan sponsor does not believe that the Plan incurred any unrelated business income that would result in income taxes during the years ended February 28, 2025 and February 29, 2024.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

4. PLAN BENEFIT OBLIGATIONS:

The amount of the liability could increase if claim levels, stop loss insurance reimbursements and other factors used to calculate the liability differ from the assumptions used in determining the estimates. It is reasonably possible that the estimate of the liability could materially change in the near term.

5. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

6. RELATED PARTY TRANSACTIONS:

The Plan has engaged Cigna under an administrative services contract to process claims and to provide a stop-loss policy. Total administrative fees and stop-loss premiums paid to Cigna for the years ended February 28, 2025 and February 29, 2024 were \$594,927 and \$653,912 respectively. Cigna is considered to be a party-in-interest.
