Report on the Financial Statements

Opinion

We have audited the accompanying financial statements of Kerberos International, Inc. Health & Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits and of Plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in Plan's benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and of the Plan's benefit obligations of Kerberos International, Inc. The financial statements do not include any adjustments that might result from the outcome of this uncertainty. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kerberos International, Inc. Health & Welfare Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 DESCRIPTION OF PLAN

The following description of Kerberos International, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan and Trust were established June 1, 2023 to provide health and other benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Company makes contributions for participating employees covered under the Plan. For employees covered under contracts issued by federal, state, municipal or other contracting authorities which require the payment of specified fringe dollar amounts, the Company contributes to the Plan based upon an hourly funding formula. Employer contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents.

Benefits

The Plan provides major medical, prescription drug coverage, and dental for eligible participants and their beneficiaries on a self-funded basis. The Plan carries a stop-loss insurance policy which covers aggregate claims in excess of the deductibles as specified in the contract. Other benefits such as limited medical, prescription, vision, life, critical illness, short-term disability, accident, and employee assistance program coverage are provided for through various contracts with insurance companies. The Plan purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company directly from the assets of the Plan.

Retirement

Participants can opt out of some plan benefits and have their contribution allocated to Retirement4Contractors Plan. After subtracting premiums and fees incurred by the Plan, the Plan forwarded the excess contributions to the Company's retirement plan. The retirement plan payable represents excess contributions received from the Company that have not been forwarded to the Company's retirement plan by the end of the year. For the year ended December 31, 2024, total retirement plan contributions totaled \$348,930. Retirement plan contributions payable as of December 31, 2024 and 2023 was \$184,861 and \$111,741, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan maintains its demand deposits in commercial bank accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. Any delinquent contributions were collected subsequent to year end, therefore, no allowance for uncollectible accounts as of December 31, 2024 and 2023 was recorded.

Pre-Funding Deposit

The Pre-Funding Deposit (liability) represents the initial deposit paid by the Plan Sponsor and subsequent funding that exceeded their contracted obligation to the Plan. This liability will be used in subsequent years as a "premium holiday" based on available funds to pay benefits as they come due. The Plan sponsor is ultimately liable to fund any deficiency in the Plan's obligations.

Payment of Benefits

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Benefits are recorded when paid.

Insurance Premiums Payable

Insurance premiums payable are based upon the actual premiums due for December 31, 2024 and 2023, but paid by the Plan after year-end.

Benefit Claims Incurred But Not Reported

The obligation for benefit claims incurred, but not reported is an estimate for self-funded benefits incurred on or prior to December 31, 2024 and 2023, but reported and paid by the Plan after year-end. The estimate was calculated using available claims experience data and projected future claims.

Administrative Expenses

All administrative expenses may be paid out of the Plan unless paid by the Company. During the year ended December 31, 2024, the Plan paid for substantially all administrative expenses, which consisted of administration fees, accounting fees, and other miscellaneous expenses.

Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan was required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan administrator believes the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023, therefore, no tax liability was reflected in these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through December 1, 2025, the date the financial statements were available to be issued.

NOTE 3 TAX STATUS

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 PLAN TERMINATION

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan management or Plan administrator to the other at least 60 days prior to the anniversary date of effective coverage under the Plan.

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 5 RISKS AND UNCERTAINTIES

The estimate for claims incurred but not reported is based on certain assumptions pertaining to available claims experience data and projected future claims. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 6 STOP LOSS COVERAGE

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The Plan maintained an insurance policy with the Fidelity Security Life Insurance Company in 2024 and 2023. The policy provides reimbursement to the Plan for claim amounts paid in excess of \$100,000 per year for each participant.

NOTE 6 STOP LOSS COVERAGE (CONTINUED)

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

During the year ended December 31, 2024, the Plan submitted claims totaling \$590,398 for stop loss recoveries. Of this amount, \$560,861 is receivable from the stop loss carrier as of December 31, 2024.

NOTE 8 ABILITY TO CONTINUE AS A GOING CONCERN

The Plan has negative cash flows from operations primarily due to a \$398,909 outstanding receivable from the Plan sponsor as of December 31, 2024 and a \$560,861 stop loss receivable due to the Plan subsequent to year-end which has not been fully funded to sustain operations. This raises substantial doubt about the Plan's ability to continue as a going concern within one year after the date the financial statements are available to be issued. The Plan sponsor, Kerberos International, Inc., is currently in the process of restructuring debt in order to pay the amount due to the Plan and provide additional funding to the Plan beyond the required funding under the Service Contract Act. The Plan sponsor has secured a line of credit with a lending institution. However, the ability to generate cash flow to meet Plan obligations is not assured. The accompanying financial statements do not include any adjustments that might be necessary if the Plan is unable to continue as a going concern.
