

This letter is being provided to explain a correction relating to the Employer Identification Number (EIN) previously reported for the above-referenced solo 401(k) retirement plan.

During our review of the plan's information, it was determined that the EIN originally used on prior filings was **incorrect**. The plan sponsor has now **updated and amended the plan to reflect the correct EIN**, which is:

The incorrect EIN was used in error and has now been corrected in all internal plan records. The correction does **not** affect plan assets, participant balances, or plan operations. No changes were made to the plan's structure, eligibility, contributions, or any other operational provisions.
