INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees

Opinion

We have audited the accompanying financial statements of Fisher Companies Group Benefit Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis and plan's benefit obligations - modified cash basis as of March 31, 2025, and the related statements of changes in net assets available for benefits - modified cash basis and changes in plan's benefit obligations - modified cash basis for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and plan's benefit obligations as of March 31, 2025, and the changes in its net assets available for benefits and changes in plan's benefit obligations for the year then ended, in accordance with the modified cash basis of accounting as described in Note B.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements are prepared using the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTE A - DESCRIPTION OF PLAN

The following description of the Fisher Companies Group Benefit Plan ("the Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsors.

General

The plan was established and began providing health benefits on March 1, 2015. The Plan elected to change its year-end from February 28 to March 31, effective March 1, 2019. In addition, the Plan changed its name from Fisher Companies Voluntary Employee Benefit Plan to Fisher Companies Group Benefit Plan, effective April 1, 2019.

The Plan provides health and other benefits covering substantially all employees of the nine participating companies (Fisher Companies, LLC; Fisher Sand and Gravel Company; Central Asphalt, Inc.; Mt. Pleasant Central Concrete Products Company, Inc.; Fisher Contracting Company; Fisher Transportation Company; Buck's Run Golf Club, LLC; Bay Aggregates, Inc.; and Fisher Construction Aggregates, Inc.). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The plan provides health benefits, (medical, vision, dental and prescription drugs), life insurance and accidental death and dismemberment ("AD&D") benefits, covering any active, full-time employee after completion of the waiting period. The Plan was amended on October 31, 2023 to include a miscellaneous coverage for human organ and tissue transplant benefits.

Self Insured Benefits

The Plan self-insures the medical and prescription drug benefits by offering a traditional Preferred Provider Organization ("PPO") with three prescription drug options or a Health Savings Account PPO option. The prescription claims are included with the health claims in the Statements of Changes in Net Assets Available for Benefits - Modified Cash Basis. The total prescription claims for the years ended March 31, 2025 and 2024 were \$801,941 and \$691,757, respectively.

Captive Insurance

On April 1, 2023, the Plan entered into an agreement with Well Health Insurance, LTD., a captive insurance company ("the Captive"). The Captive provides three levels of risk reduction to limit the Plan's exposure after self-insured benefits: the member loss fund, member assessment, and the captive risk sharing. The member loss fund is funded through the premiums paid to the Captive to cover claims above the self-insured ceiling. Once the member loss fund is exhausted, the Captive will assess additional claims that may need to be paid. The Captive may request up to 50% of the member loss fund to cover the member assessment. Captive risk sharing is used for any claims over the member assessment. This risk is shared on a pro rata basis between the members of the Captive, covering up to \$350,000 of claims in the aggregate.

The Plan has the opportunity to receive dividends for excess premiums paid over paid claims, reserves and costs. The Plan uses the modified cash basis of accounting and the amount of the dividend to be received cannot be reasonably estimated. A receivable is not recorded in the Plan's financial statements until the dividend is declared.

Stop-Loss Coverage

During the year ended March 31, 2024, the Plan, through the membership with the Captive, entered into an agreement with Berkley Accident and Health for stop-loss insurance. This covers all claims in excess of the captive risk sharing. There is an unlimited loss ceiling for the stop-loss insurance for the years ended March 31, 2025 and 2024. Total benefits paid for health claims by stop-loss recoveries during the plan years ended March 31, 2025 and 2024 were \$229,439 and \$60,299, respectively.

The Plan purchases annual insurance contracts for vision, dental, life, AD&D and transplant benefits.

Health claims of active participants, dependents and beneficiaries were processed by Administration Systems Research Corporation International d/b/a ASR Health Benefits ("ASR") for the years ended March 31, 2025 and 2024, as third-party administrators under administrative services-only arrangements. Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

Wellness Incentive Policy

On January 1, 2025 the Plan signed a Wellness Incentive Policy. This policy is designed to encourage employees of the Fisher Companies and their dependents to prioritize preventive healthcare. Employees and their dependents, who are enrolled in the Company's medical, dental and vision plans and are non-smokers, can receive a financial incentive by annually completing the following preventive visits: a physical exam, a vision exam and a dental cleaning ("Annual Preventive Visits"). Upon completion of the Annual Preventive Visits, the employee must provide substantive proof of the visits and will receive the financial incentives for the following plan year, starting April 1, 2025. After one year of compliance, eligible employees and their dependents, who complete the Annual Preventive Visits for that year, will qualify for a freeze in their weekly contribution rate starting the plan year that begins on April 1, that follows the last day of the calendar year. Eligible employees and their dependents, who complete the Annual Preventive Visits for five consecutive years will qualify for a 50% reduction in their weekly contribution rate starting the plan year that begins on April 1 that follows the last day of the fifth consecutive calendar year. Eligible employees and their dependents, who complete the Annual Preventive Visits for ten consecutive years will qualify for a 100% reduction in their weekly contribution rate starting the plan year that begins on April 1 that follows the last day of the tenth consecutive calendar year.

Contributions

The Plan agreement provides that each of the nine participating companies make monthly contributions to the Plan for each employee covered by the Plan. The employer's contribution rate per employee was determined by the Plan's management. In addition, employees pay a portion of the contribution as determined annually by management.

Vesting

There are no vested rights to current or future benefits under the Plan.

Other

The Plan and any provision thereof may be modified or amended at any time by the participating companies' management upon their approval of such modification or amendment. The Plan may be terminated at any time by the participating companies' management, upon authorization of such termination, effective as of the date of such authorization or at such later date as the participating companies' management may provide. The rights of the Plan participants are limited to expenses incurred before termination.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the modified cash basis of accounting. Benefit payments and other expenses are recognized when incurred, other than those for claims incurred, but not yet reported as of year-end. Accordingly, no liability is recorded for future payment of current benefit obligations that have not been reported. Revenues are recognized when earned. Reimbursement under stop-loss coverage and rebates are not revenue and are therefore recorded in the same period as the expense.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Cash

The Plan holds cash that is stated at cost, which is the same as current value.

Restricted Cash

Restricted cash consists of cash paid to the Captive for collateral. The collateral is calculated based on 50% of the member loss fund premiums. This will be held by the Captive as restricted cash and will only be used if the member is assessed a charge for additional claims.

Medical Claims Deposit/Payable

In accordance with the Plan's contract with ASR, the Plan is required to maintain a \$250,000 deposit with ASR to pay future claims. During the course of each month, ASR pays claims as necessary with the deposit and may also request additional funding from the Plan to pay claims in excess of \$250,000 net of any stop-loss recoveries received during the month. At month-end, ASR evaluates all activity for the month and invoices the Plan for an electronic funds transfer to replenish the deposit account to \$250,000 in the first few days of the subsequent month. At year-end, there could be a medical claims payable or a medical claims deposit based on the timing of claims. The ASR medical claims payable was \$24,819 at March 31, 2025 and the ASR medical claims deposit was \$21,941 at March 31, 2024.

In accordance with the Plan's contract with Delta Dental, the Plan is required to maintain a \$14,100 pre-funded claims deposit with Delta Dental. The medical claims deposit balance was \$14,100 at March 31, 2025 and 2024.

Estimates

Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions may affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities and the reported revenues and expenses. Accordingly, actual results may differ from those estimates.

NOTE C - CONCENTRATION OF CREDIT RISK

The Plan maintains all of its cash at one institution that occasionally exceeds the Federal Deposit Insurance Corporation limits during the year. Accounts at this institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. At March 31, 2025 and 2024 the Plan's uninsured cash balance was \$0.

NOTE D - RELATED PARTY TRANSACTIONS

For the years ended March 31, 2025 and 2024, the Plan contracted with ASR to process the Plan's claims, and ASR therefore qualified as a party-in-interest. The monthly fees paid to ASR and its suborganizations for services are based on the number of Plan participants in each participating company. The total fees paid were \$155,784 and \$146,473 for the years ended March 31, 2025 and 2024, respectively. Additional commissions and fees were \$122,980 and \$120,203 for the years ended March 31, 2025 and 2024, respectively.

The Plan had a counseling services agreement with General Agency for the years ended March 31, 2025 and 2024. Fees paid to this party-in-interest for the years ended March 31, 2025 and 2024 were \$84,144 and \$81,108, respectively. The Plan's auditor during the years ended March 31, 2025 and 2024 was Boge, Wybenga & Bradley PC. Fees paid to this party-in-interest for the years ended March 31, 2025 and 2024 were \$16,000.

NOTE E - TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated April 29, 2022 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Management has analyzed the tax positions taken by the Plan and has concluded that as of March 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax returns for the prior three years remain subject to examination.

NOTE F - BENEFIT OBLIGATIONS

In accordance with the modified cash basis of accounting, the Plan's benefit obligations are based on actual benefit payments paid (less any stop-loss recoveries) subsequent to the end of the plan year on claims incurred prior to the end of the Plan's year.

NOTE G - TERMINATION OF PLAN

Although it has not expressed any intention to do so, the plan sponsors have the right under the Plan to modify the benefits provided to and contributions required from participants and to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants under any comparable plan or plans. No assets of the Plan may revert to the plan sponsors or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE I - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices for identical assets or liabilities in active markets that management has access to on the measurement date.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and based on management's assumptions which are based on the best available information.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Captive investment: The Company has a minority ownership interest in a group captive. This investment is classified as level 2 under the fair value hierarchy as its inputs are quoted for identical assets in markets that are not active.
