NOTE 1 – DESCRIPTION OF PLAN

Empower HR 401(k) Plan is a qualified retirement plan adopted by Empower Service Corporation effective January 1, 1995, to provide eligible employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was restated effective April 1, 2022, and amended effective October 1, 2024. The Plan is a multiple-employer plan. Other companies who participate in and have adopted the provisions of the Plan include, Discovery Medical Network Inc., D & Co, LLP (formerly Durbin & Company LLP), Falcon Healthcare Inc, Remarkable Hospice Inc., and Discovery Medical Network Matagorda, LLC. Empower Service Corporation and the participating employers are collectively referred to as the Company. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following is a brief description of the principal features of the plan document. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees of the Company who have attained age 18 and completed 2 months of service are eligible to participate in the Plan. Employees will become a participant on the first day of the month coinciding with or next following the date they satisfy the eligibility requirements.

Contributions: Each participant may elect to reduce their compensation by a specific percentage or dollar amount of eligible compensation and have that amount contributed to the Plan as a salary deferral, not to exceed the dollar limit set by law. Salary deferrals can be in the form of pre-tax 401(k) deferrals, Roth 401(k) deferrals, or a combination of both. Effective February 1, 2023, the Plan adopted an auto-enrollment feature. New employees will be automatically enrolled in the Plan at 3% unless they formerly opt-out. The Plan provides that participants who are at least age 50 or will attain age 50 before the end of the calendar year may elect to defer additional amounts called catch-up contributions. Participants may revoke or make modifications to their salary deferral election at any time during the Plan year.

The Plan is referred to as a safe harbor 401(k) plan. The Company will make a safe harbor matching contribution equal to 100% of a participant's salary deferrals that do not exceed 3% of the participant's eligible compensation plus 50% of a participant's salary deferrals between 3% and 5% of the participant's eligible compensation. The safe harbor matching contribution is 100% vested.

Participants are permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as a rollover contribution.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their contributions, rollovers, and safe harbor matching contributions plus actual earnings thereon.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Payment of Benefits: If a participant's vested account balance does not exceed \$5,000, then their vested balance may only be distributed to them in a single lump-sum payment. If a participant's vested account balance exceeds \$5,000, they may elect to receive a distribution in a single lump-sum payment, installments, or partial withdrawals and they must consent to any distribution before it may be made.

A participant may be entitled to receive an in-service distribution. Generally, a participant may receive a distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59½ or need to satisfy certain immediate and heavy financial needs in the event of financial hardship.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions. Participants may repay the entire outstanding balance of the loan (including any accrued interest).

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant accounts will continue to be 100% vested. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable.

Administrative Expenses: The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. There are certain other expenses that may be paid just from a participant's account. These are expenses that are specifically incurred by, or attributable to, the participant.

Subsequent Events: Effective January 1, 2025, the Plan was amended to expand recognition of prior service with additional employers for eligibility, vesting, and contribution purposes. The amendment has no effect on the Plan's net assets as of December 31, 2024. Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company (The Standard).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Self-Directed Brokerage Account: Account primarily consist of mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund’s net asset value per unit.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of pooled separate accounts managed by The Standard. The Standard is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to the service provider qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
