INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Swedish Match Retiree Medical Plan (Non-Union)

Opinion

We have audited the financial statements of the Swedish Match Retiree Medical Plan (Non-Union) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) and of plan benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits (modified cash basis) and in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Swedish Match Retiree Medical Plan (Non-Union) (the Plan) provides only general information. Participants should refer to the Plan agreement or summary Plan documents for more complete information.

General: The Plan is a health benefit plan which provides hospital, medical, prescription and surgical benefits for eligible retirees of Swedish Match North America LLC and its affiliates (Company) and their dependents, through fully-insured and self-insured products. Certain Plan assets are held in a voluntary employees' beneficiary association trust (Trust). The Benefits Committee controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

Trustee: Northern Trust Company is the Trustee of the Plan.

Eligibility: Salary and Hourly employees of the Company not under a collective bargaining agreement, hired before January 1, 2008 who are at least age 40 with ten years of service are considered active participants in the Plan. Salary and Hourly retirees with at least ten years of service who retire at age 55 or older are eligible to receive benefits under the plan. Certain other retirees have been grandfathered into the Plan. Surviving spouses of the retiree participants are also eligible to participate in the Plan. Eligible retirees must have been covered under the Company's health benefit Plan in order to elect coverage for the Plan.

Benefits: The Plan provides health care benefits (hospital, medical, prescription and surgical) to eligible Salary and Hourly retirees of the Company and their dependents. The maximum benefit per lifetime for covered health care benefits received by an eligible member of the Plan is \$1,000,000. The Plan also provides life insurance benefits to eligible retirees, with coverage ranging from \$5,000 to \$25,000, depending upon a retiree's pre-retirement base pay.

Insured benefits: The Plan fully insures health care benefits for participants who have reached age 65 and are otherwise eligible for Medicare benefits. Premiums are paid to the insurance companies by the Company and reimbursed with assets of the Trust. A portion of the premiums is also collected from retirees and remitted to the insurance companies by Mercer, one of the Plan's third party administrators. This portion of the premiums is included in the Plan statement of changes in net assets available for benefits, but is not reimbursed by the Trust.

The Plan also provides fully insured benefits for life insurance. Premiums are fully paid to the insurance company by the Company and reimbursed with assets of the Trust.

Self-insured benefits: Health care benefits for participants under age 65 are self-insured. The claims for self-insured medical benefits are processed by Anthem Blue Cross and Blue Shield pursuant to an Administrative Service Only Contract. Prescription drug claims are administered by CVS/Caremark Prescription Services pursuant to a Master Services Agreement. The claim processors pay claims directly to or on behalf of participants and are then reimbursed by the Company. The Company is then reimbursed by the Trust. A portion of the contributions is also collected from retirees and remitted to the Trust by Mercer, to fund a portion of the claims expense. Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

Note 1. Description of the Plan (Continued)

Stop loss coverage: The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as aggregate exposure for all claims). Payments for stop-loss insurance are included in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds received related to claims paid were \$802,799 for the year ended December 31, 2024, and have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Contributions: Contributions are made by retirees to provide medical coverage for themselves and their dependents. Contributions are made by the Company in amounts sufficient to fund the Plan expenses which exceed retiree contributions. The Plan Administrator and management of the Company believe that the Plan conforms with the requirements of ERISA.

Payment of benefits: The Plan's maximum payout of health care benefits is \$350,000 per covered individual per year. Individual claims over \$350,000 were also covered by stop-loss insurance. Any claim amounts exceeding the maximum payout are covered by stop-loss insurance. Premium payments for the stop-loss insurance coverage are funded by the Company and reimbursed by the Trust.

Plan termination: Although it has not expressed any intention to do so, the Company has the right at any time to discontinue the insurance coverage and terminate the Plan subject to the provisions set forth in the Internal Revenue Code (IRC) and ERISA. Upon termination of the Plan, all contributions will terminate and the remaining assets of the Trust will be used to provide benefits to participants.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan prepares financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Under this basis of accounting, the only asset recognized in the financial statements is investments. There were no investments as of December 31, 2024 or 2023. All transactions, unless otherwise noted, are recognized in the financial statements as either cash receipts or cash disbursements. The modified cash basis of accounting differs from generally accepted accounting principles primarily because accounts receivable, prepaid expenses, accounts payable, and accrued expenses (other than those described in Note 6) are not included in the financial statements.

Use of estimates: The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, benefit obligations, and changes therein, incurred but not reported claims payable, and other disclosures. Actual results could differ from those estimates.

Actuarial cost method: The post-retirement benefit obligation is computed in accordance with the provisions of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 965 and is equal to that portion of the total Expected Post-retirement Benefit Obligation deemed to have been earned to date calculated, using the projected Unit Credit Method.

Payment of benefits: Self-insured benefits are recorded when paid by the Company to the Plan's claims processors. Insured benefit payments (premiums) are recorded when paid by the Company.

Rebates: Prescription rebates are paid by the prescription claims processor to the Company as part of an agreement between the Company and the prescription claims processor. Rebates received related to claims paid were \$89,390 for the year ended December 31, 2024, and have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Subsequent events: The Plan has evaluated subsequent events through October 13, 2025, the date these financial statements were available to be issued.

Note 3. Benefit Obligations

Post-retirement benefit obligations: A post-retirement benefit obligation has been recognized for retiree health care benefits. The benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the Company and from existing assets of the Plan. Post-retirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the Company.

The actuarial present value of the expected post-retirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The following changes were made for the December 31, 2024, funded status measurement:

- The discount rates were updated to use the September 30, 2024, Mercer Yield Curve.
- Health care claims/contributions and the administrative expense assumptions were updated to reflect recent experience.

The assumed ultimate trend rate and grade-down period are based on macroeconomic principles. These assumptions reflect assumed long term general inflation, nominal gross domestic product growth rates, and the excess of national health expenditures over other goods and services, and an adjustment for an assumed impact of population growth.

The health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by one percentage point in each year, it would increase the plan benefit obligation by \$7,112,000 and \$6,636,000 as of December 31, 2024 and 2023, respectively.

Claims incurred but not reported: Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Note 4. Tax Status of the Plan and Trust

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated November 19, 2018, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time, the Trust may be subject to income taxes. No state or federal income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and the Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRS and, therefore, believes that the related Trust is tax-exempt.

Auditing standards generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Risks and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades.
