Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tnemec Company, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1. Plan Description

The following description of Tnemec Company, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Tnemec Company, Inc. and its wholly owned subsidiaries Tex-Cote, LLC and Epoxytec, LLC (the Plan Sponsor), with the exception of nonresident aliens, employees covered under a collective bargaining agreement, independent contractors, and leased employees. Participants hired before October 1, 2024 are eligible to participate in the 401(k) portion of the Plan and receive discretionary employer matching contributions upon hire. Participants hired on or after October 1, 2024 are eligible to participate in the 401(k) portion of the Plan and receive discretionary employer matching contributions after completion of two months of service. The Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participating employees may elect to contribute to the Plan up to 100% of their annual earnings, subject to certain limitation under the Internal Revenue Code (IRC). New participants are automatically enrolled at 5% of their eligible wages, unless the participant specifically elects not to participate in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to make pretax or Roth contributions. The Plan also allows rollover contributions from other qualified plans.

The Plan Sponsor, at its discretion, will contribute (match) a specified percentage of each participant's contribution in an amount not to exceed a certain limit of the participant's annual compensation. For the year ended December 31, 2024, the Plan Sponsor made a discretionary matching contribution equal to 50% of each participant's contribution in an amount not to exceed 5% of the participant's annual compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator, or into individual brokerage accounts offered by the Plan in 1% increments. Participants may change their investment options daily.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Plan Sponsor contribution and Plan earnings, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. A participant may have two loans outstanding at one time. These transactions are treated as transfers between the investment fund and the participant notes receivable fund. The notes receivable are secured by the balance in the participant's account, bear interest at rates commensurate with the current prime rate (8% at December 31, 2024), and mature through 2032. Notes receivable must be paid back within five years, except if the note receivable is used to purchase a primary residence, in which case the note receivable must be repaid within 15 years. Principal and interest are paid ratably through payroll deductions.

Note 1. Plan Description (Continued)

Vesting: Participants are immediately vested in participant contributions plus earnings thereon. Each participant is 20% vested in the Plan Sponsor's discretionary matching contributions after two years of service and an additional 20% at the end of each succeeding year until the employee is 100% vested after six years. Participants will be 100% vested in Plan Sponsor discretionary matching contribution accounts upon termination of employment on or after attaining age 65 or if participant terminates employment due to death or total and permanent disability (as defined under the Plan).

Payment of benefits: Upon retirement or termination of employment, Plan participants are entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. If the balance of a terminated participant's account does not exceed \$1,000, the participant will receive a lump-sum payment in the absence of other instructions. If the participant's account balance exceeds \$1,000 but does not exceed \$5,000 then the Plan will distribute the funds to an individual retirement account if the participant did not make an affirmative election to either receive a distribution or rollover the distribution. In-service distributions are not permitted unless the participant has attained age 59½, certain hardship conditions are met or rollover contributions are available. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½. Benefits are payable in lump-sum payments with certain exceptions allowed.

Forfeitures: Forfeitures represent the nonvested portion of employer contributions and net investment income upon employee termination. Forfeited amounts are used to reduce future employer contributions or may be applied to pay expenses of the Plan to the extent not paid by the Plan Sponsor. Any remaining amounts forfeited shall be allocated to participants' accounts. Forfeitures of \$9,978 were used to reduce employer discretionary matching contributions to the Plan during the year ended December 31, 2024. Forfeited nonvested accounts totaled \$53 and \$0 at December 31, 2024 and 2023, respectively.

Plan termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer discretionary matching contributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes therein. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants and the discretionary matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Note 2. Summary of Significant Accounting Policies (Continued)

Allowance for credit losses: The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivable. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management recorded no allowance for credit losses as of December 31, 2024 and 2023, as all amounts were determined to be fully collectible.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's Board of Directors determines the Plan's valuation policies utilizing information provided by the custodian. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in supplemental schedule, schedule H, part IV, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefit payments are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable from participants that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation in the fair value of investments.

Note 3. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2022, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quote prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of relevant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Registered investment companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Brokerage accounts: Accounts primarily consists of mutual funds and common stocks that are valued based on the readily determinable market prices.

Common collective trust: Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a public-quoted price in an active market. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value.

Newport Trust Company, LLC and Ascensus Trust Company are the custodians as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Newport Trust Company, LLC amounted to \$5,716 for the year ended December 31, 2024. Fees paid by the Plan to Ascensus Trust Company amounted to \$0 for the year ended December 31, 2024. Fees paid by the Plan for investment management services are netted against investment income.
