We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - PLAN DESCRIPTION

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The United Contractors, Inc. Employee Stock Ownership Plan (the "Plan") is a defined contribution plan covering all employees of United Contractors, Inc. (the "Company"). The Plan operates in relevant part as an employee stock ownership plan (ESOP) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees of the Company are generally eligible to participate in the Plan after performing one hour of service.

Each participant is entitled to exercise voting rights attributable to leveraged shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustees are permitted to vote allocated shares purchased directly by the trust.

2. Participant Accounts

Each participant's account is credited an allocation of the Company contribution based on hours worked during the Plan year. Earnings, including gains and losses, for the Plan year are allocated to all participants' separate accounts on the basis of each participant's opening account balance for the Plan year less distributions and charges to each participant's account during the Plan year.

3. Vesting

A participant's account becomes 100 percent vested if any one of the following three conditions are met:

1. Completion of six years of service
2. Attaining normal retirement age of 60 years
3. Disability or death

3. Vesting - Continued

Participants vest 20 percent per year of service after two years of service, and are 100 percent vested after six years of service. Participants earn a year of service by completing 1,000 hours of employment during a plan year.

4. Payment of Benefits

Fully Vested Participant:

On termination of service a fully vested participant is eligible for distributions in the following plan year.

Partially Vested Participant:

On termination of service a partially vested participant is eligible for distributions of their vested portion in the following plan year.

Participant electing a distribution with a vested balance of \$5,000 or less, will receive a lump-sum payment. Participant electing a distribution with a vested balance greater than \$5,000, are paid in annual installment over a period not exceeding five years plus one additional year (but no more than five additional years) for each \$205,000 by which the account balance exceeds \$1,230,000. Participants may elect to defer any distributions until attaining the age of 60. The plan does not provide for any annuity distributions.

5. Forfeitures

Forfeitures are first used to pay the Plan's ordinary and necessary administrative expenses. Any balance remaining will be allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Participants' accounts were allocated \$169,351 of Plan forfeitures for the year ended March 31, 2025. The Plan had \$0 of forfeitures that had not been allocated.

6. Administration of Plan Assets

The Plan's assets, which consist principally of United Contractors, Inc. common shares, and fixed income and equity common trust funds are held by a trustee of the Plan. Company contributions are held and managed by the trustee, which invests cash received and interest income and makes distributions to participants. A trustee also administers the payment of interest and principal on the loan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid directly by the Plan.

7. Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

8. Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

9. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

In addition, upon termination of the Plan the trustees shall direct the trust to pay all liabilities and expenses of the trust and to sell shares of financed stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note J for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and distribution income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

S Distribution's income are recorded when received.

Payment of Benefits

Benefits are recorded when paid.

NOTE C - CONTRIBUTIONS

The Company made discretionary contributions to the Plan. The Company contributed \$2.00 per hour worked in the year ended March 31, 2025, for all employees in the Plan.

NOTE D - UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE

The 2025 and 2024, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended March 31, 2025, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Great Banc Trust Company in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$22,064,691 and \$22,703,283 at March 31, 2025 and March 31, 2024, respectively and related net income of \$1,169,630 for the year ended March 31, 2025.

NOTE E - TERMINATED PARTIALLY VESTED PARTICIPANTS

Partially vested participants who have terminated, share in plan earnings until they have incurred a forfeiture break in service for five consecutive years. After five years their nonvested account balance will be forfeited and reallocated.

NOTE F - TAX STATUS

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Internal Revenue Service has determined and informed the Company by a letter dated October 29, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - PARTY IN INTEREST

The Plan's investments are managed by GreatBanc Trust Company. GreatBanc Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund.

Fees paid by the Plan for legal, accounting, appraisal, and other administrative expenses services totaled \$34,530 for the year ended March 31, 2025.

NOTE I - DATE OF MANAGEMENT'S REVIEW

Subsequent events were evaluated through December 5, 2025, which is the date the financial statements were available to be issued.

In December 2025, The Company anticipates providing a loan to the Plan to facilitate the segregation of part or all the balances attributable to terminated participants, resulting in a re-leverage transaction. Additionally, in March 2026, the Company expects to acquire 3,410 shares from shareholders of the Sponsor and subsequently sell those shares to the ESOP in a leveraged transaction.

NOTE J - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The Plan's valuation methodology used to measure the fair value of mutual funds was derived from quoted market prices of active markets.

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 3 Fair Value Measurements*

The fair value of the Company common stock is based on an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches consistent with prior years. The appraiser took into account significant unobservable inputs including historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

The ESOP Administration Committee, under the supervision of the Company's Board of Directors, determines the fair value measurement policies and procedures in consultation with the Company's chief financial officer. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information. The resulting value was \$2,641 and \$2,501 per share at March 31, 2025 and 2024, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
