Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Bi-Mart Corporation Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of February 22, 2025 and February 24, 2024, and the related statement of changes in net assets available for benefits for the fiscal year ended February 22, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Bi-Mart Corporation Employee Stock Ownership Plan as of February 22, 2025 and February 24, 2024, and the changes in its net assets available for benefits for the fiscal year ended February 24, 2024, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Bi-Mart Corporation Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan Agreements for a more complete description of Plan provisions.

History and general – Bi-Mart Corporation (the Company or Plan Sponsor) established the Plan effective February 2003. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (the Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by a committee comprised of three persons appointed by the Company's Board of Directors. The trust department of GreatBanc Trust Company, an independent third-party bank, is the Plan's trustee (the Trustee). Accordingly, GreatBanc Trust Company is considered a party-in-interest under ERISA.

In February 2004, the Plan acquired 100% of the outstanding stock of Bi-Mart Acquisition Corporation (BMAC), parent company of the Plan Sponsor (the ESOP Transaction). The ESOP Transaction was funded through a combination of debt financing obtained by BMAC in connection with the ESOP Transaction and approximately \$12.4 million of funds received from Bi-Mart Corporation Defined Contribution Retirement Plan (DCRP) participants who elected to make a one-time transfer of a portion of their account balance to the Plan.

The Plan purchased BMAC common shares using the proceeds of the ESOP Transaction (see Note 6) and holds the stock in a trust established under the Plan. The borrowings were repaid over a period of 20 years by fully deductible corporate contributions to the Plan. As the Plan made each payment of principal and interest an appropriate percentage of stock was allocated to eligible employees' accounts in accordance with applicable regulations under the Code.

The borrowings were collateralized by the unallocated shares of stock. There are no rights against shares once they are allocated under the ESOP. As of February 24, 2024, the loan was paid in full and all shares were allocated to participants. The Company may periodically make additional contributions of cash or previously repurchased stock to the ESOP on a discretionary basis as approved by the Company's board of directors. For the fiscal year ended February 24, 2024, 456,111 shares were allocated to participants. For the fiscal year ended February 22, 2025, 497,866 shares were contributed to the plan.

Fiscal year – The Plan's fiscal year is the last Saturday in February. The fiscal year ended February 22, 2025 (fiscal 2025) contained fifty-two weeks, and the fiscal year ended February 25, 2024 (fiscal 2024) contained fifty-two weeks.

Eligibility – Employees of the Company are generally eligible to participate in the Plan after one year of service and attaining age 18. Participants who are not employed on the last day of the calendar year are not eligible for an allocation of Company contributions for such year.

Notes to Financial Statements

Contributions – Prior to repaying the ESOP Transaction loan, the Company was obligated to make contributions in cash to the Plan which, when aggregated with the Plan's earnings or losses, equal or exceed the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its loan. Subsequent to repayment of the ESOP Transaction loan management decided to continue supporting the Plan by recycling redeemed shares and making annual contributions. The amount of these contributions will be determined at the discretion of management based on the Company's financial performance and other relevant factors.

Participant accounts – The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with contributed shares of BMAC's common stock and forfeitures of terminated participant's nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the calendar year or terminated employment during the year due to normal age retirement, disability, or death, will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the number of shares of BMAC common stock allocated to their accounts.

Vesting – If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants are 100% vested after five years of service. No participant other than those who terminate employment due to retirement, disability or death will become vested prior to the completion of five years of service.

Payment of benefits – Distributions from the Plan will be made when a participant retires, dies, or otherwise terminates employment with the Company and its participating subsidiaries. Distributions are made in the form of BMAC common stock with an automatic put option to the Company.

Forfeitures – If a Plan participant resigns or is terminated from employment with the Company or related subsidiary before completing five years of vesting service, the non-vested portion of the participant's account shall be forfeited and credited to a forfeiture account on the first anniversary of the participant's termination date. If the former participant returns to employment with the Company before incurring five consecutive years of absence, the former participant's balance will be restored from current year forfeitures. Forfeitures in the current year remaining after reinstating former employees are allocated to Plan participants on a pro rata basis. There were 39,757 shares forfeited and reallocated during the fiscal year ended February 22, 2025.

Diversification – Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in BMAC stock into investments with differing risk attributes. Participants who are at least age 50 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a ten-year period. In each of the first five years, a participant may diversify up to 25% of the balance in their account less all amounts previously diversified. In the following five years, the percentage increases to 50%.

Administrative expenses – As provided in the Plan Agreement, administrative expenses may be paid by either the Plan or the Company. The Company has historically paid the operating expenses of the Plan.

Voting rights – All shares of BMAC common stock held by the Plan are generally voted by the Trustee. Participants and/or beneficiaries are entitled to vote any employer securities allocated to their accounts with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of a trade or business, or other similar transactions.

Plan termination – Although the Company has expressed no intent to do so, the Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon such termination or partial termination of the Plan, the entire interest of each of the affected participants shall become 100% vested. Upon termination of the Plan, the Plan Administrative Committee should direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed in the Plan terms and the Code.

Put option – Under federal income tax regulations, the BMAC common stock that is held by the Plan and its participants is not readily tradable on an established market or is subject to trading limitations and includes a put option. The put option requires participants receiving distributions upon termination, retirement, death or disability, to resell shares either to the Plan or the Company at the then estimated fair value, which is estimated annually at year-end by a third-party appraiser.

Transfer of assets – Participants electing diversification or distributions can transfer a portion of their account into the DCRP. There were account balances totaling \$2,586,776 transferred into the DCRP during the year ended February 22, 2025.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Income recognition – The net depreciation in fair value of BMAC common stock consists of both the realized gains or losses and unrealized appreciation and depreciation of BMAC stock.

Payments of benefits – Benefits are recorded when paid.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through December 12, 2025, which is the date the financial statements were available to be issued.

Note 3 – Tax Status

The prior plan document received a favorable determination letter from the Internal Revenue Service (IRS) dated January 27, 2015, stating the Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan’s tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of February 22, 2025 and February 24, 2024.

BMAC common stock – The fair value is based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior fiscal years as illustrated in the following table. The appraiser took into account historical and projected cash flow, return on equity, and market comparability. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Loan Payable

In February 2004, the Plan entered into an \$82 million loan agreement with the Company related to the ESOP Transaction. The proceeds of the loan were used to purchase \$82 million of BMAC's common stock. This is a related party and party-in-interest transaction. The unallocated shares were collateral for the loan. The ESOP loan agreement provided for the loan to be repaid over 20 years. The final principal installment of \$6,217,903 was paid in the fiscal year ended February 24, 2024.

Note 7 – Risks and Uncertainties

The Plan investments consist of BMAC common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that the changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 8 – Related Party and Party-in-Interest Transactions

The Plan invests in BMAC common stock and had indebtedness guaranteed by the Company. These are related party and party-in-interest transactions. As described in Note 2, the Company pays substantially all plan administrative expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.
