To Whom It May Concern,

We are writing to request abatement of penalties associated with the late filing of our Form 5500 for the 2024 plan year.

The late filing occurred due to an administrative oversight during a period of internal transition. We were under the mistaken impression that additional enrolment updates needed to be completed before the Form 5500 could be finalized and submitted. This misunderstanding led to the filing deadline passing unintentionally. Once the issue was identified, we took immediate steps to correct it and prepare the necessary documentation. This delay was not the result of willful neglect. Our organization has a strong record of timely filings, and this situation was an isolated error. We have reviewed our internal procedures and implemented additional checks to ensure all future reporting deadlines are tracked and met without interruption.

We respectfully request penalty abatement on the grounds of reasonable cause. Our intention has always been to remain fully compliant with the Department of Labor and IRS requirements, and we have taken the appropriate steps to prevent any recurrence.
