### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of the BAMSI 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## ***Notes to Financial Statements***

### ***Note 1 - Description of Plan***

The following description of the BAMSI 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a 403(b) retirement plan established on July 1, 2017 and restated in its entirety effective January 1, 2023 by Brockton Area Multi-Services, Inc. (the “Employer”). The Plan covers all eligible employees, as defined. The Plan is comprised of retirement savings assets held by Voya Retirement Insurance and Annuity Company (“Voya”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant directed.

#### ***Participant Contributions***

Participants may elect to defer a portion of their annual compensation to the Plan, subject to dollar limits set by Federal law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Participant Rollovers”).

#### ***Employer Contributions***

In order to participate in Employer contributions, a participant must have attained age 21 and have completed 500 hours of service in a 6 month period. Due to administrative errors, the Employer made a QNEC contribution of \$8,184 from a gross contribution of \$20,911 offset by \$12,727 of forfeitures applied during the Plan year ended December 31, 2024.

#### ***Discretionary Matching Contributions***

The Employer, at its discretion, may make a matching contribution to the Plan, subject to certain limitations. To be eligible for the matching contribution, a participant must be an eligible employee who is actively participating in the Plan on the last day of the Plan year. Highly compensated employees and executive management are not eligible to receive Employer contributions. The Employer matching contribution is based on years of service. For the year ended December 31, 2024, the Employer did not elect to make a discretionary matching contribution.

#### ***Discretionary Contributions***

The Employer, at its discretion, may contribute a discretionary contribution. Allocations are based on the ratio of a participant’s compensation to total compensation of all eligible participants. For the year ended December 31, 2024, the Employer did not make a discretionary contribution.

## ***Notes to Financial Statements***

### ***Note 1 - Description of Plan (Continued)***

#### ***Participant Accounts***

Each participant's account is credited with the Participant's contribution and allocations of the Employer's contributions and Plan earnings and reduced by direct loan fees and benefit disbursement processing fees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### ***Vesting***

Participants are immediately vested in their voluntary deferral contributions, including rollovers, and the earnings thereon. Participants start vesting in Employer contributions based on years of service and become fully vested after five years of vested service or upon death, disability or by reaching normal retirement age, as defined by the Plan.

#### ***Payment of Benefits***

In-service withdrawals are permitted from all vested accounts upon the attainment of age 59½. In-service withdrawals are also permitted from a participant's elective deferral accounts due to financial hardship. Participants are entitled to their total vested account balance upon death, disability, retirement or termination of employment. Upon termination of service, a participant will receive a lump-sum amount equal to the value of his or her account. If the account balance is less than \$1,000, after notification, the entire amount will be paid in a lump sum as soon as possible. If the account balance is \$1,000 or greater, but not more than \$5,000, the Plan administrator, without consent, may distribute his or her entire non-forfeited account balance to an IRA rollover account for the benefit of the former participant.

#### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance, reduced by the highest outstanding loan balance in the prior twelve-month period. Participants may not have more than one loan outstanding at any one time. Loan terms range up to five years (up to ten years for the purchase of a primary residence). The loans are secured by the vested balance in the participant's account and bear interest at a reasonable rate of interest determined by the Plan administrator. Principal and interest are paid ratably to VOYA directly from participants.

## ***Notes to Financial Statements***

### ***Note 1 - Description of Plan (Continued)***

#### ***Forfeitures***

Upon termination of service, any non-vested portion of the account will be forfeited as of the date on which the participant has five consecutive one-year breaks in service. Any forfeited amounts will be restored to a participant's account if re-employed by the Employer before incurring five consecutive one-year breaks in service or after the participant received a distribution of the vested account. Such forfeitures are used to pay the Plan's administrative expenses, if any, and reduce future Employer contributions. Forfeitures that have not been used to pay administrative expenses or used to reduce Employer contributions shall be allocated to participants as of the last day of the Plan year in accordance with the Plan document. As of December 31, 2024 and 2023, there was \$12,368 and \$12,354 in unused forfeited balances, respectively. For the year ended December 31, 2024, \$12,727 was used to fund a portion of the QNEC contributions.

#### ***Plan Administration***

The Employer is the Plan administrator and has the authority to appoint a person(s) or entities to carry out the operation of the Plan. Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs such expenses to be paid by the Plan or the participants.

### ***Note 2 - Summary of Significant Accounting Policies***

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting which is in conformity with accounting principles generally accepted in the United States of America.

#### ***Investments, Investment Valuation and Income Recognition***

Investments other than fully benefit-responsive investment contracts (valued at contract value) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Contributions***

Contributions from Plan participants and the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Benefits Paid***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used

#### ***Subsequent Events***

The Employer has evaluated subsequent events through December 12, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure in the evaluation.

### ***Note 3 - Information Certified by the Insurance Company***

Plan investments are held by the Plan's insurance Company, Voya. The fair and contract values of investments as of December 31, 2024 and 2023 and all investment transactions for the year ended December 31, 2024, including interest and dividends, and net appreciation in fair values, are reported to the Plan and certified as complete and accurate by Voya. Notes receivable from Participants and information included in Schedule H, Line 4i - Schedule of Assets (Held at End of Year) have also been derived from information certified by Voya.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

*Level I* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level II* – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

*Level III* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

### Note 5 - Fully Benefit-Responsive Investment Contract

Following is a description of the investments and valuation methodologies for the fully benefit-responsive investment contract:

#### **Fixed Account**

The Plan has a fully benefit-responsive group annuity contract with Voya. Voya maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. A crediting interest rate is established for amounts invested in the fixed account. The crediting interest rate for December 31, 2024 and 2023 was 1.50% and 1.00%, respectively. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawal and fees. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

### ***Note 5 - Fully Benefit-Responsive Investment Contract (Continued)***

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The contract values of the Plan's fully benefit-responsive fixed account contracts at December 31, 2024 and 2023 were \$49,014 and \$3,103, respectively.

### ***Note 6 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participant account balances become fully vested and any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### ***Note 7 - Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Note 8 - Related-Party Transactions and Party-in-Interest Transactions***

Certain Plan investments including shares of mutual funds and the guaranteed interest account are managed by VOYA, the Insurance Company for the Plan, therefore, these transactions qualify as party-in-interest. For the year ended December 31, 2024, fees paid to Voya and other service providers amounted to \$62,216. In addition, notes receivable from participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

### ***Note 9 - Tax Status***

The Plan adopted The Angel Pension Group, Inc. volume submitter 403(b) plan and that prototype plan has received an advisory letter from the Internal Revenue Service ("IRS") dated March 31, 2017 stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code ("Code"), and therefore, the related trust is tax exempt. The Plan administrator and the Plan's tax counsel believe the Plan is currently being operated in compliance with the applicable provisions of the Code, and therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***Note 10 - Delinquent Participant Contributions***

Under U.S. Department of Labor Regulation Section 2510.3-102, 403(b) Plan related salary deferrals and loan repayments withheld from employees' paychecks must be deposited into the Plan as soon as reasonably possible. When this regulation is not satisfied, the Plan Sponsor has engaged in a prohibited transaction. During the year ended December 31, 2024, \$3,132 of participant contributions were not remitted to the Plan within the required time period and \$206 of participant contributions were not remitted to the Plan. During the year ended December 31, 2023, \$510,920 of participant contributions were not remitted to the Plan within the required time period. Additionally, for the year ended December 31, 2019, \$381 of participant contributions were not remitted to the Plan. The Employer has made corrections for the prohibited transactions and lost earnings from 2019 during the year ended December 31, 2024. The Employer is working to make corrections for the prohibited transactions, including lost earnings, from 2023 and 2024.
