### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Windstar Lines, Inc. 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 21, 2025 and December 31, 2024, and the related statements of changes in net assets available for benefits for the period from January 1, 2025 to February 21, 2025 and the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Basis for Opinion

### **Emphasis of Matter – Plan Merger**

As discussed in Note 1 to the financial statements, the management of Windstar Lines, Inc. and affiliates, the Plan Sponsor, approved a resolution on December 26, 2024 to merge the Plan into a pooled employer plan. All Plan assets were transferred to the pooled employer plan by February 21, 2025. Our opinion has not been modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Supplementary Information Required by ERISA**

The supplementary information as of and for the period from January 1, 2025 to February 21, 2025, and as of and for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Plan Description

---

The following brief description of the Windstar Lines, Inc. 401(K) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Windstar Lines, Inc. and affiliates (the Company).

In December 2024, the Company approved the Plan to be merged into a new plan called the Lutz Financial Pooled Employer Plan, effective February 21, 2025. The merger into the Lutz Financial Pooled Employer Plan initiated a "Black-Out" period that began February 7, 2025 and continued through March 7, 2025. During the black-out period, funds could not be applied to the employee selected funds or withdrawn from the Plan or the Lutz Financial Pooled Employer Plan. Plan assets of \$7,106,097 were transferred by February 21, 2025.

Employees were eligible to make pre-tax and designated after-tax Roth salary deferral contributions and receive Company safe harbor matching contributions after completing one year of service with at least 1,000 hours. Employees were eligible to receive discretionary contributions after completing one year of service with 1,000 hours and must be employed on the last day of the Plan year. Eligible employees become participants on the first day of the quarter following the date the entry requirements are satisfied.

Effective April 1, 2024, participants were eligible to participate in the Plan once they have completed one year of service, and they no longer were required to have at least 1,000 hours.

#### ***Contributions***

Participants could make voluntary pre-tax and designated after-tax Roth salary deferral contributions up to 100% of their eligible annual compensation as defined by the Plan, up to the maximum dollar limits allowed by law. Participants could also contribute amounts representing distributions from other qualified plans. At any time, a participant could elect not to contribute. Participants who were eligible to make deferral contributions and who would have attained age 50 before the close of the calendar year were eligible to make catch-up contributions.

The Company made safe harbor matching contributions equal to 100% of the participant's elective deferrals that do not exceed 3% of eligible compensation plus 50% of the participant's elective deferrals that exceed 3% of eligible compensation up to 5% of eligible compensation. The Company could also elect to make discretionary contributions. No discretionary contributions were made in for the period from January 1, 2025 to February 21, 2025 and the year ended December 31, 2024. Contributions are subject to certain limitations.

### ***Participant Accounts***

Each participant's account was credited with the participant's contribution and allocations of a) the Company's safe harbor matching contributions, b) the Company's discretionary contributions and c) Plan earnings or losses. The Company's safe harbor matching contribution was allocated among participants based upon each participant's elected salary deferral. The Company's discretionary contribution was allocated among participants based upon eligible compensation of participants. Plan earnings or losses were allocated on the basis of actual results of the investments held in participant accounts. Participant-directed investments were maintained in individual member accounts managed by Principal Life Insurance Company (Principal).

### ***Vesting***

Participants were immediately vested in their contributions and Company safe harbor matching contributions plus actual earnings thereon. The Company's discretionary contributions credited to participants' accounts were vested based on years of service. A participant was 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary could elect to receive a lump-sum, partial payments, or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan automatically distributed those benefits that were under \$1,000 in a single lump-sum. The Plan required that distributions between \$1,000 and \$7,000 be directly rolled over to an individual retirement plan designated by the plan administrator in the event the participant does not elect a payout option. The Plan also allowed for in-service and hardship distributions, as defined by the Plan document. Benefits were recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before vesting 100%, the portion of their discretionary contributions not then vested were forfeited. The forfeited portion of any participant's account would be used to either reduce Company contributions or Plan expenses. As of February 21, 2025 and December 31, 2024, there were no forfeited non-vested accounts available or used to reduce Company contributions or Plan expenses.

## **2. Summary of Significant Accounting Policies**

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting - Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments were reported at fair value. Fair value was the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Expenses***

Administrative expenses and audit fees involved in maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Other certain expenses specifically incurred by or attributable to individual participants were paid from the applicable participant's account and included in administrative expenses. Investment-related expenses were included in net appreciation in fair value of investments.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through December 9, 2025, noting no items requiring disclosure.

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplementary information.

### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024. There were no Plan investments as of February 21, 2025.

*Common Collective Trusts:* Common Collective Trusts (CCT's) are valued at the Net Asset Value (NAV) based on the fair value of its underlying investments. These trusts invest in collective trust funds as well as a variety of pooled separate accounts and mutual funds. The fair value of mutual funds are publicly quoted pricing inputs (level 1). The NAV of the CCT is not publicly quoted but is available to current investors via the Company's website or when Plan participants access their account values. The NAV is the basis for current transactions and the CCT can be redeemed at the NAV as of the measurement date. Therefore, the Company believes that this investment has a "Readily Determinable Fair Value." The NAV is calculated in a manner consistent with GAAP for investment companies. Because it is valued similarly to mutual funds, the Company believes this CCT should be a level 1 asset to allow for consistent disclosure. Unfunded commitments typically are found in private equity funds and therefore are not applicable to CCT's.

*Pooled Separate Accounts:* Pooled separate accounts (PSA's) invest mainly in stocks, single mutual funds, fixed securities and real estate. The majority of the underlying securities have observable level 1 or level 2 quoted pricing inputs. The NAV of the pooled separate accounts are not publicly quoted but is available to current investors via the Company website or when plan participants access their account values. The NAV is the basis for current transactions, and the PSA can be redeemed at NAV as of the measurement date. Therefore, the Company believes that these investments have a "Readily Determinable Fair Value". The NAV is calculated in a manner consistent with GAAP for investment companies. Most of the security prices were obtained from a pricing service, Interactive Data Corporation (IDC). Because it is valued similarly to mutual funds, the Company believes its PSA's should be level 1 assets to allow for consistent disclosure. PSAs typically can be redeemed on a daily basis. Unfunded commitments typically are found in private equity funds and therefore are not applicable to PSAs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan was qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Related Party Transactions

---

Certain assets of the Plan were held and managed by Principal, the custodian of the Plan, therefore, these transactions qualified as party-in interest.
