As further discussed in Note 1b to the financial statements, the Plan terminated its participation in the ForUs 401(k) effective January 1, 2024, and the Plan's net assets were spun off into Security Benefit Associates Profit Sharing and Savings Plan July 5, 2024. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

### 1. Plan Description

The following description of ForUs 401(k) - PolicyGenius Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The ForUs 401(k) is a defined contribution, multiple employer plan, originally effective November 1, 2014, and restated January 1, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 15, 2016, PolicyGenius Inc. (the Company) entered into a joinder agreement with ForUs Inc. (the Sponsoring Employer) and became an adopting sponsor of the Plan. These financial statements and all mentions of "the Plan" herein pertain to the portion of the ForUs 401(k) that exists for the benefit of the Company's employees.

The Plan covers all employees of the Company who have attained the age of 18 and completed three months of service, excluding certain classes of employees as set forth in the plan document.

#### b. Plan Spin-off

On January 1, 2024, the Company's Board of Directors adopted a resolution to terminate the Company's participation in the ForUs 401(k) and spin-out the plan to Security Benefit Associates Profit Sharing and Savings Plan. Contributions to the Plan were suspended and subsequent contributions for the Plan's participants were made to Security Benefit Associates Profit Sharing and Savings Plan. On July 5, 2024, the net assets of the Plan of \$19,263,806 were spun-off to Security Benefit Associates Profit Sharing and Savings Plan.

#### c. Contributions

Participants may elect to defer up to 92 percent of annual compensation in pre-tax or Roth deferrals, as defined in the plan document and allowed by law. Participants may also roll over amounts representing distributions from other qualified plans. The Plan permits catch-up contributions for participants who have attained age 50 by the end of the plan year. The Plan provides for automatic election of participant deferrals at a rate of 6 percent of compensation for all new participants, with automatic annual increases of 1 percent up to a maximum of 15 percent. Participants may affirmatively elect a different deferral percentage or elect not to defer into the Plan. Company contributions are discretionary.

As a result of the plan spin-off described in Note 1b, there were no employee or company contributions for 2024.

d. Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, if applicable, and the Plan's earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

e. Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the company contribution portion of their accounts plus actual earnings thereon is based on years of credited service as follows:

<b>Credited Service</b>	<b>Percent Vested</b>
Less than 1 year	0%
1 year but less than 2 years	33%
2 years but less than 3 years	66%
3 or more years	100%

f. Distribution of Benefits

Upon termination of employment due to termination of service, death, disability, or retirement, participants may elect to receive the value of their vested account balance in a lump-sum distribution. In-service withdrawal options are available to participants under certain circumstances.

g. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 (reduced by the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan) or 50 percent of their vested account balance. Loan terms range up to five years. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. As a result of the plan spin-off, all outstanding loans were transferred to Security Benefit Associates Profit Sharing and Savings Plan as of July 5, 2024.

h. Forfeitures

Forfeitures are used to pay plan expenses and reduce company contributions. At July 5, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$14,302, respectively. During 2024, \$20,848 forfeitures were used to pay plan expenses. As a result of the plan spin-off, forfeitures were transferred to Security Benefit Associates Profit Sharing and Savings Plan as of July 5, 2024.

### 2. Summary of Significant Accounting Policies

#### a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are generally recorded on a trade-date basis. As permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962-325, *Plan Accounting—Defined Contribution Plans: Investments—Other*, settlement-date basis may be used when (a) the settlement date is after the financial statement date, (b) the fair value of the securities purchased or sold did not change significantly from the trade date to the financial statement date, and (c) the purchases or sales do not significantly affect the composition of the plan's net assets available for benefits.

Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### d. Payment of Benefits

Benefits are recorded when paid.

#### e. Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses include fees for certain participant-initiated transactions that are charged directly to the account of the participant who incurred them. Investment-related expenses are included in net realized and unrealized appreciation in fair value of investments.

f. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. These are referred to as participant loans in the Form 5500 and related supplemental schedules. Delinquent loans are treated as distributions based upon the terms of the plan document.

g. Subsequent Events

The Plan has evaluated the subsequent events through December 4, 2025, the date the financial statements were available to be issued.

3. Non-Exempt Transactions

Certain of the participant contributions were not remitted within the maximum period of time permitted by the Department of Labor's Rules and Regulations and, therefore, constitute the lending of monies from the Plan to the Company. These non-exempt transactions are detailed in the attached supplemental schedule, Schedule H, line 4a— Schedule of Delinquent Participant Contributions for the Period from January 1 to July 5, 2024.

During 2024, the plan sponsor corrected the non-exempt transactions by allocating lost earnings to affected participants.

4. Fair Value Measurement

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023. As a result of the plan spin-off described in Note 1b, there were no assets held by the Plan as of July 5, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Exempt Status

The Company has adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, and the plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of July 5, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Certified Investment Information

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American Trust Company, the Trustee of the Plan, has certified that the following investment information is complete and accurate:

### 1. Plan Description

The following description of ForUs 401(k) - PolicyGenius Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The ForUs 401(k) is a defined contribution, multiple employer plan, originally effective November 1, 2014, and restated January 1, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 15, 2016, PolicyGenius Inc. (the Company) entered into a joinder agreement with ForUs Inc. (the Sponsoring Employer) and became an adopting sponsor of the Plan. These financial statements and all mentions of "the Plan" herein pertain to the portion of the ForUs 401(k) that exists for the benefit of the Company's employees.

The Plan covers all employees of the Company who have attained the age of 18 and completed three months of service, excluding certain classes of employees as set forth in the plan document.

#### b. Plan Spin-off

On January 1, 2024, the Company's Board of Directors adopted a resolution to terminate the Company's participation in the ForUs 401(k) and spin-out the plan to Security Benefit Associates Profit Sharing and Savings Plan. Contributions to the Plan were suspended and subsequent contributions for the Plan's participants were made to Security Benefit Associates Profit Sharing and Savings Plan. On July 5, 2024, the net assets of the Plan of \$19,263,806 were spun-off to Security Benefit Associates Profit Sharing and Savings Plan.

#### c. Contributions

Participants may elect to defer up to 92 percent of annual compensation in pre-tax or Roth deferrals, as defined in the plan document and allowed by law. Participants may also roll over amounts representing distributions from other qualified plans. The Plan permits catch-up contributions for participants who have attained age 50 by the end of the plan year. The Plan provides for automatic election of participant deferrals at a rate of 6 percent of compensation for all new participants, with automatic annual increases of 1 percent up to a maximum of 15 percent. Participants may affirmatively elect a different deferral percentage or elect not to defer into the Plan. Company contributions are discretionary.

As a result of the plan spin-off described in Note 1b, there were no employee or company contributions for 2024.

d. Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, if applicable, and the Plan's earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

e. Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the company contribution portion of their accounts plus actual earnings thereon is based on years of credited service as follows:

<b>Credited Service</b>	<b>Percent Vested</b>
Less than 1 year	0%
1 year but less than 2 years	33%
2 years but less than 3 years	66%
3 or more years	100%

f. Distribution of Benefits

Upon termination of employment due to termination of service, death, disability, or retirement, participants may elect to receive the value of their vested account balance in a lump-sum distribution. In-service withdrawal options are available to participants under certain circumstances.

g. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 (reduced by the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan) or 50 percent of their vested account balance. Loan terms range up to five years. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. As a result of the plan spin-off, all outstanding loans were transferred to Security Benefit Associates Profit Sharing and Savings Plan as of July 5, 2024.

h. Forfeitures

Forfeitures are used to pay plan expenses and reduce company contributions. At July 5, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$14,302, respectively. During 2024, \$20,848 forfeitures were used to pay plan expenses. As a result of the plan spin-off, forfeitures were transferred to Security Benefit Associates Profit Sharing and Savings Plan as of July 5, 2024.

### 2. Summary of Significant Accounting Policies

#### a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are generally recorded on a trade-date basis. As permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962-325, *Plan Accounting—Defined Contribution Plans: Investments—Other*, settlement-date basis may be used when (a) the settlement date is after the financial statement date, (b) the fair value of the securities purchased or sold did not change significantly from the trade date to the financial statement date, and (c) the purchases or sales do not significantly affect the composition of the plan's net assets available for benefits.

Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### d. Payment of Benefits

Benefits are recorded when paid.

#### e. Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses include fees for certain participant-initiated transactions that are charged directly to the account of the participant who incurred them. Investment-related expenses are included in net realized and unrealized appreciation in fair value of investments.

### f. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. These are referred to as participant loans in the Form 5500 and related supplemental schedules. Delinquent loans are treated as distributions based upon the terms of the plan document.

### g. Subsequent Events

The Plan has evaluated the subsequent events through December 4, 2025, the date the financial statements were available to be issued.

## 3. Non-Exempt Transactions

Certain of the participant contributions were not remitted within the maximum period of time permitted by the Department of Labor's Rules and Regulations and, therefore, constitute the lending of monies from the Plan to the Company. These non-exempt transactions are detailed in the attached supplemental schedule, Schedule H, line 4a—Schedule of Delinquent Participant Contributions for the Period from January 1 to July 5, 2024.

During 2024, the plan sponsor corrected the non-exempt transactions by allocating lost earnings to affected participants.

## 4. Fair Value Measurement

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023. As a result of the plan spin-off described in Note 1b, there were no assets held by the Plan as of July 5, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Exempt Status

The Company has adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, and the plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of July 5, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Certified Investment Information

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American Trust Company, the Trustee of the Plan, has certified that the following investment information is complete and accurate:

- Fair value of investments and the carrying amount of notes receivable from participants as reflected in the Statements of Net Assets Available for Benefits as of July 5, 2024 and December 31, 2023.
- Investment income and interest income on notes receivable from participants as reflected in the Statement of Changes in Net Assets Available for Benefits for the Period from January 1 to July 5, 2024.
- Investment information as reflected in Note 4 to these financial statements.

As permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to the certified investment information.
