## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The New York Gracie Square Hospital 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes to Financial Statements

December 31, 2024 and 2023

### **1. Description of Plan**

The following description of The New York Gracie Square Hospital 403(b) Plan (the Plan) provides general information about the Plan's provisions. The New York Gracie Square Hospital, Inc. (the Hospital), is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor. The inception date of the Plan was July 15, 2021.

#### **General**

The Plan is a defined contribution plan covering eligible employees of the Hospital upon hire. Eligible participants are automatically enrolled at 6% of eligible compensation unless changed by the participant. Certain employees are excluded from the automatic enrollment provision. Annually on October 15, the deferral percentage will automatically increase by 1% up to a maximum of 15% of compensation, excluding participants automatically enrolled within that year.

The Hospital is responsible for the general administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Participant Contributions**

Each year, participants may contribute up to 75% of pretax annual compensation, as defined by the Plan. Participants may also make Roth 403(b) deferrals and Roth rollover contributions and contribute amounts representing distributions from other qualified plans. All contributions are subject to certain limitations by the Internal Revenue Code (the Code). Participants are immediately vested in their contributions plus actual earnings thereon. Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and participant's investment income (loss) and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of the participant's respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

## Notes to Financial Statements (continued)

### **1. Description of Plan (continued)**

#### **Participant Loans**

Active participants in the Plan may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may be up to 5 years, or up to 10 years for the purchase of a primary residence. The \$50,000 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. Regardless of the number of loans outstanding to a participant, no more than 1 loan shall be made to the participant in any 12-month period. The loans bear interest at a rate equal to the prime rate at the time of issuance. The loans are secured by the balance in the participant's account. If a participant terminates employment with the Hospital or other participating employers, the participant may continue to make loan payments through a preauthorized agreement. If a loan is in default, the plan administrator will offset the loan to the vested account balance by the outstanding balance of the loan to the extent permitted by law. Pending final disposition of the note, the participant remains obligated for any unpaid principal or accrued interest.

#### **Payment of Benefits**

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan.

Normal retirement is upon attainment of 65 years of age. A participant may remain employed past the normal retirement date and continue to contribute to the Plan. Upon retirement and having attained the normal retirement age, a participant will be entitled to 100% of the participant's account balance, beginning at a reasonable time after retirement. Upon separation from service with the Hospital or other participating employers due to death, disability, or termination, a participant may elect to receive an annuity, installment payments, or a lump-sum payment.

#### **Administrative Expenses**

Custodial fees to the Plan's custodians, legal fees, and certain consulting fees are paid directly from the Plan's assets. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which expenses relate. Accounting fees and fees for other services rendered are paid by the plan sponsor; such expenses are excluded from the accompanying financial statements.

### 1. Description of Plan (continued)

#### Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right to amend or terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts will be distributed in accordance with the plan agreement.

### 2. Summary of Significant Accounting Policies

*Basis of Accounting:* The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

*Valuation of Investments:* The Plan's investments primarily consist of mutual funds and a guaranteed investment contract. All investments held by the Plan, except for the fully benefit-responsive investment contract, are stated at fair value. Fair values generally are determined based on closing quoted market prices in an active market as of December 31 of each year.

The Guaranteed Long-Term Account (GLTA) is a guaranteed investment contract. The Plan sponsor has determined that the GLTA is fully benefit-responsive and, therefore, is reported at contract value in the accompanying statements of net assets available for benefits. Contract value is the relevant measurement as contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus earnings, less participant withdrawals and administrative expenses.

*Investment Transactions:* All investment transactions are recorded on the dates such trades take place. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The realized gain or loss resulting from sales transactions is the difference between the proceeds received and the average historical cost of the assets sold. The change in the difference between the fair value and the cost of investments held, plus net realized gains or losses, is reflected in the statements of changes in net assets available for benefits as net realized and unrealized appreciation in fair value of investments.

*Contributions:* Employee contributions are recognized when earned. The employer contributions recorded on the statements of changes in net assets available for benefits represents certain self-corrections remitted to the plan during 2024 and 2023.

*Payment of Benefits:* Benefits are recorded when paid.

### 2. Summary of Significant Accounting Policies (continued)

*Administrative Expenses:* Custodial fees to the Plan trustee are paid directly from Plan assets. Legal and accounting fees and fees for other services rendered are paid by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements.

*Use of Estimates:* The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

*Participant notes receivable:* Participant notes represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred.

### 3. Investments

Certain information related to investments disclosed in the accompanying financial statements and the supplemental schedule at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Prudential Bank & Trust, FSB, Empower Trust Company, LLC, and Empower Annuity Insurance Company.

On April 1, 2022, Empower Annuity Insurance Company of America, formerly known as Great-West Life & Annuity Insurance Company, the parent company of Empower Retirement, LLC (Empower) acquired the full-service retirement business of Prudential Financial, Inc. (Prudential), including Prudential Retirement Insurance and Annuity Company (PRIAC) and Prudential Bank & Trust, FSB (PB&T). Empower became the recordkeeper of the Plan. Additionally, on October 3, 2022, PRIAC was renamed Empower Annuity Insurance Company (EAIC). Lastly, on March 31, 2023, PB&T was merged into Empower Trust Company, LLC (ETC).

Effective October 21, 2023, the Plan's recordkeeping and plan level reporting system with Prudential moved to Empower. Custody of the assets remains with EAIC for certain investments previously issued by Prudential. All other investments are held by Empower Trust Company, LLC.

ETC and EAIC are the current trustees and custodians of the Plan.

#### **4. Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The Plan uses a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1:* Quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities.

*Level 2:* Observable inputs that are based on inputs not quoted in active markets, but corroborated by market data.

*Level 3:* Unobservable inputs are used when little or no market data is available.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level input that is significant to the fair value measurement in its entirety.

All Plan investment assets reported at fair value, which consist of mutual funds, are classified as Level 1 at December 31, 2024 and 2023.

#### **5. Fully Benefit-Responsive Investment Contract**

As described in Note 2, the Plan invests in the GLTA, which is a fully benefit-responsive investment contract. The issuer maintains the contributions for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan as further described below.

The GLTA does not have a maturity date or penalties for early withdrawals. The contract issuer for the GLTA is contractually obligated to repay the principal and interest at specified interest rates that is guaranteed to the Plan. The crediting rate for the GLTA is based on a formula established by the contract issuer but may not be less than 1.0% or greater than 3.0%; the crediting rate is reviewed on an annual basis for resetting.

#### **5. Fully Benefit-Responsive Investment Contract (continued)**

The Plan's ability to receive amounts due in accordance with a fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet their financial obligations. The issuer's ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of a contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

In addition, certain events allow an issuer to terminate its contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The Plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with the contract issuer or participants is probable.

### **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **7. Commitments and Contingencies**

Effective January 1, 2009, the IRS issued final regulations for purposes of determining common control for qualified retirement plans sponsored by tax-exempt organizations. In general, tax-exempt entities that are under common control are treated as one entity for certain of the requirements of qualified plans. The regulations determine control based on facts and circumstances; for this purpose, common control would exist if, among other situations, at least 80% of the directors or trustees of one organization were either representatives of, or directly or indirectly controlled by, another organization. These regulations could have an effect on the operations of the Hospital and its related entities' retirement plans and the responsibilities of those entities for associated liabilities, such as the Hospital acting as the Plan sponsor, although such effects are uncertain at this time.

### **8. Tax Status**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated September 21, 2022 stating that the written form of the underlying pre-approved document is qualified under Section 403(b) of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under the Code, and, therefore, the related custodial accounts are tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **9. Related-Party and Party-in-Interest Transactions**

The Plan holds certain investments managed by a trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are reported as participant notes receivable in the accompanying statements of net assets available for benefits.

#### **10. Subsequent Events**

Management evaluated subsequent events for the Plan through December 12, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that require disclosure in, or adjustment to, the financial statements.
