Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Zuffa LLC 401(k) Profit Sharing Plan and Trust (“Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of February 28, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period January 1, 2025 through February 28, 2025 and the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

Zuffa LLC 401(k) Profit Sharing Plan and Trust

1 Description of Plan

The following description of Zuffa LLC 401(k) Profit Sharing Plan and Trust provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan, which began August 1, 2006, and most recently restated effective January 1, 2022, is a defined contribution plan covering all employees of Zuffa LLC (the "Company") who meet the hour and age requirements. Prior to August 16, 2016, Fertitta Entertainment, LLC and FE Transportation, LLC were participating employers of the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

As of March 1, 2025, all assets of the Zuffa LLC 401(k) Profit Sharing Plan and Trust were merged into a new plan under plan sponsor TKO Group Holdings, Inc.

Eligibility:

All employees, except union employees, employees who are residents of Puerto Rico and nonresident aliens, of the Company age twenty-one and older and who are employed for two months are eligible to participate in the Plan. The Participant must be employed for at least 91 consecutive calendar days (or 501 service hours) of the Plan Year to receive a profit-sharing contribution.

Contributions:

Employee Contributions - Participants may contribute up to 96% of their compensation to the Plan in increments of 1%. Catch-up contributions are allowed in accordance with Internal Revenue Service guidelines.

The Plan has an automatic enrollment feature which automatically enrolls participants after meeting eligibility requirements and who have not made an election, at 6% of eligible compensation, unless they elect to opt out or enroll at a different percentage. For participants who have been automatically enrolled, and participants who have elected a salary deferral of at least 1%, the deferral percentage will increase by 1% each Plan year up to 10%, unless elected otherwise. Automatic increases will occur on July 1 of each year.

Employer Contributions - The Company makes contributions to each eligible participant's account by matching 50% up to 5% of the Participant's elective deferral for the Plan year.

Employer Discretionary Contributions - The Company may also make additional contributions at its discretion. Such additional contributions, if any, shall be allocated to each Participant in proportion to his or her compensation for the calendar year. There were no Employer discretionary contributions for 2025 or 2024.

Employee and Employer contributions are determined and recorded at the time compensation is paid.

1 Description of Plan, Continued

Contributions, Continued:

Rollover contributions from other plans are also accepted, providing certain specified conditions are met. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code as defined in the Plan.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings and losses thereon.

Vesting:

All participants are 100% vested in elective deferrals, qualified non-elective contributions and rollover contributions made to the Plan.

Vesting in the employer match and employer profit sharing contributions is based on years of service. A participant is vested as follows:

Forfeitures:

Forfeitures due to termination from the Plan before a participant is 100% vested shall be used to offset administrative expenses and to reduce employer contributions. Forfeited non-vested accounts totaled \$0 and \$192,064 as of February 28, 2025 and December 31, 2024, respectively. There were \$0 (2025) and \$55,006 (2024) of forfeitures used to reduce employer match contributions and administrative expenses.

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of February 28, 2025 and December 31, 2024. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

1 Description of Plan, Continued

Notes Receivable from Participants, Continued:

The loans are secured by the balance in the participant's account and bear interest at the rate set by reference to the bank prime rate and shall be declared quarterly. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits:

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant may elect to receive a lump sum or partial installments in amount equal to the value of his or her account. The Plan also allows for in-service distributions if a participant reaches age 59 ½. Benefits are recorded when paid.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments (except for fully benefit responsive contracts, which are recorded at contract value) are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

2 Summary of Significant Accounting Policies, Continued

Administrative Fees:

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements.

Risks and Uncertainties:

The Plan's investments include investments in mutual funds, common collective trust and pooled separate accounts holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through December 11, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan. On September 16, 2022, the Internal Revenue Service issued an opinion letter stating the form of the pre-approved plan used by the Plan is acceptable under Section 401 of the IRC. The Plan has not received a determination letter specific to the Plan itself. However, the Plan Administrator believes that the Plan and underlying trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been recorded in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of February 28, 2025, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2025 and December 31, 2024.

Mutual Funds:

The fair value of the mutual funds is based on quoted market prices and are classified within Level 1 of the hierarchy.

Pooled Separate Accounts:

The fair value of the pooled separate accounts is based on the net fair value of the underlying assets. The value of each fund and of each unit of participation is determined at the valuation date. Investments are valued each day. Whenever possible, the funds use independent pricing services to value investments. These fall into the Level 2 category of the valuation hierarchy.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the account, the investment adviser reserves the right to temporarily delay from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The Fund invests in international investments with a growth strategy.

6 Party-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts and a guaranteed interest account managed by Empower Annuity Insurance Company, an affiliate of the Plan's Trustee and, therefore, these transactions qualify as party-in-interest. Usual and customary fees were paid by the funds for the investment management services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party in interest transactions.

7 Benefit-Responsive Contract

The Plan holds a benefit-responsive insurance contract with Empower. The contract meets the fully benefit responsive insurance contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

7 Benefit-Responsive Contract, Continued

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code, (2) the establishment of a defined contribution plan that competes with the plan for employee contributions, (3) any substantive modification of the Plan or the administration of the Plan that is not consented to by the wrap issuer, (4) complete or partial termination of the Plan, (5) any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on a portfolio's cash flow, (6) merger or consolidation of the Plan with another plan, the transfer of assets to another plan, or the sale, spin-off or merger of a subsidiary or division of the plan sponsor, (7) any communication given to participants by the Plan Sponsor or any other Plan fiduciary that is designed to induce or influence participants not to invest in a portfolio or to transfer assets out of a portfolio, (8) exclusion of a group of previously eligible employees from eligibility in the Plan, (9) any early retirement program, group termination, group layoff, facility closing, or similar program, and (10) any transfer of assets from a portfolio directly to a competing option. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants is probable.

The issuer may terminate the contract for cause at any time.
