INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the
PBA Employees and Fund Office Staff Pension Plan

Opinion

We have audited the financial statements of the PBA Employees and Fund Office Staff Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of February 18, 2025 and June 30, 2024, the related statement of changes in net assets available for benefits for the final period ended February 18, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of February 18, 2025 and June 30, 2024, and the changes in net assets available for benefits for the final period ended February 18, 2025, in accordance with accounting principles generally accepted in the United States of America.

Emphasis of Matter

As discussed in Note A to the financial statements, the Plan merged into the PBA Employees and Fund Office Staff Pension Retirement Plan. On February 18, 2025, all assets and liabilities of the Plan were transferred to the successor plan. As a result, the Plan ceased operations. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A - DESCRIPTION OF PLAN

The following description of the PBA Employees and Fund Office Staff Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

[1] General:

The Plan was a money purchase pension plan covering all eligible employees of the Police Benevolent Association of the City of New York, Inc. ("PBA"), PBA Health and Welfare Fund, PBA Retiree Health and Welfare Fund, PBA Annuity Fund, and PBA Legal Services Fund (collectively, the "Employer"), who have completed six months of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan sponsor was the Board of Trustees of the Plan, Principal Trust Company was the Plan's custodian and Principal Life Insurance Company was the Plan's recordkeeper.

The Plan adopted a resolution on December 16, 2024 to freeze the contributions to the Plan effective January 1, 2025. A new successor Plan, the PBA Employees and Fund Office Staff Pension Retirement Plan (the "Retirement Plan") was approved and established effective January 1, 2025. The Plan adopted a resolution to merge its assets and liabilities into the Retirement Plan effective as of February 14, 2025. The transfer of assets and liabilities from the Plan to the Retirement Plan was completed on February 18, 2025 and are shown as transfers out on the statement of changes in net assets available for benefits for the final period ended February 18, 2025.

[2] Contributions:

The Employer contributed to the Plan an amount equal to 9% of compensation, as defined by the Plan, on behalf of each eligible employee, through December 31, 2024. Participants directed the investment of employer contributions.

[3] Participant accounts:

Each participant's account included: (i) the Employer's contributions; (ii) Plan earnings; and (iii) could be charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

[4] Vesting and forfeitures:

Participants were vested in their account upon the completion of three years of service. Upon attaining normal retirement age, death, or disability of a participant, all amounts in the participant's account became fully vested. Forfeited nonvested accounts could be used to reduce employer contributions. During the period ended February 18, 2025, forfeitures of approximately \$0 were used to reduce employer contributions. There were no forfeited nonvested accounts available at February 18, 2025 and June 30, 2024.

[5] Payment of benefits:

On termination of service due to retirement, disability, or death, a participant (or a beneficiary) could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or an annuity, as defined in the Plan document.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

[6] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants could borrow from their fund account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. Loan terms ranged from one to five years; however, terms could exceed five years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at the prime rate as of the first day of the month for which the applicable loan was made, as defined in the Plan Document. Interest rates on outstanding loan balances ranged from 4.25% to 9.25% at June 30, 2024. Principal and interest were paid ratably through payroll deductions. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document. Related fees were recorded as administrative expenses and were expensed when incurred.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

[2] Subsequent events:

The Plan has evaluated subsequent events through December 15, 2025, the date the financial statements were available to be issued.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements. Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

[4] Payment of benefits:

Benefits were recorded when paid.

[5] Plan expenses:

Substantially all expenses, with the exception of fees related to notes receivable from participants and asset based fees, incurred in connection with the administration of the Plan were paid by the Employer. Expenses that were paid by the Employer are excluded from these financial statements.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENTS AND FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of February 18, 2025 and June 30, 2024.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment funds – Valued at NAV which is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective investment funds, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Stable Return Fund was composed of security backed contracts. Participant transactions (purchases and sales) could occur daily, yet if the Plan initiated a full redemption of the collective investment fund, the issuer reserved the right to require 12 months' notification in order to ensure that securities liquidations would be carried out in an orderly business manner. In addition, within 90 days of a withdrawal, monies could not be transferred out of a collective investment fund into a competing collective investment fund. In August 2023, the Plan administrator provided the required 12 month notice to remove the Stable Return Fund as an investment option. Effective November 1, 2024, no new contributions or transfers were allowed into the Stable Return Fund and existing account balances and future investment allocations were mapped into the Principal Fixed Income Guaranteed Option (see Note D).

Pooled separate account – Valued at NAV, as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly-quoted price in an active market. Effective November 1, 2024, no new contributions were allowed into the pooled separate account and existing account balances and future investment options were mapped into Principal Core Fixed Income R6 Fund, a mutual fund.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE D - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

Effective November 1, 2024, the Plan entered into a benefit-responsive guaranteed investment contract that has been issued by Principal Life Insurance Company to Principal Trust Company as custodian. Principal Life Insurance Company maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed minimum interest rate effective on or after December 30, 2022 will not be less than 0.15% or greater than 3%. The crediting rate is based on a formula established by the contract issuer but may not be less than 0.15 percent. The net crediting rate from June 1, 2024 to November 30, 2024 was 5.05%. The net crediting rate from December 1, 2024 to May 31, 2025 was 4.75%. The crediting rate is reviewed on a semiannual basis for resetting.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, participant transfers, either directly or indirectly, to competing Plan investment options will be subject to a 90-day equity wash. Were the Plan to initiate a withdrawal or transfer, either a 12-month advance notice or a 5% surrender charge will apply, whichever the Plan administrator chooses. The Principal Fixed Income Guaranteed Option may make higher crediting rates available. If these are available and the Plan administrator chooses to move the Plan's interest to a higher crediting rate, a charge of 1.50% of the Plan's interest applies.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or
4. A material amendment to the agreements without the consent of the issuer.

NOTE E - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances that were transferred to the Retirement Plan.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments were shares of mutual funds and units of common collective trusts managed by Principal Trust Company. Principal Trust Company was the Plan's custodian and Principal Life Insurance Company was the Plan's recordkeeper; therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan were \$10,218 for the final period ended February 18, 2025.

NOTE G - TAX STATUS

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated November 29, 2016, stating that the Plan is qualified under the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. The Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 18, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE H - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.
