Notes to the Financial Statements

July 17, 2025

1. PLAN TERMINATION

On March 5, 2025, Plan management approved the merger of the Plan into the Securus 401(k) Plan. All investments and notes receivable from participants were transferred from the Plan to the Securus 401(k) Plan effective June 10, 2025 and July 17, 2025, respectively. Following the transfer of assets, the Plan ceased operations and no longer holds any assets as of July 17, 2025.

2. DESCRIPTION OF THE PLAN

The following description of the Bottleless Water Solutions d/b/a Bottleless Nation 401(k) Plan (the Plan) provides only general information. Reference should be made to the Plan document for a more complete description of the Plan's provisions.

General

The plan, effective January 1, 2019, and most recently amended and restated effective July 16, 2024, is a defined contribution plan covering substantially all employees of Bottleless Water Holdings LLC d/b/a Bottleless Nation (referred to as "the Company") who are at least 21 years old and have completed two months of employment. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may make voluntary contributions up to the IRS limits of pre-tax annual compensation as defined by the Plan. After satisfying eligibility requirements, Plan participants are automatically enrolled in the Plan at a pre-tax contribution rate of 4% of their compensation, unless they elect not to participate in the Plan or select an alternative contribution rate.

The Company has elected to make a safe harbor matching contribution equal to 100% of participant contributions for the first 3% of a participant's eligible compensation and then 50% of participant contributions for the next 2% of the participant's eligible compensation during the period ended July 17, 2025.

In addition to the safe harbor matching contribution, the Company may make contributions in two manners. First, a discretionary employer matching contribution equal to a uniform percentage of matched employee contributions. Second, the Company may make a discretionary non-elective contribution allocated to all eligible participants. Both contributions are determined by the Company on an annual basis. Employees must complete at least one year of service, defined as at least 1,000 hours, during the Plan year in order to be eligible to receive both contributions. Employees must also be employed on the last day of the Plan year to be eligible to receive the discretionary non-elective contribution. The Company elected not to make employer matching or non-elective contributions during the period ended July 17, 2025.

Participants' Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, the Company's special discretionary contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

2. DESCRIPTION OF THE PLAN, CONTINUED

Notes Receivable from Participants

Participants may borrow from their accounts. Loans are made on a uniform and non-discriminatory basis. A participant may borrow up to 50% of his or her vested account balance at a minimum of \$1,000 up to a maximum of \$50,000 bearing interest at the prime rate plus 1%. Payments of principal and interest are made through payroll deductions. Loans are secured by the balance in the participant's account.

Vesting

Participants are immediately 100% vested in their voluntary and safe harbor matching contributions, plus actual earnings thereon. Vesting in the discretionary employer matching and non-elective contributions, plus earnings thereon occurs on a graded scale as shown below:

<u>Years of Service</u>	<u>Vested %</u>
Less than 2 years	0%
At least 2 years, but less than 3 years	20%
At least 3 years, but less than 4 years	40%
At least 4 years, but less than 5 years	60%
At least 5 years, but less than 6 years	80%
6 years or more	100%

Payment of Benefits and Withdrawals

Distributions and withdrawals are payable upon normal retirement at age 65, termination, disability or death. The participant, or his/her beneficiary, elects the manner he/she will receive vested benefits as outlined in the Plan document. The Plan permits hardship withdrawals to participants subject to certain restrictions. Participants may also take in-service withdrawals once they reach the age of 59 ½.

Forfeited Accounts

Forfeitures of employer matching and non-elective contributions may be used to pay administrative expenses or to reduce future employer contributions. There were no forfeitures from participants during the period ended July 17, 2025. At July 17, 2025 and December 31, 2024, there was no forfeiture balance.

Plan Administration

The Company is the administrator of the Plan, and as such, carries out the duties imposed by ERISA. The administrator has delegated certain responsibilities for the operation and administration of the Plan. Some of the administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The total administrative expenses incurred by the Plan were \$10,088 for the period ended July 17, 2025.

Subsequent Events

Subsequent events have been evaluated by plan management through December 3, 2025, which is the date the financial statements were available to be issued.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

These statements have been prepared on the accrual basis of accounting. The preparation of statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at market value. Shares of registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held at year and period end.

Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Changes in the difference between cost and quoted market value of investments are reflected as net appreciation in value of investments in the statement of changes in net assets available for benefits.

Payments of Benefits

Benefits are recorded when paid.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

4. FAIR VALUE MEASUREMENTS, CONTINUED

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at July 17, 2025 and December 31, 2024.

Money Market Fund: Valued at the quoted net asset value (NAV) or shares held by the Plan at year and period end.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the prototype plan adopted by the Plan is qualified and the trust established under the Plan is exempt under the appropriate sections of the Internal Revenue Code (the IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as most recently amended and restated, is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Plan management has concluded that as of July 17, 2025 and December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability of disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. There were no interest or penalties incurred during the period ended July 17, 2025.

The Plan has filed its tax returns for periods through December 31, 2024. These returns are generally open to examination by the relevant taxing authorities for a period of three years from the later of the date the return was filed or its due date. Accordingly, the tax filings for the years ended December 31, 2024, 2023, and 2022, are open to examination at July 17, 2025.

7. PARTY-IN-INTEREST

Plan investments are held and managed by Matrix Trust Company, and therefore these transactions qualify as party-in-interest transactions under ERISA. As described in Note 2, the Plan paid expenses to various service providers, which also qualify as party-in-interest transactions.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


