## ***INDEPENDENT AUDITOR'S REPORT***

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of February 28, 2025 and February 29, 2024, and the related statement of changes in net assets available for benefits as of February 28, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended February 28, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

**1. DESCRIPTION OF PLAN**

The following description of the 401(k) Retirement Plan (“Plan”), which was adopted by Team Staffing, LLC (“Sponsor”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Sponsor established the Plan to provide employees with a systematic means of savings and investing for the future. Regular, full-time employees of the Sponsor, as defined by the Plan document, are eligible to enroll. The Plan is a defined contribution Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Employee and Employer Contributions***

Each year, participants may contribute from 1 percent to 75 percent of their gross compensation by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor may decide to make matching contributions the Plan but are not required to do so.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of (a) Sponsor’s matching contribution, if applicable and (b) Plan earnings. Allocations of earnings and losses for each fund are based on the ratio of weighted average participant account balances per fund to the total weighted average of all participant account balances. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of service, as follows:

0%	vesting after	1 year of service
20%	vesting after	2 years of service
40%	vesting after	3 years of service
60%	vesting after	4 years of service
80%	vesting after	5 years of service
100%	vesting after	6 years of service

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account or may elect to receive substantially equal installments over a period of time. For termination of service for other reasons, a participant becomes eligible to receive the current value of the participant's vested account in a lump-sum or as substantially equal installments over a period of time. Lump-sum distributions can be paid out as either a check to the participant or as a rollover into another qualified plan of IRA. The Plan also allows for in-service hardship withdrawals in a lump sum up to 100 percent of participant's vested interest in their elective deferral account.

***Forfeited Accounts***

At February 28, 2025 and February 29, 2024, forfeited non-vested accounts totaled \$99,813 and \$758,398 respectively. These accounts will be used to pay Plan administrative expenses and reallocated to the remaining participants.

***Investment Options***

Upon enrollment in the Plan, a participant may direct participant contributions as well as the Sponsor's matching contribution, if applicable, in either a specified dollar amount per payroll period or in whole percentage increments of earnings in any of the funds offered by the Plan. Participants should reference prospectus information supplied by the Plan for detailed fund information.

*Participant Investment Rollovers*

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, and present the assets available for Plan benefits and changes in those Plan assets.

*Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of certain amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Contributions*

Participant contributions were recorded in the period in which the Sponsor made payroll deductions from participant earnings. Employer contributions were recorded in the period in which they were earned.

Contributions are limited by federal tax legislation. The statutory limit for 401(k) elective employee deferrals for 2024 was \$23,000 per participant. The statutory limit for 2025 was \$23,500 per participant. Participants who have attained age 50 by the end of the Plan year are eligible to contribute an additional \$7,500 as catch-up contributions.

*Investment Valuation and Income Recognition*

Investments in common/collective trusts and mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-

dividend date. The Plan's interest in collective trust is valued based on information reported by the Trustee using the audited financial statements of the collective trust as of year-end. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Fair Value Measurements***

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosure*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodology used for fair value measurement as of February 28, 2025 and February 29, 2024.

***Payment of Benefits***

Distributions to participants are recorded when paid.

***Administrative Expenses***

Certain Plan administrative expenses are paid by the Company. Other expenses such as legal and accounting are paid from Plan assets and deducted from participant accounts in accordance with the Plan document.

***Prior Period Adjustment***

An adjustment was recorded in the prior year to adjust net assets to Mid Atlantic Trust Company's certified trust report. This appeared to have been a timing difference and an adjustment was not necessary. The adjustment would not have had a material impact on net income in the prior period. Net assets have been restated to reflect the balance on Mutual of America's records at the end of the prior year.

***Date of Management's Review***

The Plan has evaluated subsequent events through December 10, 2025, the date the financial statements were available to be issued. During the audit, it was noted that an employee had made contributions to the plan before the employee had become eligible. The amounts contributed will be refunded to the employee.

**3. *INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)***

Mid Atlantic Trust Company, the trustee, maintains all records of investment transactions and determines the valuation of the investment portfolio. As required by 29 CFR 2520-103-8 of the Department of Labor's Rules and regulations for Reporting and Disclosure under ERISA, Mutual of America has provided certification to the Plan administrator regarding the accuracy and completeness of certain information. The following information was included in the information certified by Mid Atlantic Trust Company for the years ended February 28, 2025 and February 29, 2024, and was used in the preparation of the financial statements and supplemental schedule in compliance with ERISA.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the

Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

**6. *TAX STATUS***

The IRS has determined and informed the Sponsor by a letter dated November 30, 2020, that the Plan and related trust, as then designed, were in compliance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of February 28, 2025 and February 29, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

**7. *PARTIES-IN-INTEREST***

The record keepers for the period under audit was Mutual of America. Therefore, transactions with Mutual of America qualify as party-in-interest transactions. During fiscal year ended February 28, 2025 and February 29, 2024, the Plan paid \$81,724 and \$72,303, respectively, in administrative fees and \$13,000 and \$14,000 in audit fees were paid in 2025 and 2024 by forfeitures.

**8. *RISKS AND UNCERTAINTIES***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur

in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500**

There were no reconciling items between the net assets available for benefits per the financial statements to Schedule H of Form 5500.

**10. DELINQUENT PARTICIPANT CONTRIBUTIONS**

The Company determined that certain participant contributions and loan repayments had not been remitted to the Plan in a timely manner according to Department of Labor regulations. The amount reported for the year ended February 28, 2025 was \$19,400. Although these remittances were made, they fell outside the normal processing time the Company allows. The Company will calculate lost earnings for the 2025 late contributions and deposit these funds into the Plan.
