### 1. Plan description, eligibility and funding policies:

#### General

The following description of the indiGO Auto Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a self-directed, defined contribution plan, covering all full-time employees of indiGO Auto Group (the "Company") who meet the eligibility requirements detailed below. It is subject to the provisions of the Employee Retirement Security Income Act of 1974 ("ERISA").

The Company and its board of directors coordinate and manage the administration of the Plan. Reliance Trust Company is the trustee of the Plan. The Plan's record keeper for all periods presented was ADP Retirement Services, Inc. ("ADP").

#### Eligibility

In order to participate in the Plan, employees must be at least age 21 and have completed 3 months of service. Employees will receive credit for one month of service for each month in which an employee completes one hour of service. An hour of service is any hour for which employees are paid or are entitled to payment. If employees are absent from employment with the employer because of qualified military service, the military service will count as service for the purpose of meeting the Plan's eligibility requirements. Employees will become a participant on the first day of the month following the completion of the eligibility requirements.

If employment is terminated after becoming a participant in the Plan, or after satisfying the Plan's eligibility requirements but before actually becoming a participant, and are later rehired as an eligible employee, the rehired employee will become a participant in the Plan on the next entry date following rehire. If employment is terminated before satisfying the Plan's eligibility requirements and are later rehired, the rehired employee must satisfy the Plan's eligibility requirements before participating in the Plan.

#### Contributions

Participant may contribute to pre-tax and after-tax (Roth) elective deferrals up to the dollar limitation provided by law. An eligible employee shall become a participant effective as of the first day of the next month following the date on which such employee met the eligibility requirements. Participants may commence salary deferrals on the effective date of participation and on the first day of each Plan month. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are allowed subject to conditions set forth in the Plan agreement.

Contributions: (cont'd.)

The Company may make discretionary matching contributions. In 2024, the Company made discretionary matching contributions equal to 25% of the first 4% of the participant's compensation. Participants must be eligible to participate in the Plan to receive discretionary matching contributions. Participants are immediately vested in discretionary matching contributions.

Participant accounts and vesting

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) the Plan's earnings and charged with any applicable administrative expenses. Allocations are based on a participant's eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are at all times vested in their deferral and rollover contributions and the appreciation or depreciation thereon. Participants are immediately vested in the Company's contributions portion of their account plus earnings.

Net assets available for benefits include the accounts of active participants, as well as certain separated, vested and retired participants who have elected to defer receipt of their benefits to a later date. These participants share in the earnings of the investments.

Forfeitures

At February 29, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$21 and \$21, respectively. These amounts will be used to reduce future employer contributions and pay administrative expenses.

Distributions to participants

Participant accounts become fully vested upon attainment of the normal retirement age of 65, early retirement as defined in the Plan Agreement, or in the event of death or total and permanent disability. After a participant reaches age 59 1/2, they may request an in-service distribution from all accounts. Benefit payments upon termination of employment are distributed as a lump sum, in installments, or if qualified, as an annuity. Distributions may be deferred until the participant reaches the age of 73 if the value of the distribution is not less than \$5,000. However, the Plan agreement stipulates that minimum distributions must commence no later than April 1 of the year following the year in which the participant reaches the age of 73.

Notes receivable from participants

Participants may borrow the lesser of one-half of their vested account balance or \$50,000 reduced by the participant's highest outstanding loan balance during the last twelve months. Loan terms range from one to five years, unless the note is for the purchase of a principal residence. Notes are secured by the participant's vested account balance to the extent of the unpaid principal amount of the note plus accrued interest and are repaid through payroll deductions. Participants may have one loan outstanding at any time. Interest is earned on the participant loans at the prime rate in effect on the 14th day of the month plus one percent at the inception of the note.

Plan merger

Effective February 29, 2024, the Plan was merged into the PON North America, Inc. Defined Benefit Plan. As a result, all investments were transferred from the Plan to the PON North America, Inc. Defined Benefit Plan on that date.

2. Summary of significant accounting policies:

Date of Management's review

Subsequent events were evaluated through August 31, 2025, which is the date the financial statements were available to be issued.

Accounting basis

The financial statements of the Plan have been prepared on an accrual method basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because the contract value is the amount participants normally would receive if they were to initiate permitted transactions under the term of the plan. There are no plan assets that are fully benefit-responsive investment contracts for the years presented.

Use of estimates

The process of preparing financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measure date. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits

Benefits are recorded when distributed.

Risks and uncertainties

The Plan provides for various investments. In general, such investments are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Market risks include global events, which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risks associated with certain investment securities, it is reasonably possible that changes in the values of securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Administrative expenses

Investment and management fees are charged to participants based upon their investment elections, which vary between the various investment options and funds selected. These fees are charged to the respective investment option or fund in determining its unit value. Certain administrative fees including a base rate per plan, a charge per participant, service fees, and audit fees are paid by the Company.

Federal income taxes

The Plan has adopted a non-standardized profit-sharing plan, which obtained its latest opinion letter on October 6, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype document satisfied the applicable provisions of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

2. Summary of significant accounting policies: (cont'd.)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 29, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken. With few exceptions, the federal income tax returns of the Plan are subject to examination by the IRS, generally for three years after they were filed.

3. Parties-in-interest:

Notes receivable from participants qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions of ERISA and the IRC.

4. Commitments and contingencies:

The administrative committee has represented to us that there are no legal or un-asserted claims against the Plan, no unfulfilled commitments, the Plan has been properly administered and all documents have been properly updated to reflect all current requirements and regulations to keep the Plan qualified. There are no irregularities, errors or illegal acts involving management or employees that could have a material adverse effect on the Plan. There are no unusual or extraordinary transactions with related parties nor are there any items pending that would represent a contingent loss.

5. Information not covered by auditor's report:

Pursuant to the terms of the Plan, indiGO Auto Group 401(k) Plan has entered into a trust agreement with Reliance Trust Company for the period ended February 29, 2024 and year ended December 31, 2023, whereby, the trustee holds the Plan's investment assets and executes transactions therein, including the receipt of income and payment of withdrawals. For financial reporting and disclosure purposes under the Employee Retirement Income Security Act of 1974, the administrative committee has elected the method for compliance permitted by of the Department of Labor Rules and Regulations 29 CFR 2520.103-8 which permits the Plan's administrative committee to rely on financial statement information certified by the Plan trustee and provides that the independent public accountant need not perform auditing procedures with respect to information certified to by the trustee of the Plan, Reliance Trust Company, whereby the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of February 29, 2024 and December 31, 2023, in the Schedule of Assets (Held at End of Year) - Schedule H, Part IV, Line 4i as of February 29, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the period ended February 29, 2024.

#### 6. Investments:

##### Fair value measurements

ASC 820, *Fair Value Measurements and Disclosures*, clarifies the definition of fair value for financial reporting, establishes a framework for measuring fair value, and requires additional disclosure about the use of fair value measurements in an effort to make the measurement of fair value more consistent and comparable. A summary of the fair value hierarchy under ASC 820 is described below.

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. In addition, ASC 820 establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

##### Fair value measurements

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets

*Registered investment companies (mutual funds):* Valued at net asset value (NAV) of shares held by the Plan at year-end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

Level 2      Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Common/collective trusts:* Valued at the NAV as reported by such trusts and determined by the trustee of the Plan. The underlying trust fund investments reflect prices based on quoted market prices utilizing public information. The common/collective trusts held by the Plan provide for daily redemptions by the Plan at the reported NAV with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further

Level 3      Inputs to the valuation methodology are unobservable inputs (i.e. projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at February 29, 2024 and December 31, 2023.
