Note 1 - Plan Description

The following description of the Puget Sound Kidney Centers Tax-Sheltered Annuity Plan (the Plan) provides general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering eligible employees of Puget Sound Kidney Centers (the Employer). The Plan is intended to meet the requirements under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Nationwide Trust Company, FSB, and Nationwide Financial Services, Inc. (collectively referred to as Nationwide) are the custodian and recordkeeper of the Plan, respectively.

Effective January 1, 2026, the plan year end is changing from March 31 to December 31 and the name of the Plan will be changed to Puget Sound Kidney Centers Retirement Plan.

Eligibility - All employees are eligible to make elective deferrals to the Plan upon commencing employment. All employees who have completed two years of service with the Employer, as defined by the plan document, are eligible to receive employer matching contributions.

Contributions - Eligible employees may elect to defer up to 100% of their compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover).

The Employer makes fixed employer matching contributions of 100% of participants' elective deferrals up to the first 7% of eligible compensation. Effective January 1, 2026, the employer matching contribution formula changed to a discretionary match.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions as well as allocations of plan earnings or losses. The accounts for eligible participants are also credited with matching contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in their contributions and employer matching contributions plus earnings thereon.

Notes Receivable From Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Interest rates are set at 2% above the prime rate, as defined. Principal and interest are paid ratably through electronic funds transfer.

Payment of Benefits - Upon termination of service, retirement, death, or disability, a participant, or their beneficiary, may elect to receive a lump-sum payment or installment payments. Participants who have attained age 59½ may also elect to receive a distribution of their elective deferral account balance prior to termination of employment (in-service withdrawals). The Plan also allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Pledged Collateral for Defaulted Policy Loans - Prior to March 18, 2024, Variable Annuity Life Insurance Company (VALIC) was a custodian of the Plan and VALIC allowed participants to take out policy loans which were funded from the general assets of VALIC and repaid directly to VALIC. The participant's account balance was not reduced; however, a portion of the participant's account were pledged, or held in collateral, to cover the outstanding Policy Loan in case of default. Defaulted Policy Loans or loans in foreclosure were recognized as a liability in the statements of net assets available for benefits at the time of default.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through December 8, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Annuity Contracts - Non fully benefit-responsive fixed annuity contracts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

On March 15, 2024, the asset custodian for the Plan changed from VALIC to Nationwide Trust Company, FSB (Nationwide) and at that time, all assets of the Plan, other the VALIC Fixed Account Plus, were transferred from VALIC to Nationwide. The VALIC Fixed Account Plus contract restricted withdrawal or transfer from the account to 20% per year. There were no further purchases being made to the VALIC Fixed Account Plus after March 15, 2024.

Note 4 - Fixed Annuity Contracts

The Plan entered into a fully benefit-responsive investment contract with Nationwide Life Insurance Company (Nationwide Life). Nationwide Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Nationwide Life is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Nationwide Life but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit Nationwide Life to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events may include amendments to the plan documents, bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events may include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, material misrepresentations, or a material amendment to the agreement without the consent of the issuer.

Note 5 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of March 31, 2025 and 2024, and investment income or loss for the year ended March 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB, and The Variable Annuity Life Insurance Company. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Tax Status

Management has adopted a Nationwide Financial Services, Inc. pre-approved 403(b) plan document. Nationwide Financial Services, Inc. received an approval letter from the IRS dated May 29, 2024, which states that the form of the plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Party-in-Interest Transactions

Plan investments include fixed annuity contracts issued by VALIC and Nationwide; therefore, transactions with such investments and fees paid from the Plan to VALIC and Nationwide qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Concentrations of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of fixed annuity contracts issued by VALIC and Nationwide. These investments represent approximately 29% of total plan investments at March 31, 2025 and 2024, respectively. The Plan's management seeks to limit its credit exposure by placing its contracts with high-credit quality institutions.
