INDEPENDENT AUDITOR'S REPORT

To the Trustees of the
National Football League Players Association Money Purchase Pension Plan

Opinion

We have audited the accompanying financial statements of the National Football League Players Association Money Purchase Pension Plan National Football League Players Association Money Purchase Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of February 28, 2025 and February 29, 2024, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the statements of net assets available for benefits of the National Football League Players Association as of February 28, 2025 and February 29, 2024, and the statements of changes in net assets available for benefits for the years then ended in accordance with the modified cash basis of accounting described in Note 1.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 1 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.





Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 1 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.


Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

 - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Report on Supplemental Information

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Such information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS (MODIFIED CASH BASIS)

YEARS ENDED FEBRUARY 28, 2025 AND FEBRUARY 29, 2024

NOTE 1. PLAN DESCRIPTION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of National Football League Players Association Money Purchase Pension Plan (the Plan) provides certain general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering certain employees of the National Football League Players Association (the Association) as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate in the Plan on two entry dates (March 1 or September 1) following six months of service.

Method of Accounting - The accompanying financial statements are presented on a modified cash basis of accounting, which is another comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Generally, revenue is recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred. These financial statements include net appreciation in fair value of investments as required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Additionally, assets resulting from cash transactions, such as investments and participant loans receivable are recognized. Interest is also accrued on loans receivable.

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results may differ from those estimates.

Employer Contributions - The Employer will make an employer contribution to the participants' account equal to a percentage of their salary in accordance with the following classification groups as follows:

- Participants with less than 24 months of service - 7.5%
- Participants with at least 24 months, but not more than 119 months, of service - 15%
- Participants with more than 119 months of service - 20%



NOTE 1. PLAN DESCRIPTION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Rollover Contributions - The Plan provides for rollover contributions, which represent contributions by participants from other tax-qualified retirement plans. The maximum amount of a participant's rollover contribution is not affected by the limits otherwise applicable to participant contributions.

Participant's Accounts - Each participant's account is credited with (a) the Association's contributions, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. The contributions are allocated within each participant's account based upon the participant's investment elections. Investment earnings are allocated based on the participant's investment elections. All amounts in participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in rollover contributions and employer contributions plus actual earnings thereon. Participants must evaluate their own investment goals and choose one or more of the investment options. Poor investment performance by the investments selected by participants may cause their vested balance to be lower than the amounts contributed to the Plan on their behalf.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. The notes are secured by the vested balance in the participant's account and bear a reasonable rate of interest, which is commensurate with local prevailing rates of a commercial U.S. bank and are determined at the time the loan is made. Note transactions are treated as transfers to (from) the investment funds from (to) a participant's notes receivable.

Notes to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Plan management has evaluated the collectability of notes receivable from participants and because they are secured by the participants account an allowance has not been recognized.

Benefits - Benefits are payable to participants or designated beneficiaries upon retirement, termination, death, disability, or hardship, when they become eligible to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefit payments are recognized when paid.

Administrative Expenses - The Association pays substantially all administrative expenses for the Plan.



NOTE 1. PLAN DESCRIPTION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation - The Plan's investments are stated at fair value (except for fully benefit-responsive investments contracts, which are reported at contract values). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by its investment advisers and custodians. Purchases and sales of securities are recognized on a trade-date basis. Interest and dividend income is recognized when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2. FAIR VALUE MEASUREMENT

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at February 28, 2025 and February 29, 2024.

Level 1

Mutual funds are traded in active markets on national and international securities exchanges and are valued at closing prices on the last business day of each period.

Level 2

Short-term investment funds are held at cost which approximates fair value.

Investments in Investment Entities

Authoritative guidance on fair value measurements permits the Plan to measure the fair value of an investment in an investment entity that does not have a readily determinable



NOTE 2. FAIR VALUE MEASUREMENT (CONTINUED)

fair value based upon the net asset value (NAV) per share or its equivalent of the investment. NAV is based on the fair value of the underlying investments of the fund, minus fund liabilities, divided by the number of outstanding shares. This guidance does not apply if it is probable that the investment will be sold at a value different than NAV.

The Plan's investment in investment entities is subject to the terms of the respective private placement memoranda and governing agreements. Income or loss from investments in these investment entities is net of a proportionate share of fees and expenses incurred or charged by these investment entities.

The Plan's risk of loss in these entities is limited to its investment. The Plan may increase or decrease its level of investment in these entities at its discretion. The Plan typically has the ability to redeem its investment from these entities on a daily basis.

The following table summarizes, for investments in which the Plan has an interest, the Plan's investments in certain entities that calculate net asset value per share as fair value measurement as of February 28, 2025 and February 29, 2024 by investment strategy:

The investment included in the table presented above reports as a direct filing entity (DFE) to the Department of Labor. Participant transactions (purchases and sales) may occur daily. There are no redemption restrictions for individual participants within the Plan, however, there is up to a 12-month redemption for this investment at the Plan level.

NOTE 3. TAX STATUS

The Plan document is a prototype plan document, in which the Internal Revenue Service (IRS) stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC.

Accounting standards provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribe a threshold of "more likely than not" for recognition and derecognition of tax positions taken or expected to be taken in a tax return. The Plan performed an evaluation of uncertain tax positions for the years ended February 28, 2025 and February 29, 2024, and determined that there were no matters that would require recognition in the financial statements. As of February 28, 2025, the Plan is no longer subject to tax examination for years prior to 2021.



NOTE 4. PRIORITIES UPON TERMINATION

The Plan sponsor intends to continue the Plan indefinitely, but reserves the right, at any time, to terminate the Plan. In the event of the termination of the Plan, each participant shall become fully and immediately vested in their account. Upon termination, the Trustees may distribute all of the participants' accounts or continue the trust until benefits are paid.

NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

NOTE 6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of common collective trusts and mutual funds managed by John Hancock. John Hancock is a Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan sponsor (the Association) pays certain administrative expenses on behalf of the Plan.

NOTE 7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through December 10, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
