### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Kendrick Oil Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 28, 2025 and February 29, 2024, and the related statement of changes in net assets available for benefits for the year ended February 28, 2025, and the related notes to the financial statements.

**1. Description of plan**

The following description of the Kendrick Oil Company (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Although not formally amended, the Plan sponsor applied requirements for the Setting Every Community up for Retirement Enhancement (SECURE) Act of 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act, and the SECURE 2.0 Act of 2022 at the respective effective dates.

**General**

The Plan is a profit sharing and salary deferral (401(k)) defined contribution plan covering all employees of the Company who are age 21 or older and have completed one year of service, except members of a collective bargaining unit and nonresident aliens. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The Company, at its sole discretion, may contribute to the Plan each year an amount which it deems advisable. Participants may contribute up to 100% of their annual compensation subject to certain limitations of the Internal Revenue Code. For the years ended February 28, 2025 and February 29, 2024, the Company elected to make a safe-harbor contribution equal to 100% of the first 5% of employee compensation.

**Participant accounts**

Each participant's account is credited with the participant's contributions and an allocation of (1) the Company's contributions, and (2) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of participant accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 20% vested after two years of service increasing 20% per year until 100% vested after six years of credited service.

**Investment options**

All investments are self-directed. A participant may direct contributions to any of the mutual funds, guaranteed interest accounts, or the money market fund offered within the Plan. The investment options that held participant balances during the years ended February 28, 2025 and February 29, 2024 are listed in Note 3.

**Payment of benefits**

Upon termination of service, a participant may elect to begin distributions from his or her account in amounts less than or equal to the vested value. The participant is not required to immediately withdraw or rollover their vested value upon termination. Hardship distributions and in-service distributions are permitted when certain criteria are met. In-service distributions are permitted once the participant has attained the age of 59.5 years.

**1. Description of plan, continued**

**Forfeitures**

Forfeitures of the non-vested balance of participants' accounts may reduce administrative expenses or employer contributions to the Plan. The amount of forfeitures totaled \$0 and \$2,015 for the years ended February 28, 2025 and February 29, 2024, respectively.

**Notes receivable from participants**

Participants may borrow from their fund accounts. The minimum loan amount is \$1,000 and a participant may only have one loan outstanding at any time. The maximum loan amount is equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the related participant's account and bear interest at 1% over the prime interest rate. Principal and interest are paid ratably through payroll deductions or by check if prepaying.

**2. Summary of accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Estimates**

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition**

The Plan's investments are stated at their quoted market prices. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date.

**Notes receivable from participants**

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of February 28, 2025 and February 29, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment.

**Administrative expenses**

Most administrative expenses of the Plan are paid by the Plan's trust fund. However, the Company may pay such expenses at the Company's discretion.

**4. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**5. Tax status**

The Plan is covered by a Volume Submitter Prototype Document which received a letter from the Internal Revenue Service dated September 30, 2014, in which it stated that the Plan, as then designed, was in compliance with the applicable requirement of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**6. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**7. Transactions with parties in interest**

Certain Plan investments are shares of mutual funds managed by the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for investment management services were netted against investment returns. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party in interest transactions.

**8. Fair value measurements**

The fair value of mutual funds are based on quoted market prices for those of similar investments.

The framework for measuring fair value produces a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities;
- Quoted inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
