Note 1 - Plan Description

The following description of Pivotal Health Solutions, Inc. 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Pivotal Health Solutions, Inc. , Blackline Capital, Armedica Manufacturing, Inc., and Metrix, LLC (collectively, the "Companies") who have completed two months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 1, 2025, the Plan merged into the Performance Health 401(k) Plan (see Note 7).

Contributions

The Plan provides for employee salary 401(k) contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to contribute up to 100 percent of their eligible compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Plan provides for employer matching contributions. The employer matching contributions formula is to match 100 percent of participant contributions up to the first 3 percent of eligible compensation plus 50 percent of participant contributions for the next 2 percent of eligible compensation. The Companies may make annual discretionary qualified nonelective contributions. The participant must be employed as of the last day of the plan year to be eligible for any discretionary qualified nonelective contributions that may be made for the plan year. For the period ended January 1, 2025, there were no annual discretionary contributions made to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions. Vesting in the Companies' match and discretionary contribution portion of their accounts, plus additional earnings thereon, based on years of credited service. Participants are vested 33.33 percent after one year of service, 66.67 after two years of service, and become fully vested after three years of service. Participants become fully vested if while an employee they die or become disabled.

Note 1 - Plan Description (Continued)

Benefit Payments

Distributions are payable upon attainment of age 59½, normal retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures attributable to employer contributions are used to reduce future company contributions. At December 31, 2024, the ending forfeiture balance was \$4. Due to the plan merger (see note 7), there was no ending forfeiture balance as of January 1, 2025.

Termination

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Talcott Resolution Life Insurance Company (Talcott) or its affiliates. These transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. See Note 6 for additional information.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

There were no administrative expenses paid for the period ended January 1, 2025.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including December 12, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Talcott holds the Plan's investment assets and execute all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Empower Annuity Insurance Company of America ("EAICA") on behalf of Talcott as of and for the year ended December 31, 2024. Due to the plan merger on January 1, 2025 (see note 7), the asset transfer shown in the Statement of Changes in Net Assets Available for Benefits was not certified.

Note 4 - Tax Status

The Plan is a pre-approved plan. The pre-approved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Investment Contracts

The Plan had a fully benefit-responsive investment contract with Talcott. Talcott maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 3 percent. The interest crediting rate is based on a formula agreed upon with the issuer.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 6 - Fair Value Measurements

The following tables present information about the Plan's assets measured at fair value on a recurring basis at December 31, 2024. The Plan held no assets at January 1, 2025 as a result of the plan merger (see Note 7).

Accordingly, all assets, participants, and their related account balances were transferred. The 5500 was prepared based on the date the assets were physically transferred, February 28, 2025. Generally accepted accounting principles require the financial statements to report the merger based on the effective date of the transaction. As such, the Statement of
