## Independent Auditors' Report

### The Retirement Plan Committee of Farmer Bros. Co. Hourly Employees' Pension Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Farmer Bros. Co. Hourly Employees' Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of February 24, 2025 (in liquidation) and June 30, 2024 (in liquidation), and the related statements of changes in net assets available for benefits for the period from July 1, 2024 to February 24, 2025 (in liquidation) and for the year ended June 30, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 24, 2025 and June 30, 2024, for the period from July 1, 2024 to February 24, 2025 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, the Retirement Plan Committee of the Plan approved a plan of liquidation on June 17, 2024 effective June 30, 2024, and management determined liquidation is imminent. As a result, the accompanying financial statements are prepared on the liquidation basis of accounting used in presenting the June 30, 2024 financial statements.

Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

### **1. Description of Plan**

The following brief description of the Farmer Bros. Co. Hourly Employees' Pension Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### ***General***

The Plan was a defined benefit plan established on July 1, 2009 to provide retirement benefits to eligible collectively bargained employees of Farmer Bros. Co. (the "Company" or "Employer"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was amended and restated on July 1, 2015. Specific provisions of the Plan are contained in the Plan document, which governed the legal operations of the Plan.

Effective October 1, 2016, the Plan was amended to freeze eligibility and cease accrual of benefits under the Plan. Additionally, the normal benefit of each participant was frozen.

On June 17, 2024, the Retirement Plan Committee approved a resolution to terminate the Plan effective June 30, 2024. During the year ended June 30, 2024, the Plan was required to accrue and separately present any costs that it expects to incur and the income it expects to earn during liquidation, as well as any adjustments to those estimates in future periods. All assets have been distributed by February 24, 2025.

In January of 2025, the Employer formally accepted a final buy-in offer from Western & Southern Life to issue a single-premium non-participating group annuity contract on behalf of certain Plan participants. In January of 2025, the Plan paid a premium amount of \$2,864,896 of which \$12,855 was refunded to the Plan Sponsor in May of 2025.

#### ***Eligibility***

An employee who was represented by Local 265, Sheet Metal, Air, Rail and Transportation Workers, Local 337, International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America, or Local 455, United Food and Commercial Workers Union were eligible to participate if he or she were paid on an hourly basis, had completed one year of eligibility service (1,000 hours), and attained the age of 21 years. Former Sara Lee employees who met certain requirements became participants on July 1, 2009. In addition, salaried-paid employees (and others not paid on an hourly basis) hired at any time after July 1, 2009, who had met the Plan's age and service requirements were allowed to participate in the Plan.

#### ***Plan Administration***

The Plan was administered by officers and employees of the Company ("Plan Administrator"). The Plan Administrator is responsible for controlling and managing the Plan's operations and making investment allocations. The Principal Trust Company (the "Trustee") executes investment transactions and invests cash received and investment income as directed by the Plan Administrator.

***Pension Benefits and Vesting***

Normal retirement age was 65; however, participants could retire earlier or later. For married participants, the normal form of payment was joint and survivor annuity. The normal benefit for unmarried participants was a monthly amount payable for the life of the participant. If the actuarial equivalent of the participant's vested accrued benefit did not exceed \$5,000 it was paid in a lump sum as soon as administratively feasible after separation from service or after termination of employment.

For Local 265, Sheet Metal, Air, Rail and Transportation Workers participants, monthly benefits were based on the participant's years of credited service divided by fifteen (but not greater than one) multiplied by 38% of his or her final average earnings. Benefit accruals were frozen as of December 31, 2011.

For Local 337, International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America participants, monthly benefits were based on the participant's years of credited service multiplied by \$38. Benefit accruals were frozen as of December 31, 2014.

For Local 455, United Food and Commercial Workers Union participants, monthly benefits were based on the participant's years of credited service accrued under the Plan on and after March 1, 2009 multiplied by \$33. Benefit accruals were frozen as of October 1, 2016.

A participant became fully vested in his or her accrued pension benefit on the date he or she attained normal retirement age (provided he or she is an employee of the Company) or completed five years of vested service, as defined in the Plan document.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The Company approved to terminate the Plan effective June 30, 2024. As a result, the Plan has changed its basis of accounting for periods starting July 1, 2023, from the accrual basis to the liquidation basis.

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan followed U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and were related to assets with unadjusted quoted prices in active markets. Level 2 inputs related to assets with other than quoted prices in active markets which could include quoted prices for similar assets or liabilities or other inputs which could be corroborated by observable market data. Level 3 inputs were unobservable and were used to the extent that observable inputs did not exist.

Pursuant to U.S. GAAP guidance, investments where fair value was measured using the Net Asset Value ("NAV") per share as a practical expedient was not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

All of the Plan's investments were stated at fair value. Mutual funds were valued at the daily closing price as reported by the fund. The funds held by the Plan were open-end funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily NAV and to transact at that price. These funds were deemed to be actively traded. Investments in pooled separate accounts were valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient was not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unrealized and realized appreciation of investments during the year was included in net appreciation in fair value of investments in the statements of changes in net assets available for benefits. Purchases and sales of the investments were recorded on the trade date. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Actuarial Present Value of Accumulated Plan Benefits***

Accumulated plan benefits were those future periodic payments, including lump-sum distributions, that were attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died and (c) present employees or their beneficiaries. Benefits under the Plan were accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees equaled the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, - retirement, death, disability, and termination of employment - were included, to the extent they were deemed attributable to employee service rendered to the valuation date.

***Actuarial Present Value of Accumulated Plan Benefits (continued)***

The actuarial present value of accumulated plan benefits was determined by an independent actuary and was that amount that resulted from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuation as of July 1, 2024 were (a) Pri-2012 blue collar projected with Scale MP-2021 (annuities) and Internal Revenue Service 417(e) mandated table effective on July 1, 2024 (lump sum), and (b) liability interest rate of 4.99% (annuities) and 5.50% (lump sum). The computation of the actuarial present value of accumulated plan benefits was made as of July 1, 2024. Had the valuations been performed as of June 30, 2024, there would be no material differences. As a result of the Plan termination (see Note 1), there is no remaining liability at February 24, 2025.

***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

***Plan Expenses***

Certain expenses related to administering the Plan were paid from Plan assets, such as the Pension Benefit Guaranty Corporation ("PBGC") premiums and contract administrator fees. Expenses that were paid by the Company were excluded from these financial statements. Investment related expenses were included in the net asset value of the respective funds and consequently, those expenses were not separately reflected but were a component of net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is December 12, 2025.

**3. Funding Policy**

The Plan was a noncontributory defined benefit plan to which the Company made actuarially determined contributions in amounts at least sufficient to meet minimum funding standards under the terms of ERISA. The Plan has met the minimum funding requirements of ERISA as of February 24, 2025 and June 30, 2024.

**5. Information Certified (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4j – Schedule of Reportable Transactions, including investments held at June 30, 2024, and net appreciation in fair value of investments and dividend and interest income, for the period from July 1, 2024 to February 24, 2025 and for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

**6. Party-In-Interest Transactions**

All Plan investments were interests in pooled separate accounts and mutual funds held by Principal Life Insurance Company, and managed by Principal Financial Group, the parent company of the Trustee. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

**7. Tax Status**

The Plan received a favorable tax determination letter dated March 30, 2011, from the Internal Revenue Service ("IRS") stating that the design of the Plan satisfied the qualification requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator believed that the Plan was designed and was currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan was subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.
