Dear Sir or Madam,

This letter is submitted in response to Notice CP406 to provide a reasonable cause explanation for the late filing of the 2023 Form 5500 for the CLARKEBOT 401K PS PLAN.

Effective July 1, 2023, Clarkebot, Inc. transitioned its existing retirement plan from ADP to a Professional Employer Organization (PEO) arrangement with Justworks. During this mid-year transition, Clarkebot believed that ADP, as the plan's prior recordkeeper and administrator, would prepare and file the final Form 5500 for the portion of the 2023 plan year prior to the transition.

Due to an administrative misunderstanding during the service-provider transition, the Form 5500 was not filed as expected (although it was prepared). It was not due to willful neglect. Clarkebot, Inc. has a history of timely compliance with its employee benefit plan reporting obligations and has taken steps to improve their understanding of filing responsibilities to prevent similar issues in the future.
