Opinion

We have audited the accompanying financial statements of the International Brotherhood of Electrical Workers Local Union No. 163 Health & Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligation of the International Brotherhood of Electrical Workers Local Union No. 163 Health & Welfare Fund as of March 31, 2025 and 2024, and the changes in its net assets available for benefits and changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the International Brotherhood of Electrical Workers Local Union No. 163 Health & Welfare Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.





In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.


Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED MARCH 31, 2025 AND 2024

NOTE 1. DESCRIPTION OF THE PLAN

The International Brotherhood of Electrical Workers Local Union No. 163 Health and Welfare Fund (the Plan) is a multi-employer collectively bargained health benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The following brief description of the International Brotherhood of Electrical Workers Local Union No. 163 Health and Welfare Fund (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete description of the Plan's provisions.

General - The Plan covers eligible employees covered by collective bargaining agreements between participating employers and the International Brotherhood of Electrical Workers Local Union No. 163 (the Union). The Plan also covers eligible dependents of active employees. There is no retiree coverage under this plan. Under the provisions of the Consolidated Omnibus Budget Reconciliation Act (COBRA), unemployed participants can continue their eligibility for a certain period after they cease employment by paying their own contributions.

Eligibility - To become initially eligible for welfare benefits, (employee no dependents), must work at least 400 hours for participating employers of the Plan within a twelve-month period. Continuing eligibility requires an employee to work a minimum of 69 hours (119 for employees with dependents) in the subsequent months. An eligible employee will have benefit credit account (hours bank) established once the following hours are met. The maximum Hour Bank are 830 hours for single coverage and 1,430 hours for family coverage.

Benefits - The Plan covers employees working in jobs covered by the collective bargaining agreements, for which contributions are required to the Plan. The Plan provides benefits such as medical, hospitalization, prescription drug, dental, optical and life and accidental death and dismemberment insurance, accident and sickness. The Plan provides these benefits through either insurance or indemnity arrangements with the following companies: Aetna, Delta Dental, Vision Benefits of America (VBA) and the Life Insurance Company of North America. The plan also provides a health care reimbursement arrangement (HRA) benefits for reimbursement of qualified out of pocket medical expenses pursuant to IRC 213(d).



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Insured Benefits - The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits, dental and optical benefits.

Contributions - The Plan is funded by participating employer contributions based on the rate specified in the collective bargaining agreement between participating contributing employers and the Union. Contributions are also permitted from those employees who wish to maintain their eligibility for benefits that would have otherwise been terminated due to insufficient hours worked.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Employer Contributions - Revenue from employer contributions is determined by hours of work reported by participating employers and the contractual employer contribution rates in effect. Employer contributions are included in revenue during the period in which the work is performed. The contributions receivable and reciprocal receivable represents uncollected contributions for hours worked through end of the Plan year and are based on verified subsequent period cash collections.

Reciprocal Contributions - Reciprocal contributions represent payments received from other local health and welfare plans for work performed by plan participants out of the local union's area of operation.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees (Trustees) determines the Plan's valuation policies utilizing information provided by its investment advisors and custodians. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates - The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Accordingly, actual results may differ from those estimates.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Benefit Obligations Claims Incurred but Not Reported - Plan benefit obligations are estimated by the Plan's actuary in accordance with accepted actuarial principles. The Trustees receive the independent actuarial and consulting firm's report and implement the recording of these obligations. The statements of benefit obligations include the actuarial estimate of claims payable, claims incurred but not reported, and accumulated eligibility credit obligations. The accumulated eligibility credits are based on the hours in the Hours Bank and the benefit credit account and the Plan cost per hour at the end of the year. Except for change in interest rate, the actuarial assumptions and methods have not changed from those used in the prior year.

Postretirement Benefit Obligations - The provisions of the Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 965 do not apply to this plan. The Plan has not recognized any benefit obligations relating to post-employment or post-retirement benefits since the Plan is not required to provide coverage beyond the participant's accumulated eligibility credits.

Administrative Expenses - Administrative expenses are paid by the Plan.

NOTE 3. TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) and the Plan sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4. PLAN TERMINATION

In the event of Plan termination, the Trustees shall disburse the funds to pay any and all outstanding debt and obligations of the Plan and then apply any remaining surplus in a manner best able to accomplish the purposes of the Plan in accordance with the provisions of applicable federal law.



NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described on the next page:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Security and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the NAV per share or the daily closing price which is generally equivalent to \$1 per share.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE 7. PARTY-IN-INTEREST

Certain assets of the Plan are managed by Bank of America, the custodian, as defined by the Plan. These transactions qualify as party-in-interest transactions. In addition, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
