### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Northfield Retirement Communities, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 10, 2025 and December 31, 2024, and the related statements of changes in net assets available for benefits for the period from January 1, 2025 to February 10, 2025 and for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 10, 2025 for the period from January 1, 2025 to February 10, 2025, and as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Emphasis of Matter – Plan Merger***

As discussed in Note 1, “General” section to the financial statements, the management of Northfield Retirement Communities, Inc. Retirement Plan, the Plan Sponsor approved to merge the Plan into a Pooled Employer Plan effective February 10, 2025. Our opinion has not been modified with respect to this matter.

**Other Matters – Supplementary Information Required by ERISA**

The supplementary information as of February 10, 2025 and December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Plan Description

---

The following description of the Northfield Retirement Communities, Inc Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Northfield Retirement Communities, Inc. (the Community) and was established January 1, 2003.

Employees were eligible to make pre-tax and after-tax Roth salary deferral contributions after attaining age 21 and completing 90 days of service. Eligible employees became participants on the first day of the month following the date on which entry requirements were fulfilled. Participants were also eligible to participate in the discretionary matching contributions and qualified non-elective contributions after attaining age 21 and completing one year of service with 1,000 hours of service.

#### ***Merger***

Effective February 10, 2025, the Plan Sponsor approved for the Plan to be merged into a Pooled Employer Plan. Plan assets of \$837,396 were transferred to the Pooled Employer Plan during February 2025. Empower is the custodian of the Pooled Employer Plan.

#### ***Contributions***

Participants were able to make salary deferral contributions up to 100% of their annual eligible compensation, subject to the maximum dollar amount allowable by law. Employees were automatically enrolled in the Plan with an initial salary deferral of 3% unless the Plan was informed otherwise. At any time, a participant could elect not to contribute or increase or decrease their deferral rate. Participants could also contribute amounts representing distributions from other qualified plans. All participants who were eligible to make deferral contributions who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The Community also could make discretionary matching contributions and qualified non-elective contributions. During the period from January 1, 2025 to February 10, 2025 and the year ended December 31, 2024, the Community elected to make discretionary matching contributions equal to 100% of elective deferrals up to 3% of eligible compensation, plus 50% of elective deferrals which were over 3% but were not over 5% of eligible compensation.

#### ***Participant Accounts***

Each participant's account was credited with the participant's contributions and allocation of (a) the Community's discretionary matching contributions and qualified non-elective contributions, and (b) Plan earnings or losses. The Community's discretionary matching contributions were allocated

among participants based upon each participant's elected salary deferral. The Community's qualified non-elective contributions were based on eligible compensation of participants. Plan earnings or losses were allocated on the basis of actual results of the investments selected by each participant. Investments were maintained in individual member accounts managed by Principal Trust Company (Principal).

### ***Vesting***

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Community's discretionary matching contributions and qualified non-elective contributions credited to participants' accounts were based on years of continuous service. A participant was 20% vested after one year of service and vesting increased 20% per year until a participant was 100% vested after five years of service.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary could elect to receive lump-sum or installment payments equal to the value of the vested funds allocated to the participant's account. Participants could also receive in-service and hardship distributions, as permitted in the Plan document. The Plan required mandatory distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event that the participant did not elect otherwise. Distributions under \$1,000 were paid out to the participant in the event the participant did not elect a payout option. Benefits were recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability or death, the portion of the Community's contributions not then vested were forfeited. The forfeited portion of any participant's account were used to pay Plan expenses, reduce the Community's contributions, or be re-allocated to remaining participants. As of February 10, 2025 and December 31, 2024, the Plan held \$0 in forfeited non-vested accounts. The Community used a total of \$23 and \$12,812 to reduce the Community's contributions and pay Plan expenses during the period from January 1, 2025 to February 10, 2025 and during the year ended December 31, 2024, respectively.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investment is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments were reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on the fair value of investments.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

### ***Other***

The Community paid a portion of the administrative expenses incurred. Expenses that were absorbed by the Community were excluded from the financial statements. Other expenses specifically incurred by or attributable to individual participants were paid from the applicable participants' accounts. Investment-related expenses were included in net appreciation (depreciation) in fair value of investments.

### ***Risks and Uncertainties***

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. The Plan and the Community have considered such events or transactions through December 15, 2025, noting no items requiring disclosure.

### 3. Information Certified by Principal

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplementary information.

### 4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
  
- Level 2     Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 10, 2025 and December 31, 2024.

*Collective Investment Trusts:* Valued at the net asset value (NAV) of units of the collective investment trusts as a practical expedient. The NAV, as provided by the trustee, is used to estimate fair value. The NAV is based on the fair value of underlying investments held by the trust less its liabilities. Participant transactions (purchases and sales) may occur daily.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan investments as of February 10, 2025.

### 5. Tax Status

---

The Plan was qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and was exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan was currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Plan Termination

---

The Community has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date (see "General" section of Note 1).

### 7. Related Party Transactions

---

The Plan investments were collective investment trusts managed by Principal. Principal was the custodian of the Plan, and therefore, these transactions qualified as party-in-interest transactions.
