## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants  
Tranco Logistics, LLC 401(k) Plan  
Chattanooga, Tennessee

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed an audit of the financial statements of Tranco Logistics, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audit and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Tranco Logistics, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was established January 1, 2013, as a defined contribution plan available to all employees of Tranco Logistics, LLC; Tranco Global, LLC; Tranco Fleet, LLC; and Transcomp Permit and Fuel Tax Services, LLC (collectively the Company). Each employee is eligible to become a participant in the Plan after completing three months of service (there is no minimum hour's requirement during this three-month period) and attaining age 21. As of March 2022, employees must complete six months of services for employee deferrals and safe harbor contributions and one year of service for employer matching and nonelective contributions. Once an employee is eligible to enter the Plan, he or she can elect to participate on the first of every month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Each year, participants may contribute up to a 100% of pre-tax annual eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover contributions). The Company contributes a discretionary match as determined annually to those who have obtained the age of 21 and have completed one year of service, having been credited with 1,000 hours of service in the plan year. The discretionary match for 2024 was 50% of the first 6% participant deferrals. There was no profit-sharing contribution in 2024. Contributions are subject to certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, rollover contributions, and allocations of (a) the Company's contribution, if applicable, and (b) plan earnings less expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Administrative fees and certain investment fees are allocated based on participant earnings or account balances.

#### **Investment Options**

Investments are currently held by Reliance Trust Company (Reliance). Upon enrollment in the Plan, a participant may direct contributions in any available funds managed by Reliance. Participants may change their investment options at any time.

#### Forfeited Accounts

Forfeitures may be used to offset employer contributions and reduce plan expenses. As of December 31, 2024 and 2023, there were forfeited nonvested accounts totaling \$73,099 and \$48,887, respectively. For the year ended December 31, 2024, forfeitures of nonvested accounts totaling \$2,234 were used to reduce plan expenses and no amounts were used to offset employer contributions.

#### Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon.

Vesting in the Company's employer nonelective contribution portion of their accounts plus actual earnings thereon is based on years of vesting service (with 1,000 hours of service in a plan year being equal to one year of vesting service) as follows:

#### Administrative Expenses

The Plan permits the payment of plan expenses to be made from the Plan's assets. If the Company does not pay these expenses, then the expenses paid using the Plan's assets will be allocated among the participant accounts. For the year ended December 31, 2024, administrative fees paid for by plan assets totaled \$23,860.

#### Payment of Benefits

Upon severance of employment, a participant, or their beneficiary, whose vested account balance exceeds \$5,000, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or for participants subject to required minimum distributions (RMD) only, installments on a monthly, quarterly, or annual basis equal to or exceeding the RMD amount. The Plan will make a mandatory distribution following severance of employment for participants whose vested account balance is equal or less than \$5,000 (the Plan includes rollovers when determining whether a participant's vested account balance meets this \$1,000 minimum). Hardship withdrawals are allowed.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The notes are secured by the balance in the participant's account. The interest rates on the outstanding loans ranged from 4.25% to 8.50%.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, plan assets must be used for the exclusive benefit of participants.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting and Use of Estimates**

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Financial Accounting Standards Board (FASB) has adopted the Accounting Standards Codification (ASC) as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates (ASU) from time to time to make adjustments to GAAP.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated as reported by the custodian, Reliance. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan follows FASB ASC 820, *Fair Value Measurement*. FASB ASC 820 defines fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

**Level 1** - consists of unadjusted quoted prices in active markets for identical assets or liabilities and has the highest priority.

**Level 2** - consists of inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.

**Level 3** - consists of significant unobservable inputs for the asset or liability and has the lowest priority.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Stable Value Fund:* The fair value of the stable value fund is based on net asset value (NAV) reported by the fund managers as of the financial statement dates and recent transaction prices. The investment objective of the stable value fund is to provide preservation of capital and provide sufficient liquidity to participants and provide stable and predictable returns.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit.

### NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by the Standard. The Standard is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Certain investment expenses paid to the trustee are netted against investment returns.

### NOTE 6 – TAX STATUS AND UNCERTAIN TAX POSITIONS

The Plan has adopted a volume submitter plan which obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the plan administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status.

### **NOTE 6 – TAX STATUS AND UNCERTAIN TAX POSITIONS (Continued)**

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC Topic 740, *Income Taxes*. Using that guidance, tax positions initially need to be recognized in the financial statements when it is more likely than not the position will be sustained upon examination by the tax authorities.

The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years ended December 31, 2021 through December 31, 2024, the years that remain subject to examination by major tax jurisdictions as of December 31, 2024.

### **NOTE 7 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS**

As of December 31, 2024, the vested balance of net assets available for benefits that were in accounts of participants that are no longer employees of the plan sponsor totaled \$302,859. Of those balances, no amount had been requested to be paid to the participants but were not paid until subsequent to the Plan's year end.

### **NOTE 8 – PROHIBITED TRANSACTIONS**

During 2024, the plan sponsor failed to remit all employee contributions to the Plan on a timely basis, which is a prohibited transaction under ERISA. The plan sponsor is in the process of calculating the lost earnings to the participants and will contribute that amount to the Plan in order to correct the prohibited transactions.

### **NOTE 9 – SUBSEQUENT EVENTS**

The plan administrator evaluated events and transactions subsequent to December 31, 2024 through December 11, 2025 (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. The plan administrator has not identified any items requiring recognition or disclosure in the financial statements.
