Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Minneapolis Retail Meat Cutters and Food Handlers Health and Welfare Fund (the “Plan”) is a multiemployer welfare benefit plan, established in 1966, as a result of collective bargaining agreements between United Food and Commercial Workers Union Local 663 and contributing employers. The Plan provides medical, prescription drug, dental, vision, short-term disability, life, and accidental death and dismemberment benefits to participants on whose behalf employers contribute in accordance with their collective bargaining agreement. Retirees who elect to maintain medical coverage under this Plan are required to contribute toward the cost of such coverage. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan documents include detailed rules for each situation. Participants should refer to the Plan agreement and any amendments regarding specific provisions of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Benefit Obligations

Benefit obligations are estimated by the Plan’s actuarial consultant in accordance with accepted actuarial principals, based on paid and incurred claims cost studies, plan benefits, claims experience and other data as considered necessary.

Effective January 1, 2025, the Plan transitioned from a retroactive weekly eligibility system to a prospective monthly eligibility system, resulting in accumulated eligibility as follows:

Prior to the transition, the benefit obligation for future earned coverage represented an estimate of claims which would be due the following year for participants who had been credited with sufficient weeks prior to year end, to maintain eligibility after year end. The obligation had been estimated using the total weekly projected cost per participant multiplied by the total weeks of future earned coverage, as determined by the Plan’s consulting actuary and the Plan’s eligibility records.

D. Contributions

Employer contributions as reported are contributions made for hours worked during the year. Contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

The Plan does not provide retiree coverage. Therefore, the Plan does not report postretirement benefit obligations.

E. Employer Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

F. Tax-Exempt Status

No provision for federal income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9).

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Reclassification

Certain amounts reported in the February 29, 2024 financial statements have been reclassified to conform to the current year presentation. The reclassifications had no effect on the previously reported net assets available for benefits.

H. Administration

The Plan is administered by Wilson-McShane at the following rates:

NOTE 3 - FAIR VALUE MEASUREMENTS

FASB ASC 820 provides the framework for measuring fair value of the Plan's investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1 - Inputs are quoted prices in active markets.

Level 2 - Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 - Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investment bought and sold as well as held during the year.

NOTE 4 - PLAN TERMINATION

Upon the termination of the Plan, per the Agreement and Declaration of the Trust, any and all monies remaining in the Plan after payment of all expenses and obligations of the Plan shall be either expended and used for the continuance of purposes of the Plan until such monies have been exhausted, or transferred to another trust or trusts providing similar benefits.

NOTE 5 - RISKS AND UNCERTAINTIES

Benefit obligations are reported based on certain assumptions pertaining to health care inflation rates, participant demographics and other assumptions which are subject to change. Due to the uncertainty of the assumption process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the financial statements.

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some estimated values may differ from values that would have been used had a ready market existed for the investments. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the financial statements.

NOTE 6 - MAJOR EMPLOYERS

Contributions from four employers accounted for approximately 85% and 84% of employer contributions during the years ended February 28, 2025 and February 29, 2024, respectively. In the event these employers suspend contributions, the Plan would terminate coverage to the employer's participants as required under the Plan document and retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.

NOTE 7 - CONCENTRATION OF CREDIT RISK

During the years ended February 28, 2025 and February 29, 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit were subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

A component of the initiative was the establishment of Health Reimbursement Arrangements (HRAs), which became effective in July 2025. These accounts were funded from unused grace weeks. There were no additional material subsequent events that required recognition or additional disclosures in these financial statements.
