I just logged into my account today and found out that the form wasn't filed. I only received one email on Sept. 29th telling me it wasn't filed. Because I receive hundreds of emails a day, I didn't see it. Please waive the \$750 fee. I would have liked a phone call or an email a day letting me know it wasn't filed. ADP communicates well when it's trying to upgrade me or sell me more products, but I received virtually no communication about something as important as a late filing. I'm having some serious trust issues.
