INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Lakefield Veterinary Group, Inc. 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Lakefield Veterinary Group, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Lakefield Veterinary Group, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lakefield Veterinary Group, Inc. 401(k) Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report, dated October 15, 2024, indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the Lakefield Veterinary Group, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Lakefield Veterinary Group, Inc. (the "Company", "Plan Sponsor" or "Employer"), is intended to qualify under Section 401(a) and related provisions of the Internal Revenue Code (IRC), and was established January 1, 2019, and restated January 1, 2022. Participating employers of the Plan include Lakefield Professional Group of Texas, PC, Lakefield Professional Group of Indiana, PC, Lakefield Professionals Group of Washington, PC, Lakefield Professional Group of Minnesota, PC, Lakefield Professional Group of Arizona, PC, Lakefield Professional Group of Oregon, PC, and Lakefield Professional Group of Wisconsin, SC. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination of employment, or financial hardship. The Plan covers certain employees of the Plan Sponsor, who meet certain eligibility requirements as defined in the Plan. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Plan Sponsor is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Plan Sponsor has delegated certain responsibilities for the operation and administration of the Plan. Reliance Trust Company (the "Trustee") acts as the Plan's asset custodian and directed trustee (Note 3) and an affiliate of the Trustee performs participant record-keeping services.

Eligibility

All employees of the Plan Sponsor, except for union employees, non-resident aliens, leased employees and residents of Puerto Rico are eligible to participate in the Plan upon attaining age 18 and completing at least six months of service. Employees may enter the Plan immediately upon meeting the eligibility requirements.

1. DESCRIPTION OF THE PLAN (continued)

Contributions

Plan participants may elect to contribute up to 100% of their annual eligible pre-tax compensation, subject to certain maximum limitations imposed by the IRC. Participants who have attained or will attain the age of 50 by the last day of the Plan year, may elect to make catch up contributions, as defined by the Plan, subject to IRC limitations. Rollover contributions representing distributions from other qualified retirement plans are permitted.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Participants enrolled through the automatic enrollment provision will have their deferral rate increased by 1% annually each year beginning in year three if no election is made.

The Plan Sponsor may make Employer discretionary matching and profit sharing contributions to the Plan. For the year ended December 31, 2024, there were no Employer discretionary matching or profit sharing contributions elected. The Plan Sponsor contributes Employer safe harbor matching contributions to the account of each eligible participant equal to the sum of 100% of a participants' elected deferrals that do not exceed 1% of the participants compensation, plus 50% of the participants elective deferrals that exceed 1% of the participants compensation but does not exceed 6% of the participants compensation.

Participant accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Employer contributions, if any, and Plan earnings, and charged with Plan losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Notes receivable from participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the highest outstanding loan balance on the participant's account during the prior twelve month period. The notes receivable from participants (or "loans") are issued by the Plan and collateralized by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence. Under the terms of the Plan document, participant loans shall accrue a reasonable rate of interest at the prime rate plus one percent, as defined in the plan document. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the interest rates on outstanding loans ranged from 3.25% to 8.50% with various maturity dates through December 2029.

Payment of benefits

Upon termination of service due to death, disability, attaining age 59.5 or retirement, a participant may elect to receive either a lump-sum distribution, installment payments, or a partial withdrawal under various options equal to the value of the participant's vested interest in his or her account. If a participant's account balance is equal to or less than \$7,000 upon termination, the balance is distributed as a lump-sum distribution to an individual retirement account unless requested to be rolled over into another qualified Plan. If a participant's account balance exceeds \$7,000, the participant may elect to receive a lump-sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan, as described in the Plan document.

Participants with an immediate and heavy financial need may be eligible for a hardship withdrawal, subject to certain restrictions as described by the Plan document. In addition to the foregoing, participants are permitted to request distributions from their vested Plan accounts at any time after having attained age 59.5.

Vesting

Participants are immediately 100% vested in all participant contributions, Employer discretionary matching and profit-sharing contributions, plus actual earnings thereon. Employer safe harbor matching contributions vest after 2 years of service.

Forfeitures

If a participant terminates employment and is less than 100% vested in their Employer safe harbor matching contributions, the participant will forfeit the non-vested portion of their account. Additionally, forfeitures may occur as a result of excess Employer contributions. These forfeited amounts may be used to reduce future Employer contributions or pay Plan administrative expenses. For the year ended December 31, 2024, forfeitures of \$184,045 were used to offset Employer contributions. The forfeiture account balance as of December 31, 2024 and 2023 was \$73,227 and \$105,625, respectively.

Subsequent events

The Plan has evaluated subsequent events through December 10, 2025, the date the financial statements were available to be issued.

Effective June 27, 2025, the Plan transitioned the record-keeper from the Standard Insurance Company to Empower Retirement LLC. Plan management is not aware of any other subsequent events which would require recognition or disclosure in the financial statements.

Administrative expenses

Certain administrative expenses of the Plan, including record-keeping and audit fees, were paid directly by the Plan Sponsor but may, at the direction of the plan administrator, be paid by the Plan. The Plan is not required to reimburse the Plan Sponsor for expenses paid on its behalf. Investment fees, which may vary according to the individual investment options selected, are paid out of the assets of the Plan. Transaction fees for certain participant initiated activity are charged to the specific account of the participant initiating any such transaction.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates. Significant items subject to such estimates and assumptions include the fair value of investments.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Investment valuation and income recognition

Investments are reported at fair value, except for a fully benefit-responsive investment contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4). Contract value is the amount the participant would receive under the terms of the investment contract (Note 5).

Purchase and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions and contributions receivable

Receivables for employee contributions, if any, are recorded based on the date the contributions have been separated from the participant's pay, which is the pay date. Employer contributions are recorded in the year they are earned and to coincide with the year in which the Plan Sponsor records the contribution in its general ledger. Rollover contributions are recorded when received by the Trustee.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make loan repayments and the participant loan is determined to be a distribution, the participant loan balance is reduced and a deemed distribution is recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Trustee, determined to be a qualified institution by the plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year) ("supplemental schedule"). The Trustee has certified that the following data included in the financial statements is complete and accurate:

- Non-interest bearing cash, investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The fair value hierarchy consists of three levels of inputs that may be used to measure fair value as follows:

- *Level 1* - Quoted prices in active markets for identical assets or liabilities.
- *Level 2* - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- *Level 3* - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Registered investment company funds (RICs): Valued at the net asset value (NAV) which is the quoted market prices of shares held by the Plan at year end. RICs held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The RICs held by the Plan are deemed to be actively traded.

Common collective trusts (CCTs): Units held in CCTs are valued using the daily NAV, which is based on the fair value of the collective trust's underlying investments as reported by the audited financial statements of the trust at year end. The NAV is used as a practical expedient to estimate fair value. Plan management believes that the occurrence of events that would cause the fund to transact at less than contract value is not probable. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in a orderly business manner. There are no outstanding commitments related to the CCTs as of December 31, 2024.

5. GROUP ANNUITY CONTRACT

The Standard Stable Asset Fund is a fixed group annuity contract (the "Contract"), issued by the Standard Insurance Company (the "Issuer"). It is issued to the Plan itself, so participants have a beneficial interest in the Plan's group annuity contract. The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments. The Standard Stable Asset Fund has crediting rates based on an external index that are backed by the general account of the issuing Company. The crediting interest rate was 2.09% for the Plan year ended December 31, 2024. The Standard Stable Asset Fund is valued daily and interest is credited daily to deposits to the fund. The interest rate is declared quarterly by the Issuer. When declared, additional amounts of interest remain in effect for the following calendar quarter. Additional interest is not guaranteed for future years. The minimum guaranteed rate is equal to 1.00% per annum in all years.

The value of the Standard Stable Asset Fund is derived from the contract provisions, which is backed by the general account of the Issuer. The contract value is defined as the value of the contract owners account, which is the sum of contributions, plus interest credited, less withdrawals.

A premature termination of the Plan's contract, or other occurrences such as Plan termination, could limit the Plan's ability to withdraw 100% of the participants' interests in this account. Plan management believes these events are highly unlikely.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable.

The Contract does not permit the Issuer to terminate the Contract prior to the scheduled maturity date. The plan administrator may terminate the Contract with advance written notice provided to the Issuer.

6. TAX STATUS

The Plan has adopted the Non-Standardized Pre-Approved Profit Sharing Money Purchase Plan document (the "Pre-Approved Plan"). The Internal Revenue Service informed the issuer of the Pre-Approved Plan, by a letter dated June 30, 2020, that the Pre-Approved Plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants' accounts will become fully vested.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to a related party under accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Company pays certain fees and expenses on behalf of the Plan. These transactions qualify as party-in-interest transactions. The Plan has included in its investment fund options certain funds managed by the Trustee or one of their affiliates. Transactions in these funds are considered party-in-interest transactions under ERISA. Such transactions are permitted under provisions of the Plan and are specifically exempt from prohibition of party-in-interest transactions under ERISA.

The Trustee retains as compensation for services provided to the Plan, any interest (or "float") on amounts earned, while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024, the Plan Sponsor failed to remit to the Plan's Trustee certain employee contributions and loan repayments within the period prescribed by DOL regulations. The delayed contributions and loan repayments are considered prohibited, or nonexempt, transactions. The Plan administrator is in the process of taking corrective action, including payment of lost interest.
