## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of Holiday Wholesale, Inc. Profit Sharing & 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

#### General

The Plan is a defined contribution plan covering substantially all employees, except union employees, of Holiday Wholesale, Inc., Vacationland Vendors, Inc., Dunkin' Donuts, and Travel Mart, Inc., herein collectively referred to as the "Company." A non-union employee becomes eligible to participate in the Plan on the first entry date (first day of the month coinciding with or following the date in which the eligibility requirements are met) upon attaining the age of 18 and completing one year and 1,000 hours of service. Effective January 1, 2024, long-term part-time employees who generally work less than 1,000 hours a year become eligible to participate in the Plan if they have attained the age of 18 and completed more than 500 hours of service during the last three consecutive plan years as required under SECURE 2.0. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On September 10, 2024, the Company's directors approved a resolution to terminate plan participation for Dunkin' Donuts and Travel Mart, Inc. effective on March 1, 2025. See further discussion in Note 2 - Subsequent Events.

#### Contributions

Participants are allowed to contribute pretax compensation up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may contribute a discretionary matching contribution. The Company currently matches 100% of a participant's elective deferrals, not to exceed 3% of a participant's compensation. For the year ended February 28, 2025, the Company made discretionary matching contributions of \$422,036. Rollovers are not matched.

#### **Contributions (Continued)**

The Company may also make a discretionary profit sharing contribution as determined by the Company each plan year. Any discretionary profit sharing contributions made by the Company are participant-directed. There were no discretionary profit sharing contributions made by the Company for the year ended February 28, 2025.

Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, and allocations of (a) the Company's discretionary profit sharing contribution and (b) plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. Participants are entitled to the benefit that can be provided from their vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company's discretionary matching contributions, plus actual earnings (losses) thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts plus actual earnings (losses) thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts. Loan terms range from one to five years. Loans may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime interest rate. Interest rates on existing loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service for any reason, a participant or their beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account or partial withdrawals if the account balance is greater than \$7,000. If the participant's vested balance does not exceed \$7,000, it can be distributed only in a single lump sum payment. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

### **Note 1: Description of Plan** (Continued)

#### **Forfeitures**

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary profit sharing contributions. These forfeitures may be used to pay plan expenses or to reduce Company contributions in accordance with the plan document. There were no unused forfeitures as of February 28, 2025. As of February 29, 2024, unused forfeitures from nonvested accounts were \$419. Forfeitures in the amount of \$1,608 were used to pay plan expenses for the year ended February 28, 2025.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses had been recorded as of February 28, 2025 and February 29, 2024. Delinquent participant notes receivable are reclassified as distributions based on the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Administrative Expenses

The Company absorbs various plan expenses including audit fees and certain third-party administration fees, which are excluded from these financial statements. The Plan absorbs certain third-party administration fees and investment advisory and management fees, which are allocated proportionately to plan participants based on their respective account balances. Loan fees are charged directly to the participant's account against the investment option for which the loan was originally charged.

#### Subsequent Events

The Plan has evaluated subsequent events through December 12, 2025, which is the date the financial statements were available to be issued.

As disclosed in Note 1 - General, effective on March 1, 2025, the directors of the Company approved a resolution to terminate plan participation for Dunkin' Donuts and Travel Mart, Inc. and their respective employees were no longer allowed to participate in the Plan. As a result, all participants of these Companies had their account balances spun-off into another plan. Plan assets of \$3,376,954 and \$34,601 were transferred from the Plan to a successor custodian on April 10, 2025 and May 5, 2025, respectively.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of February 28, 2025 and February 29, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*MetLife GAC Series 25053 CL 0:* The fair value of the fund is determined based on quoted market prices of the underlying investments owned by the fund, which is allocated to the Plan based on their pro-rata share of the securities in the underlying separate account in which the Plan participates.

### Note 4: Information Prepared and Certified by the Custodian

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, and non-interest-bearing cash held at February 28, 2025 and February 29, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended February 28, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the Custodian of the Plan.

### **Note 5: Party-in-Interest Transactions**

Certain recordkeeping fees were paid to Premier Retirement Partners LLC and EPIC Retirement Plan Services, which qualify as party-in-interest transactions. Certain investment fees were paid to John F. Suby & Associates, SC and also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

Notes receivable from participants also qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

The Company has the right under the plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary profit sharing contributions.

### **Note 7: Tax Status**

The Company adopted a non-standardized pre-approved profit sharing plan with an IRS opinion letter that states the non-standardized plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
