INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries of
The Raymond F. Kravis Center for the Performing Arts, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Raymond F. Kravis Center for the Performing Arts, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Notes to Financial Statements
June 30, 2025 and 2024**

NOTE A - DESCRIPTION OF THE PLAN

The following description of The Raymond F. Kravis Center for the Performing Arts, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

[1] General:

The Plan is a defined contribution plan covering eligible employees of The Raymond F. Kravis Center for the Performing Arts, Inc. (the "Organization"). Employees become eligible to participate in the Plan immediately upon being hired by the Organization, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

[2] Contributions:

Participants may contribute up to 100% of pre-tax or as a Roth elective deferral contribution, on annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In no event may participant pre-tax and Roth contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified plans.

The Organization may make matching, discretionary and qualified non-elective contributions to the Plan at the discretion of its Board of Directors. On December 12, 2019, the Board of Directors approved an annual matching contribution for eligible participants based on 50% of each participant's contributions during the Plan year, not to exceed 10% of the participant's annual compensation. There were no qualified non-elective contributions for the year ended June 30, 2025. To be eligible to receive contributions from the Organization in a given year, a participant must be employed by the Organization on the last day of the Plan year and must have worked a minimum of 1,000 hours during such year. Contributions by the Organization are credited to individual participants' accounts at the time the contribution is made and are allocated to participants' accounts based on participants' elections. Participants direct the investment of participant and Organization contributions into various investment options offered by the Plan.

[3] Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contributions and (b) Plan earnings (losses) and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

[4] Vesting:

Participants are immediately vested in their contributions and qualified non-elective contributions, plus actual earnings thereon. Vesting in the Organization's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is as follows:

[5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime less 1%, as defined. The prime rate was 8.00% and 8.50% at June 30, 2025 and 2024, respectively. Interest rates on outstanding loan balances range from 2.25% to 7.50% at June 30, 2025 and 2024, respectively. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

[6] Payment of benefits:

For termination of service for any reason and at any age, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested benefit, or monthly, quarterly, or annual installments over a period of not more than the participant's assumed life expectancy (or the participant and his or her beneficiary's assumed life expectancies), provided the participant's vested benefit exceeds \$5,000. A participant's vested benefit will be distributed automatically upon termination of service if his or her vested benefit does not exceed \$5,000.

[7] Forfeitures:

Forfeited non-vested accounts may be used to reduce future Organization contributions and pay Plan expenses. During the year ended June 30, 2025, forfeitures of \$6,036 were used to pay Plan expenses. Forfeited non-vested accounts available were \$2,637 and \$0 at June 30, 2025 and 2024, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

[2] Subsequent events:

The Plan has evaluated subsequent events through December 10, 2025, the date the financial statements were available to be issued.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of benefits:

Benefits are recorded when paid.

[5] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation in fair value of investments.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, as permitted under such election, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust Company"), a member of the Principal Financial Group and Principal Life Insurance Company, have certified the completeness and accuracy of all investments and related investment activity, notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of June 30, 2025 and 2024, the statement of changes in net assets available for benefits for the year ended June 30, 2025 and the accompanying supplemental schedule of assets (held at end of year) as of June 30, 2025.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term; the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2025 and 2024.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Principal Fixed Income Guaranteed Option: The Principal Fixed Income Guaranteed Option is a guaranteed general-account backed group annuity contract, issued by Principal Life Insurance Company ("Principal Life") to Principal Trust Company as custodian. Benefit payments are made at contract value with no termination or surrender charge adjustments for Plan benefit events and investment transfers initiated by Plan participants. Given these provisions, the Plan considers this contract to be fully benefit-responsive. The contract is reported at contract value. Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

A rate of interest contractually guaranteed by Principal Life is credited to participant account balances. The rate credited to participant accounts is a composite weighted average of underlying guarantees provided in the contract. Each underlying guarantee is in full effect for its full maturity. The maturity of each guarantee varies from 2 to 10 years at the establishment of the guarantee. Each guarantee matures at a different time. The crediting rate is subject to a minimum guaranteed rate that is determined through a formula according to state insurance regulations and utilizing U.S. Treasury rates as outlined in the group annuity contract. The minimum rate will range between 1.0% and 3.0% depending on prevailing market conditions. There are no fees for administrative and recordkeeping services deducted from the net crediting rate. The net crediting rate was 1.65% and 1.55% at June 30, 2025 and 2024, respectively. The net crediting rate is reset semiannually on December 1 and June 1. The contract cannot be terminated before the scheduled maturity date.

No redemption fees, early withdrawal charges, or market value adjustments are charged on participant transfers of assets into or out of the contract. However, participant transfers, either directly or indirectly, to competing Plan investment options will be subject to an equity wash. An equity wash requires that transfers must be directed to a non-competing investment option under the Plan for 90 days before such transferred amounts may be directed to any other competing Plan investment option. Competing Plan investment options include other guaranteed investment options, a stable value money market, or other short-term fixed income investment option with an average duration of less than three years. An employer-level surrender of the Plan's interest or initiated transfer will be subject to either a 12-month advance notice or a 5% surrender charge, whichever the Plan administrator chooses. Notification of the Plan's intent to terminate its interest may be revoked within 90 days of receipt of such notice, after which time, notice becomes irrevocable. The Fixed Income Guaranteed Option may make higher guaranteed rates available. If these are available and the Plan administrator chooses to move the Plan's interest to a higher guaranteed rate, a charge of 1.50% of the Plan's interest applies. If there are multiple higher guaranteed rates available, the 1.50% charge applies to each higher rate that the Plan administrator elects.

Prudential Guaranteed Income Fund: The Prudential Guaranteed Income Fund ("GIF") is a group annuity insurance product with no maturity date issued by Prudential Retirement Insurance and Annuity Company ("Prudential"). Amounts contributed to the GIF are deposited in Prudential's general account. Effective October 3, 2022, Prudential Retirement Insurance and Annuity Company was renamed to Empower Annuity Insurance Company. Therefore, the Plan administrator has received documents and correspondence referencing Empower Annuity Insurance Company. Payment obligations and the fulfillment of the guarantees specified in the group annuity contract are insurance claims supported by the full faith and credit of Prudential. Under the group annuity insurance contract that supports the GIF, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable time frames. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is directly between the Plan and Prudential. The repayment of principal and interest credited to participants is a financial obligation of Prudential. There are no reserves against contract value for the credit risk of Prudential or otherwise. Given these provisions, the Plan considers this contract to be fully benefit-responsive. The contract is reported at contract value. Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The concept of a value other than contract value does not apply to the GIF, even upon a discontinuance of the contract, in which case contract value would be paid no later than 90 days from the date Prudential provides notice of discontinuance. The GIF differs from other group annuity products because a fair value adjustment does not apply upon discontinuance. The GIF, and therefore the liability of Prudential, is not backed by specific securities of the general account of Prudential, and therefore the fair value of the securities in Prudential's general account do not represent the fair value of the GIF. The Plan owns a promise from Prudential to receive interest at crediting rates, which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract.

The GIF is not a traditional guaranteed investment contract, and therefore there are no known cash flows that could be discounted. As a result, the fair value of the GIF is equal to the contract value.

Interest is credited on contract balances using a single "portfolio rate" approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the GIF regardless of the timing of those contributions. Interest crediting rate resets are reviewed on a semiannual basis. When establishing interest crediting rates for the GIF, Prudential considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within Prudential's general account. These rates are established without the use of a specific formula. The minimum crediting rate under the contract was 2.95% and 2.75% at June 30, 2025 and 2024, respectively. Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days. There are no events that allow Prudential to terminate the GIF and which require the Plan Sponsor to settle at an amount different than contract value paid within 90 days. The contract cannot be terminated before the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer noted above. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code ("IRC") or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or
4. A material amendment to the agreements without the consent of the issuer.

NOTE F - TAX STATUS

The Plan has adopted a Volume Submitter 403 (b) Plan sponsored by Principal Life Insurance Company. On March 31, 2017, the Internal Revenue Service ("IRS") stated in an advisory letter that the Volume Submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related accounts are exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related accounts are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments were managed by Principal Trust Company and Principal Life Insurance Company, therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan for administrative and advisory services were \$12,330 for the year ended June 30, 2025.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at June 30, 2025 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE I - MUTUAL FUND FEES

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

NOTE J - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Organization's contributions.
