NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Zara USA & Related Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Zara USA, Inc., Massimo Dutti USA Inc., and ITX USA LLC (collectively, the Company or Employer). The Plan was established on February 1, 2011 and qualifies under the Internal Revenue Code (IRC) as a 401(k) Retirement Plan. The Plan was amended and restated effective January 1, 2022 and February 1, 2024 and is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended.

In February 2024, the Plan changed recordkeeper and custodian John Hancock Trust Company LLC (John Hancock or Former Trustee) to Empower Trust Company, LLC (Empower or Trustee).

The Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. The most recent Plan document reflects the adoption of certain provision of the SECURE 2.0, as applicable.

Eligibility

An employee is eligible to participate and make contributions in the Plan upon reaching age 21 and after completing one year of service for elective deferrals and one year of service for employer match and non-elective contributions. Employees enter the Plan on the first day of the month coinciding with or next following the date the age and service requirements are met.

Contributions

Each pay period, participants may contribute up to 90% of their compensation, as defined in the Plan document, subject to certain IRC limitations. Pursuant to the Plan document, the Employer automatically withholds 3% from eligible employee's compensation unless the employee elects another percentage or elects not to contribute. Unless the participant elects to change his or her deferral percentage or opts out of the Plan, the participant's contribution percentage will automatically increase 1% annually until the contribution deferral percentage reaches a maximum of 6%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allows for Roth contributions.

The Employer makes matching contributions equal to 50% of each employee's elective deferral contributions up to 6% of their compensation. Employer contributions are also subject to certain IRC limitations.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may invest in various registered investment company funds or common/collective trust funds, each with different risk exposure and return potential. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution, (b) the Company's contributions and (c) investment earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Employer contributions and earnings thereon is based on years of continuous service, as follows:

Participants are immediately vested upon termination of the Plan, upon reaching the retirement age of 65, or upon disability or death while an employee of the Employer. Any nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination, retirement, death or disability, a participant is entitled to receive a distribution of their vested account. A participant may elect to receive a lump sum amount equal to the value of his or her account, or a series of cash payments, in substantially equal installments. In addition, the Plan allows for hardship distributions if certain criteria are met. Active participants may also take distributions from the Plan upon attainment of age 59 ½.

If the total vested value is below \$1,000 in a participant's account at the time of termination, then a distribution will be made to the participant regardless of whether they consent to receive it. If the total vested value is greater than \$1,000, but less than \$5,000, the participant has the option of either 1) rolling over their balance into a qualified individual retirement account, or 2) receiving a distribution. If the vested value is greater than \$5,000, the participant may elect to receive a lump-sum distribution, installment payments, or to remain in the Plan. Effective February 1, 2024, the Plan has adopted the SECURE 2.0 provision which increased this limit from \$5,000 to \$7,000.

The Plan also provides for minimum required distributions per Internal Revenue Service (IRS) regulations by April 1 of the calendar year following the later of the calendar year which the participant reaches age 73 or the calendar year the participant retires.

Notes Receivable from Participants

Participants may borrow from their Plan a minimum of \$1,000 up to a maximum of \$50,000, but not more than 50% of their vested account balance. Participants can only have one outstanding loan at a time. Note terms are for a period not exceeding five years unless they are for the purchase of a participant's primary residence, in which case the term is 15 years.

Interest rates are set by the Plan Administrator using the prime rate plus 1%. The notes are secured by the vested balance in the participant's account. Interest rates on loans to participants range from 3.75% to 9.50% and the loans mature on various dates through 2045.

Forfeitures

Forfeitures of non-vested participant balances can be used to pay Plan expenses, restore forfeited accounts, or reduce the Employer's contributions. The balance of forfeited non-vested accounts totaled \$261,110 and \$52,800 at December 31, 2024 and 2023, respectively. \$248,861 of forfeitures were utilized to pay administrative expenses during 2024.

Investment Options

Participants direct the investment of their contributions, as well as the Employer's contribution, into various investment options offered by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared using the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of plan assets, liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investments. The investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' account balances.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value as further described in Note 3.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Delinquent loans are treated as distributions based upon the terms of the Plan document. Delinquent loans are loans

for which any scheduled repayment remains unpaid at the end of the period specified in the loan documents and any loans for which there is an outstanding principal balance existing after the last scheduled repayment date.

Contributions

Contributions from Plan participants and the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan and included in net appreciation of fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair values.

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the SEC. Mutual funds are required to publish their daily value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - Valued at the net asset value (NAV) of shares held by the Plan at year end based on information reported by the Custodian or Former Trustee. The NAV, as provided by the Custodian or Former Trustee, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The redemption notice period could be up to 12 months if the entire interest in the fund is redeemed. The collective trust funds have a daily redemption frequency for participant-directed transactions. There were no unfunded commitments of the collective trust funds as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Prior to February 2024, certain investments in the plan were managed by the Former Trustee or their affiliates. Since February 1, 2024, certain Plan investments are managed by Mercer Investments LLC who, as of that date, serves as the Trustee and Plan Administrator. These transactions qualify as party-in-interest transactions. Additionally, notes receivable from participants also qualify as party-in-interest transactions

Although it has not expressed an intention to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS. Prior to February 1, 2024, that pre-approved plan document had an opinion letter dated June 30, 2020. Since February 1, 2024, a new pre-approved plan document has been adopted with an opinion letter dated August 14, 2020. Both opinion letters stated that the form of the respective pre-approved plan document was in compliance with the applicable requirements of the IRC. Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events for recognition and disclosure through December 10, 2025, the date the financial statements were available to be issued. There were no subsequent events that require recognition or additional disclosure in these financial statements.
