### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2025 Financial Statements

We have performed an audit of the accompanying financial statements of the FHC, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended June 30, 2025 stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion on the 2025 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2025 Financial Statements section:

- The amounts and disclosures in the accompanying 2025 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the accompanying 2025 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2025 Financial Statements**

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2025 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the 2025 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the 2025 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2025 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### 1. Description of Plan

The following description of the FHC, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is sponsored by FHC, Inc. and Neuralynx, Inc., a wholly-owned subsidiary of FHC, Inc. (collectively, the Company).

##### General

The Plan is a defined contribution plan sponsored by the Company. Employees are eligible for participation in the Plan after attaining the age of 21 and completing three (3) months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions

Participants may elect to contribute pre-tax or post-tax compensation, as defined, to the Plan subject to certain Internal Revenue Code (IRC) limitations. In addition, participant contributions may consist of rollovers from other qualified retirement plans.

The Company provides matching contributions equal to 100% of the first 3% of the participant's elective deferrals plus 50% of the next 2% of the participant's elective deferrals. The Company may also elect to make discretionary profit sharing contributions in any plan year. There was no discretionary profit sharing contribution made during 2025 or 2024.

##### Participant Accounts

All contributions to the Plan are participant-directed among investment options offered by the Plan. Each participant's account is credited or charged with the participant's and Company's contributions, earnings or losses, withdrawals, and an allocation of administrative expenses as outlined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants shall at all times be 100% vested in their contributions and employer matching contributions plus actual earnings thereon. Participants become 20% vested in their profit sharing contributions after two years of service. The vesting percentage increases 20% for each subsequent year of service, with participants becoming fully vested after six years of service. Forfeitures are used to reduce Company contributions and pay administrative expenses.

##### Administrative Expenses

The Company pays all administrative expenses associated with the Plan, with the exception of contract administration, recordkeeping, and investment advisory fees, which are paid by the Plan to John Hancock Life Insurance Company, Wilshire Associates, Inc. and Setaway LLC. Certain redemption fees are paid directly by the plan participants. These payments are considered party-in-interest transactions, although not prohibited under ERISA.

**Note Receivable from Participant**

The Plan does not allow participants to borrow from their accounts. However, the Plan was amended to allow the participants of the Neuralynx, Inc. 401(k) Plan, a plan previously sponsored by Neuralynx, Inc., to transfer their outstanding notes receivable balances to the Plan. One loan remained at June 30, 2025 and 2024, which is secured by the balance of the participant's account, and bears interest at 4.25%. Principal and interest are paid ratably through payroll deductions.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investments**

Investments are held in pooled separate accounts and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Pooled separate accounts, excluding the John Hancock Stable Value Fund, invest in shares of mutual funds. None of these pooled separate accounts held by the Plan are subject to transfer or withdrawal restrictions.

The John Hancock Stable Value Fund invested solely in units of the John Hancock Stable Value Trust (the Trust), a collective investment trust managed by John Hancock Life Insurance Company. The John Hancock Stable Value Trust invests primarily in fixed income mutual funds and separately managed bond accounts. Deposits to and withdrawals from the Trust may be made daily at the current Net Asset Value (NAV) per unit. A delay of up to 12 months may be experienced for plan level withdrawals.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Note Receivable from Participant**

Note receivable from a participant is measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

### **Payment of Benefits**

Benefit payments are recorded when paid.

### **Subsequent Events**

Management has evaluated the existence of subsequent events through December 4, 2025, which represents the date that financial statements were available to be issued.

### **3. Fair Value Measurement**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Pooled separate accounts, excluding the John Hancock Stable Value Fund* – Valued based on the market prices of the underlying assets.

*John Hancock Stable Value Fund* – Valued based on the NAV of units held by the Plan. NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. Tax Status

The Internal Revenue Service has determined and informed the third-party administrator by a letter dated November 23, 2020, that the prototype Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the advisory opinion, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 5. Information Prepared and Certified by the Custodian

The Plan's investments and related investment transactions, and note receivable from participant and related note receivable transactions were obtained by management and agreed to or derived from the information certified by John Hancock Life Insurance Company, the custodian of the Plan, as complete and accurate. This information is disclosed in the following:

### 6. Party-In-Interest Transactions

In addition to the party-in-interest transactions previously disclosed, the Plan investments are pooled separate accounts managed by John Hancock Life Insurance Company and the Plan has a note receivable due from a participant resulting from a transfer from the Neuralynx, Inc. 401(k) Plan. These transactions are considered to be party-in-interest transactions, although they are not prohibited under ERISA.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
