NOTE 1 – PLAN DESCRIPTION

The following description of the RedWater, Inc. Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

RedWater, Inc. (Company) established the Plan effective as of January 1, 2024. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and it's designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company. The directed Plan Trustee is an independent third party appointed by the Company's Board of Directors.

On January 1, 2024, the Plan purchased 1,000,000 shares of the Company's common stock using the proceeds of a borrowing issued by the Company (see Note 5) and holds the common stock in a trust established under the Plan.

The borrowing is collateralized by the unallocated shares of common stock of the Company. The Company as the lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024, and for the year then ended, present separately the assets and liabilities and changes therein pertaining to:

- a) the accounts of employees with vested rights in allocated common stock (allocated), and
- b) common stock not yet allocated to employees (unallocated).

As further discussed in Note 5, the Plan had a contribution receivable of \$2,000,000 at December 31, 2024. In the period in which the contribution is paid, and the Plan utilizes the funds for debt service, an appropriate number of shares will be released and allocated for financial reporting purposes.

Eligibility

Employees of the Company, not covered by a collective bargaining agreement who have completed 1 year of service and are 21 years old are eligible to participate. Once eligibility is met, participants enter the Plan on the next entry day, either January 1, April 1, July 1, or October 1. Participants who do not have at least 1,000 hours of service during such Plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions

The Company is obligated to make contributions in cash to the Plan which equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Additional contributions may be made at the Company's discretion. Employee contributions are not permitted.

Payment of Benefits

Distributions on account of death, disability, or retirement (age 65) are made in a lump-sum in the Plan year following the event. Distributions for other separations from service commence in the fifth Plan year following the separation from service and are made in 5 annual installments. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in the form of cash. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited, as of the last day of each Plan year as the note payment is made to release shares, with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Participants may also receive an allocation of shares related to the repurchase of shares from distributions. Generally, only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a combination of the participant's eligible compensation, relative to total eligible compensation, as well as length of service prior to the effective date of the Plan. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Vesting begins at 20% after 2 years of service with participants becoming fully vested after 6 years of service.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the participant's shares at year-end.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. There were no forfeitures allocated to participants during the Plan year ended December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and, (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income, if any, is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Company paid the administrative expenses for the Plan for the year ended December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value of Level 3 Assets

During the year ended December 31, 2024, the Company did not repurchase or redeem any shares from the Plan.

NOTE 5 – NOTE PAYABLE

On January 1, 2024, the Company's former owners sold 1,000,000 shares of stock (representing 100% of the issued and outstanding shares) to the Plan for \$26,019,804 under an ESOP Stock Purchase Agreement. Upon this transaction, the Plan entered into a \$26,019,804 note with the Company. The agreement provides for the note to be repaid over 43 years. The loan bears interest of 4.54%

Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 22,511 shares being released and allocated for the Plan year ended December 31, 2024. As of December 31, 2024, the Plan had a contribution receivable from the Company of \$2,000,000 and an interest payable of \$898,953

The Plan realized a share release related to this payable; however, for financial reporting purposes, the Plan does not release any shares until the debt service is actually paid. Therefore, the accompanying financial statements disclose these shares as unallocated shares. Subsequent to year-end, the Plan received the contribution of \$2,000,000 and paid the combined principal and interest payable to the Company. The financial statements will disclose the shares related to this contribution and payment as allocated for the plan year ending December 31, 2025.

NOTE 1 – PLAN DESCRIPTION

The following description of the RedWater, Inc. Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

RedWater, Inc. (Company) established the Plan effective as of January 1, 2024. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and it's designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company. The directed Plan Trustee is an independent third party appointed by the Company's Board of Directors.

On January 1, 2024, the Plan purchased 1,000,000 shares of the Company's common stock using the proceeds of a borrowing issued by the Company (see Note 5) and holds the common stock in a trust established under the Plan.

The borrowing is collateralized by the unallocated shares of common stock of the Company. The Company as the lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024, and for the year then ended, present separately the assets and liabilities and changes therein pertaining to:

- a) the accounts of employees with vested rights in allocated common stock (allocated), and
- b) common stock not yet allocated to employees (unallocated).

As further discussed in Note 5, the Plan had a contribution receivable of \$2,000,000 at December 31, 2024. In the period in which the contribution is paid, and the Plan utilizes the funds for debt service, an appropriate number of shares will be released and allocated for financial reporting purposes.

Eligibility

Employees of the Company, not covered by a collective bargaining agreement who have completed 1 year of service and are 21 years old are eligible to participate. Once eligibility is met, participants enter the Plan on the next entry day, either January 1, April 1, July 1, or October 1. Participants who do not have at least 1,000 hours of service during such Plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions

The Company is obligated to make contributions in cash to the Plan which equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Additional contributions may be made at the Company's discretion. Employee contributions are not permitted.

Payment of Benefits

Distributions on account of death, disability, or retirement (age 65) are made in a lump-sum in the Plan year following the event. Distributions for other separations from service commence in the fifth Plan year following the separation from service and are made in 5 annual installments. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in the form of cash. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited, as of the last day of each Plan year as the note payment is made to release shares, with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Participants may also receive an allocation of shares related to the repurchase of shares from distributions. Generally, only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a combination of the participant's eligible compensation, relative to total eligible compensation, as well as length of service prior to the effective date of the Plan. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Vesting begins at 20% after 2 years of service with participants becoming fully vested after 6 years of service.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the participant's shares at year-end.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. There were no forfeitures allocated to participants during the Plan year ended December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and, (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Company paid the administrative expenses for the Plan for the year ended December 31, 2024.
