## **Independent Auditors' Report**

To the Plan Administrator  
Johnson, Pope Profit Sharing Plan and Trust:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Johnson, Pope Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

December 31, 2024 and 2023

### (1) **Description of Plan**

The following description of the Johnson, Pope Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the Plan’s provisions.

#### (a) **General**

The Plan, which became effective January 1, 1976, is a defined contribution plan covering eligible employees of Johnson, Pope, Bokor, Rupel & Burns, LLP (the “Company”). The Plan was restated effective January 1, 2021 in accordance with the Internal Revenue Service’s (“IRS”) mandatory restatement cycle. Employees are eligible to participate in the Plan upon hire and may enter the Plan on the first day of month coinciding with or next following the eligibility requirement. There is no age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### (b) **Contributions**

Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company may make profit-sharing or matching contributions to the Plan at the discretion of the Company. For plan year 2024, the Company matched 25% of contributions by eligible employees which totaled approximately \$465,000. Participants are required to be employed in an eligible position as of the last day of the plan year and to have worked 500 hours to qualify to receive that year’s matching contribution.

Profit-sharing contributions are allocated to participants employed by the Company on the last day of the plan year based on the ratio of the participant’s eligible compensation for the plan year to the eligible compensation of all participants for the plan year. The Company declared discretionary profit-sharing contributions of approximately \$1,610,000 for 2024.

#### (c) **Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s matching or profit sharing contribution and (b) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Participants have the ability to direct the investment of their account balances between various mutual funds and a money market fund. Each investment has a unique and varied investment objective.

### (1) Description of Plan - Continued

#### (c) Participant Accounts - Continued

Prior to plan year 2015 the Plan offered a self-directed brokerage account as an additional investment option for participants. This election was discontinued during prior year 2015 and the participants who opted into the self-directed brokerage account were able to keep their investments within the self-directed brokerage accounts, however no new contributions may be made into these accounts.

#### (d) Vesting

Participants are immediately vested in their contributions, and effective January 1, 2019, Company match, and profit sharing contributions plus actual earnings thereon.

#### (e) Payment of Benefits

On termination of service due to death, or disability, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. For participants with vested balances less than \$1,000, participants receive a lump-sum distribution as soon as administratively feasible. In addition, the plan administrator may permit a participant to take partial distributions or installment distributions solely to the extent necessary to satisfy the required minimum distributions rules under the plan agreement.

The Plan also has a hardship withdrawal provision which allows active participants, meeting specified requirements, to take a distribution from their vested account balance that does not exceed an amount that satisfies their immediate financial need plus any related taxes.

#### (f) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the Wall Street Journal's prime rate at date of transaction plus one percent, as determined by the plan administrator. Loans existing as of December 31, 2024 had interest rates ranging from 6.50% to 9.50%.

Principal and interest are paid ratably through payroll deductions. Notes considered in default as defined by the plan document become due in their entirety and become a taxable distribution to the participant, unless the participant resumes repayment of the loan outside of the Plan.

#### (g) Administration Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### (1) Description of Plan - Continued

#### (h) Forfeited Accounts

Forfeitures may be used to reduce the Plan's administrative expense and/or any Company contributions. As of December 31, 2024 and 2023, forfeitures totaled approximately \$3,400, and \$23,600, respectively. Approximately \$4,400 of forfeitures were used to offset employer contributions during 2024.

### (2) Summary of Significant Accounting Policies

#### (a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and present net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

#### (b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

#### (c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### (d) Risks and Uncertainties

The Plan provides for various investment options in a combination of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the valuation of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### (e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### (f) Payment of Benefits

Benefits are recorded when paid.

#### (g) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### (3) Information Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, excluding self-directed brokerage accounts totaling \$18,804,642 and \$18,636,202 as shown in the statements of net assets available for benefits, as of December 31, 2024 and 2023, respectively;
- Total investment income and related investment activity, excluding \$3,186,426 related to self-directed brokerage accounts, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Assets held for investment purposes excluding self-directed brokerage accounts totaling \$18,804,642, as shown in the supplemental schedule, as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### (4) Fair Value Measurements

The Plan applies the provisions of Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, in measuring fair value. ASC Topic 820 established a three tier fair value hierarchy which prioritizes the inputs used in measuring fair value as follows:

Level 1: Observable inputs such as quoted prices in active markets;

Level 2: Inputs, other than quoted prices in active markets, that are observable either directly or indirectly;

Level 3: Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

### (4) Fair Value Measurements - Continued

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### *Registered Investment Companies*

Registered investment companies are valued at quoted market prices in an active market, which represent net asset values of shares held by the Plan at year end and are classified as Level 1 investments.

#### *Self-Directed Brokerage Accounts*

Underlying securities are valued at fair value based on the closing price reported on the active market or inactive market in which the individual securities, registered investment companies or corporate bonds are traded. Self-directed brokerage accounts as of December 31, 2024 and 2023 had investments with readily determinable values and were traded in active markets.

### (5) Related Party Transactions and Party-in-Interest Transactions

The Plan invests in registered investment companies managed by Capital Bank and Trust Company. Capital Bank and Trust Company acts as the investment trustee for only those investments as defined by the Plan. These transactions qualify as party-in-interest transactions but are exempt from prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments and administrative expenses. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan made direct payments to parties-in-interest of approximately \$203,000 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### (6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

### (7) Tax Status

The Plan has adopted a pre-approved plan document. The pre-approved plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has been amended, however the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (8) Subsequent Events

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 29, 2025, the date the financial statements were available to be issued.
