Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Benefits Plus Trust Fund Welfare Benefit Plan (Plan 505), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the statements of benefit obligation and net assets available for benefits of Benefits Plus Trust Fund Welfare Benefit Plan (Plan 505) as of March 31, 2025 and 2024, and the changes in the benefit obligations and net assets available for benefits for the year ended March 31, 2025, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

Notes to Financial Statements

Note 1 – Description of Plan 505

The following brief description of the Benefits Plus Trust Fund Welfare Benefit Plan (Plan 505 or the Plan) is provided for general information purposes only. Reference should be made to the Summary Plan Description for a more complete description of the Plan's provisions.

General – The Plan provides group medical, vision, and life insurance benefits through a multiple-employer trust fund. All benefits are fully insured. The Plan is maintained in compliance with the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Benefits – The Plan provides benefits for participating employees and their dependents whose employers are active members of the Benefits Plus Trust Fund Welfare Benefit Plan and whose job positions are covered under the terms of a collective bargaining agreement with Local 2003. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Eligibility – Employees covered under the collective bargaining agreement with Local 2003 are eligible for benefits for whom contributions are paid on a monthly flat-rate basis, and their dependents for whom coverage is elected and paid, become eligible on the date of hire, and remain eligible until the last day of the month in which their employment is terminated, for any reason.

Contributions – Participating employers pay contributions for the participating employees covered under the Plan. Contribution rates are determined based upon amounts needed to pay insurance premiums and plan expenses.

Plan termination – Although they have not expressed any intent to do so, the Trustees have the right under the Plan to modify or terminate the Plan at any time. The Plan and participating employers do not promise the continuation of any benefits, nor do they promise any benefits at or during retirement. In the event the Plan terminates, the Trustees shall wind up the remaining affairs of the Plan, and any and all monies remaining in the Plan, after the payment of administrative and other expenses, shall be allocated so as to continue the payment of benefits to participating employees and their beneficiaries under the employee welfare benefit plan in accordance with the Trust Agreement. No portion of the remaining assets shall be paid to or be recoverable by any participating employer.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Cash and cash equivalents – For the purposes of financial statement presentation, the Plan considers all short-term investments with an original maturity of three months or less to be cash equivalents.

Benefits Plus Trust Fund Welfare Benefit Plan (Plan 505) Notes to Financial Statements

Due to/from Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501) – The balance represents amounts due to Plan 505 from the Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501). Plan 501 holds the cash and cash equivalents of Plan 505 in checking money market bank and investment accounts.

Receivables from employers – Receivables represent amounts due from participating employers for hours worked in January, February and March, and are presented in the statement of benefit obligations and net assets available for benefits, net of the allowance for doubtful accounts. There is no collateral related to these receivables. An allowance for doubtful accounts is estimated based on Plan 505's historical losses, the existing economic conditions, and the financial stability of its employers. Receivables are written off in the year deemed uncollectible. The plan's administrator has determined that an allowance for doubtful accounts was not necessary as of March 31, 2025 and 2024.

Payment of benefits – Premiums paid by the Plan are recorded as insurance premiums in the accompanying statements of changes in net assets available for benefits. Amounts due to insurers that are recorded as premiums due to insurers in the accompanying statements of benefit obligations and net assets available for benefits.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Concentrations – Approximately 86% of employer contributions were concentrated with two employers for the year ended March 31, 2025. As of March 31, 2025 and 2024, approximately 83% and 84% of the receivables from employers were concentrated with two employers, respectively.

Note 3 – Income Taxes

The Plan is a taxable plan. Income taxes are provided for the tax effects of transactions reported in the financial statements and consist of taxes currently due, plus deferred taxes. The Plan's tax returns are prepared on an accrual basis. Accordingly, income and deductions are recognized in the same periods for tax reporting purposes and for financial statement purposes.

The Plan follows Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 740-10 relating to accounting for uncertain tax positions. ASC 740-10 prescribes a recognition threshold and measurement process for accounting for uncertain tax positions and also provides guidance on various related matters such as derecognition, interest, penalties, and disclosures required. The Plan does not have any entity-level uncertain tax positions. The Plan files income tax returns in the United States federal jurisdiction and various state jurisdictions.

The plan has evaluated subsequent events through December 15, 2025, which is the date the financial statements were available for issuance.
